Ready to Rally for Cole Family

Josh and Kirsten (Burgess) Cole are graduates of Ovid-Elsie and reside in Elsie. Like most married couples they started jobs and looked forward to planning their family. They have been blessed with three great kids, daughter, Vivian, a freshman in college, a son, Justin, a freshman at OE and daughter, Evalyn, an 8th grader at OE. They also have the good fortune of having both sets of parents who live in the same community as well as several close friends. A normal family, living their day to day lives until their son Justin was diagnosed with B-Cell Acute Lymphoblastic Leukemia at age 12.

From that day back in September of 2016, the lives of the Cole family changed dramatically. The tests, procedures and chemotherapy drug treatments became their new normal. With the treatments, Justin was able to get into remission within that first year of being diagnosed, but to keep him in remission, chemo therapy was to be continued over the next three years. He was unable to attend school during the sixth grade, unable to attend public outings and unable to spend time with friends or family due to germs and the risk of infection. He returned to school for his 7th grade year but was unable to participate in extra circular sports like football, one of his favorite sports. One season later in 8th grade he was ok'd to play football once again. In November of 2019 everyone was looking forward to Justin's return to remission as he was only 100 days from that goal when he experienced back pain and was rushed to ER. His leukemia had relarsed

Once again, he began immediate, intense, chemo treatment at Sparrow Hospital and plans for a bone marrow transplant is scheduled for next month in Ann Arbor at U of M.

On Wednesday, February 26th, a benefit basketball game, for the Cole family, READY to Rally, will be held at Ovid-Elsie High School beginning at 7 pm. The Spartan themed game will include player staff of Ovid-Elsie, vs, friends and family of the Cole's. There will be a face painting station, cotton candy, popcorn, 50/50 drawing, a full concession stand and much more planned for this night of family fun. Admission for the event will be by donation at the door. For those unable to attend, donations can be made at Journey Federal Credit Union where an account in Justin's name has been established.

Conservation Funds Available for Michigan Farmers

EAST LANSING – Michigan farmers and forest owners who submit applications by March 20, 2020, will be considered for the current selection for U.S. Department of Agriculture conservation financial assistance. Conservation financial assistance is available for implementing a wide variety of practices to reduce soil erosion, improve wildlife habitat, protect water quality and manage private forest land.

Establishing cover crops is one of many conservation practices eligible for financial assistance.

"Helping Michigan's agricultural producers improve conservation on working lands benefits everyone," said USDA State Conservationist Garry Lee. "This funding will help farmers and forest owners protect our natural resources including our lakes, rivers and wildlife, while producing the food and forest products we rely on."

Conservation financial assistance is available through the Environmental Quality Incentives Program administered by the USDA Natural Resources Conservation Service. Complete applications received by March 20, will be ranked and considered for fiscal year 2020 funding. Financial assistance is available for implementing designated conservation practices such as windbreaks, nutrient management plans, cover crops, forest management plans, crop residue and tillage management, animal waste storage facilities and many others. Applications are ranked and selected for funding on a competitive basis.

A portion of USDA conservation funding is targeted to state-level conservation priorities. These include funds for farmers seeking Michigan Agricultural Environmental Assurance Program verification, high tunnels in Wayne and Genesee counties, honey bee habitat, organic producers and producers transitioning to organic production, creating or improving monarch butterfly habitat, practices to address concentrated flow erosion, and energy conservation.

Conservation activities receiving financial assistance must be part of an agricultural or forest operation's conservation plan. Producers should work with their local NRCS or conservation district staff to develop a conservation plan before applying for the program. Successful applicants enter into a contract with NRCS to implement conservation activities and are reimbursed for a portion of the cost.

NRCS provides higher levels of financial assistance for beginning farmers and historically underserved producers. Applications are accepted on a continuous basis, producers and forest owners are encouraged to submit applications at any time. More information about conservation financial assistance through the Environmental Quality Incentives Program is available at local NRCS offices and online at www.mi.nrcs.usda.gov.





Nichole was a Registered Medical Assistant at MSU until her illness forced her to resign last fall.




Nichole is survived by her husband Jon, 3 children: Hunter,

The territory looked more like the end of March instead of February. We drove up to the Corner Store which is Amish owned and run, north on Mission Road. My intentions were to get three or four kinds of cheese, all of it sliced for sandwiches and I did. I bought some yummy Swiss, Provolone, Cheddar and Havarti cheeses plus a couple of pounds of Black Forrest ham and three kinds of sandwich wraps. Then I did a bit more shopping then intended, picked up some white chocolate to make some Easter candy for my great grandchildren and popcorn for us all to enjoy.

Linda had come along to get out of the house and was enjoying herself. She had just come along for the ride but ended up doing a bit of shopping also. Of course we stopped by an Aunt Millie's bread outlet on the way back through Mt Pleasant. That outlet sells canned vegetables as well as day old bread. Linda picked up some burger and hotdog buns for thirty-three cents each. Finally we stopped at the Country Chef for lunch in Ithaca.

What I learned when I was there.....the burgers are fresh and huge and the order of onion rings reminded me of Rohac's in the 1960's that were on the east side of Owosso. Next time I order the onion rings I need to get a half order......the serving size at the Country Chef is very abundant. I sort felt like I waddled out the door 'cause I was stuffed even though the meal was breakfast, lunch, and dinner all in one. Good thing that I don't do that very often or my gait would be a permanent waddle

Since I'm doing a bit of reminiscing I thought that I could share a phone call that I received from Sue Hardaker at the Historical Society in Elsie. A gentleman who had moved into the Bannister area had stopped to seek information on his homestead. The historical research showed that a pea vinery had once graced his property. A pea vinery is a place where the local farmers brought their pea crop (vines and all) to be processed. At that time Stokley's had a cannery in Owosso and were the receivers of the final product.

It was rather fascinating to find out how the process worked.....from field to table. If I remember correctly, pea vineries have been around since the mid 1880's through the 1950's. It was a place where many men experienced their first job, a place that was powered by donkeys or oxen and eventually by power belts and electricity. Peas were a cash crop that many a farmer planted ten acre patches to supplement their farm....quite popular during the Great Depression. If you know of anyone who had firsthand experience with a pea vinery you are lucky to have a walking historian in your midst. So talk to them and get them to share their knowledge.

Life is good and the knowledge is bountiful and much of it combines common sense in our daily and historical lives. May God bless you and your memories.

Religious Thoughts

"Flip It"

"Truly I say to you, today you will be with Me in Paradise (Luke 23:43)."

I saw a show at the Wharton Center at Michigan State on Saturday, "The Illusionists." These five Broadway magicians were absolutely incredible! They took numerous impossible scenarios and magically flipped them into stunning miracles. With absolute precision, they flipped it. And even in the third row I could not tell how.

On the night of October 29th, 1978, my brother Jack got into his white Ford station wagon, dosed himself with a gallon of gasoline, and lit a match. He was 28. On the night that he blew himself up in his car with gasoline, in the parking lot of the Irish Castle Bar in Los Angeles, I was 2,265 miles away in Livonia, Michigan asleep.

That night changed lives in my family. Eternity changed too. At just 17 years old, it was the worst experience of my life. Where do you go after something like that? Who do you talk to for solace and some perspective? I went nowhere for about two years.

On the day of April 3rd, 33, God in the flesh was murdered in Jerusalem, probably naked, definitely whipped, beaten, and bloody, in a public execution on a cross. Two thieves died with Him. As you can imagine, like Jack's death, it was nasty.

That night changed lives in Israel. For those who knew Jesus, as the promised Old Testament Messiah, it was the absolute worst day of all time, ever. And yet God took the very worst, and flipped it to be the very best, ever...because He didn't stay dead. He walked out of His own grave. God took the worst and made it the best. That's no illusion. It's real magic. His is the only empty grave on Earth. Death died.

Jack always called me by a nickname. As a baby I wouldn't lie still. Always squirming. That name was Flipper, which he shortened to Flip. That moniker would be a self-fulfilling prophecy of sorts because Jesus flipped me. Two years after Jack entered eternity, I heard the gospel. Spiritually, I was asleep, until then.

"In Him, you also, after listening to the message of truth, the gospel of your salvation—having also believed, you were sealed in Him with the Holy Spirit of promise, who is given as a pledge of our inheritance, with a view to the redemption of God's own possession, to the praise of His glory (Ephesians 1:13-14)."

God flipped my despair and made it a stunning miracle. I heard, believed, and the Holy Spirit entered my body. His seal is a down payment, a legal pledge that guarantees God will complete the "purchase" when I die. Like the thief, when Jesus took his worst day and made it his best, He flipped Flip. Are you despairing? Paul wrote Romans, the sixth book in the New Testament, to explain the gospel. Give it a read, ask Him to wake you up to understand it, and He'll flip your life too. It's no illusion.



Did You Know?

According to the National Kidney Foundation®, African Americans have an increased risk of developing kidney disease. In fact, African Americans are three times more likely than Caucasians to suffer from kidney failure. The NKF notes that African Americans' risk is elevated because African Americans have high rates of diabetes, high blood pressure and heart disease. Research points to a lack of recognition as to the seriousness of kidney disease as one factor that might be behind African Americans being so vulnerable to kidney disease. A study published in the American Journal of Kidney Diseases found that nearly half of African Americans have at least one risk factor for kidney disease, but less than 3 percent say they feel kidney disease is a "top health concern." Learning about kidney disease and the vital role kidneys play may compel more people to prioritize kidney health and make lifestyle choices that can reduce their risk for kidney disease.







Annual Colorectal Cancer Screenings Recommended

As the human body ages, screening for various conditions and diseases may need to occur more frequently. Routine doctor visits may not be a part of most people's image of the perfect retirement, but such checkups can save lives and make one's golden years much more enjoyable.

The World Health Organization notes that cancer is the leading cause of death across the globe and that colorectal cancer is the second most common cause of cancer death in the world. A 2017 study published in the journal Cancer Epidemiology, Biomarkers & Prevention concluded that risk factor modification, screening and treatment all have considerable potential to reduce colorectal cancer mortality by 2030.

The U.S. National Library of Medicine recommends that men and women between the ages of 50 and 75 be screened for colorectal cancer every year. Doctors screen for colorectal cancer in various ways, and many of these screenings need not be conducted annually. However, the USNLM recommends that all men and women between the ages of 50 and 75 receive a fecal occult blood, or stool-based, test every year. In addition, men and women should receive a fecal immunochemical, or FIT, test every year. The FIT is a simple test that adults can con-

duct in the privacy of their own homes.

Doctors may recommend additional screenings for colorectal cancer. Upon making such recommendations, doctors will discuss patients' screening options, which include an assortment of tests, and then recommend which test might be best for the patient. The USNLM recommends men and women receive stool DNA tests every three years, flexible sigmoidoscopy tests every five years and double contrast barium enemas every five years. Virtual colonoscopies (once every five years) and colonoscopies (once every 10 years) also may be recommended.

Colorectal cancer claims hundreds of thousands of lives across the globe every year. Men and women over 50 can reduce their risk of falling victim to colorectal cancer by scheduling annual screenings.

Recommended Vaccines for Adults

Newborn babies endure quite a bit in the first few days and months of their lives. Routine immunizations help newborns overcome these obstacles, and as newborns get old they receive vaccines to prevent measles, mumps, rubella, hepatitis, and chicken pox.

A common misconception suggests that vaccines are only for the young. However, the Centers for Disease Control and Prevention notes that the protection provided by some child-hood vaccines can wear off. In addition, some people may be at risk for certain vaccine-preventable diseases due to lifestyle, existing health conditions and age. As a result, it's important for adults to make sure their vaccines are up-to-date.

Those who are unsure of their vaccine status should discuss their health history with their doctors. In the meantime, adults should know that the following vaccines are recommended for people of various ages.

- Influenza: An annual flu shot is highly recommended. Doctors and health officials indicate that getting the flu vaccine is the single most effective way to prevent seasonal flu or reduce the duration and severity of the illness should it be contracted.
- Tdap: This vaccine contains strains of tetanus, diphtheria and pertussis (whooping cough). All three are implicated in serious illnesses or death, according to WebMD. Just about every person, young and old, should receive the Tdap vaccine. The CDC says that every adult should get the Tdap vaccine once if they did not receive it as an adolescent. Then a Td booster shot every 10 years is sufficient.
- Shingles: People who have been exposed to varicella (chicken pox) in their youth are at risk for shingles as they grow

older. The CDC says nearly one out of three people in the United States will develop shingles in their lifetime. A shingles vaccine can protect against shingles and complications from the disease. Adults who are 50 and older should get the vaccine, which is administered in two doses.

- Pneumococcal polysaccharide vaccine (PPSV23): This vaccine protects against serious pneumococcal diseases, including meningitis and bloodstream infections. It is recommended for all adults age 65 and older.
- Pneumococcal conjugate vaccine (PCV 13): This protects against serious pneumococcal disease and pneumonia. Adults 65 years or older who have never received a dose of PCV13 should discuss PCV13 with their physicians.

Vaccines protect the very young from various diseases, but there are many vaccines that are still vital to health in adulthood.

Michigan Awarded \$1.65 Million Hereditary Cancer Grant by CDC

LANSING – The Michigan Department of Health and Human Services (MDHHS) Lifecourse Epidemiology and Genomics Division has received a \$1.65 million grant from the Centers for Disease Control and Prevention (CDC). The funds will be used to increase screening for family cancer history, and the use of genetic counseling and testing for hereditary cancer syndromes over the next three years.

MDHHS is one of four recipients to be awarded the CDC Cancer Genomics Program: Translating Research into Public Health funding opportunity, which supports the implementation and evaluation of activities and strategies related to screening cancer family history and the use of genetic counseling and testing. Oregon, Washington and Utah were also awarded funds. Michigan will receive \$550,000 annually for the next three years under the grant terms.


"Being aware of your family history and receiving a referral for cancer genetic counseling can help clarify risk," said Dr. Joneigh Khaldun, chief medical executive and chief deputy for health for MDHHS. "This grant will help Michigan continue efforts toward increased screening and testing."

With this grant, MDHHS will continue the promotion and support of hereditary cancer genomic services. This will include community and provider education, patient and provider resources, surveillance, community events related to hereditary cancer and policy/systems review and change.

The grant focuses primarily on Hereditary Breast and Ovarian Cancer (HBOC) and Lynch syndrome. HBOC is a condition which can cause an increased risk of breast, ovarian, pancreatic and prostate cancer in an affected person. Lynch syn-

drome is a condition which can cause an increased risk of colorectal, endometrial, ovarian, gastric, small bowel and other cancers.

Michigan has been a recipient of the CDC Cancer Genomic Program Cooperative Agreement since 2008.





Wolfpack Turns the Tables on Vikings LAINGSBURG -- It was Valentine's Day, and there was no love lost between the Laingsburg

Wolfpack and Potterville Vikings.

No pre-game chat between the rival coaches. Five Potterville assistant coaches standing shoulder to shoulder along the end line during pre-game warmups.

Who does that? A stand of unity? A show of strength? A try at intimidation?

No matter. No one on either team was intimidated by all the pre-game hype, or by the task at hand. LHS prevailed in a game that remarkably turned into a CMAC classic after the Vikings chipped-chipped away at a 15-point deficit throughout the second half.

"This (Feb. 14) game turned out to be like a mirror image of that first game," said Laingsburg coach Daniel Morrill. "The way Potterville came back, the way they tied it with a long threepointer, the way we won it at the free throw line. It was a great high school basketball game played by two really good teams.

"I'm so proud of my guys for hanging in there through this whole Laingsburg-Potterville controversy. They earned this one."

LHS came out running-and-gunning -- their typical style of play -- and ran to a quick 19-12 advantage. They maintained that through much of the 2nd quarter, getting scoring boosts from Gabe Hawes (playing with the flu), Connor Thomas and Zach Hawes. The 'Pack led 24-19 at

In the second half, the officiating tightened up, putting both teams in the double bonus for foul shots. Said Morrill, "With the lead, we knew they'd have to foul us to get back in the game. We hit our foul shots, we have the advantage."

The hosts made some. They missed some. What they didn't count on was Potterville post player Cole Krause. Krause scored 17 of his game-high 35 points in the 4th quarter. He kept the Vikes close, and after a stoppage in play, Cole Davis stunned the home crowd with a long threepointer to knot the score for the first time, 74-74, with just 8.8 seconds left to play.

Laingsburg inbounded the ball. And that's where the double-bonus played to their advantage. Gabe Hawes was fouled on the inbounds pass, went to the line for two free throws ... and calmly swished them both. Advantage, LHS, 76-74.
