If you believe in recycling as much of your waste as possible as one way to protect our environment, then you'll be glad to know the GLR is there for you. The recycling facility in Laingsburg (7500 Woodbury Rd.) will be open Saturday, March 12; Tuesday, March 15; Saturday, March 26. Saturday hours are 9 am to 1 pm; Tuesday hours are 4 pm to 7 pm. It is open to everyone, regardless of where they live. If you're coming from a distance, as many do, ask your friends and neighbors if they'd like to share loads and alternate trips. If you're connected with a business, contact us for a free waste audit or to see how we can help you save money by recycling. We also want to help schools reduce their waste and provide students with a great public service opportunity.

Things to know if you're new: Materials need to be sorted, fairly clean, and dry; if there are any problems with your materials, we'll gladly take the time to help you learn the ropes. The guidelines on what we can accept change frequently but it's not our fault—really! To better understand what's involved, read "Plastics Explained", an article from Recycle Ann Arbor at https://www.recycleannarbor.org/knowledge-base/plasticsexplained. Below is a current list of what we're taking:

Newspaper and phone books; tin and scrap metal; aluminum (separate); corrugated cardboard (include brown paper bags here); boxboard; mixed office paper and junk mail; magazines; books; #1 plastics, clear & transparent green or blue only (bottles and jars—no clamshells, e.g., takeout, berries and salad containers); #2 plastics (milk jugs/cloudy separated from solid color containers); #5 "tub" plastics (e.g., yogurt, sour cream, etc.; household batteries (please separate into regular, rechargeable, lithium and button); glass bottles and jars (all colors); electronics (there is a \$5 fee for flat screens); and empty inkjets from Canon, Brother and HP. We now also accept dental care products like toothbrushes, spent toothpaste tubes, and floss containers.

GLR cannot accept plastic bags polystyrene/Styrofoam. However, the latter is accepted at the St. Johns Lions', Meridian Township and East Lansing sites; and stores like Meijer, Kroger and Walmart take the bags.



Letter to the Editor

I've been hearing things being said about the Ovid-Elsie School District. I'm really curious and maybe other district taxpayers should be too. I guess I'm addressing my curiosity to the people in charge – the school superintendent and assistant, the school board and anyone else with decision making responsibilities for the Ovid-Elsie School system.

IS IT TRUE THAT:

--there was a 2019 bond renewal approved to complete major repair in some restrooms in school district buildings and the work has yet to be completed?

--there is a millage that was approved containing the words "stadium repair" that has now led to a \$1.8 million dollar artificial turf installation replacing the natural grass turf?

--the OE school system will be getting a loan to pay for a

large sum of the turf project?

--the loan in question is for 10 years?

-- the loan payments will be \$115,000 per year paid from the general fund? So out of \$1.8 million, \$1,150,000 is being borrowed and paid back – at what interest rate? So we have only \$650,000 to put into this project? And what general fund projects will get cut because we are using that money for our "new

-- the warranty for the turf was negotiated for 7 years (2 more years than normal warranty)?

--the loan could outlast the life of the turf?

--the cost analysis presented showing info about the turf project has almost all identical numbers to a generic document found on the internet? Convince me that the OE cost analysis is valid for OE estimates. Was it just copied to "look good" and has no real factual numbers relating to the job at OE

-that some people making OE school district financial decisions don't all even live in this school district?

--there are other simple issues not being addressed such as rules in place for a dress code at the high school, for bullying, and for hard lock-down actions?

These are just a few of my questions. I'm sure others also have questions. I believe a few people spending money for many people need to be conscientious about what they are doing. Are they making smart, sensible financial decisions for the majority of students or making not so financially smart decisions for just a few students?

I now have this phone number on my phone's contact list and I also wanted to thank the very kind and sup-

portive lady at the Probate Court office in Ithaca who told me about affidavits and made my life simpler. Since I was in Ithaca I went over to the Mercantile Bank which is also my bank and the ladies there helped me fill out the affidavit and notarized it for me. Even with all the angst that events were showering me with, I also got to work with some very kind and compassionate people. 

How To Involve Seniors in Your Community

The negative effects of isolation is something the vast majority of the world can now relate to. The COVID-19 pandemic forced people from all walks of life and from every corner of the globe to spend less time with friends, family members, neighbors, and other acquaintances. As the world cut back on in-person interactions to curb the spread of the virus, billions of people recognized just how difficult feelings of isolation can be.

A report from the National Academies of Sciences, Engineering, and Medicine indicates that roughly 25 percent of adults aged 65 and older are considered to be socially isolated. Seniors are invaluable resources in their communities.

· Promote senior-friendly volunteering opportunities. The importance of volunteers was never more apparent than during the pandemic, when many nonprofits and other organizations were forced to meet their missions without the assistance of volunteers who had been urged to stay home. Communities can facilitate by developing and highlighting senior-friendly volunteering opportunities. For example, libraries can start a program where seniors read to children in person or via Zoom.

· Give seniors a chance to teach. One great way to shed light on local history is to invite local seniors to speak about how life in their communities has changed and how it's stayed the same. Themed speaking series can attract locals with specific interests. For example, local veterans can be asked to share stories of their time in the service, while retired business owners can offer insight and advice on running successful local businesses.

· Develop nature-based programs. A 2019 study published in the journal Scientific Reports found that spending just 120 minutes a week in nature is associated with better overall health and improved well-being. Nature-based community programs, such as planting days at local parks, hiking clubs or even beach or lakeside cleanups, is a great way seniors, to get their weekly



'St. Charles played well tonight and stayed in position to win their second straight MSAC championship" commented Coach Shaw.






