Applications for the Commodity Supplemental Food Program (Senior CSFP) are currently begin taken by phone. This program provides nutritious food, on a monthly basis, to low-income residents of Shiawassee County who are 60 years of age or above.

Persons 60 years of age or older must meet the 130% Poverty index. Family size 1 - \$17,667; family size 2 - \$23,803; family size 3 - \$29,939. For each additional family member add \$6,136. Distribution begins August 2, 2022.

Also: Applications for The Emergency Food Assistance Program (TEFAP) are currently being taken by phone. This program provides nutritious food, to low-income residents of Shiawassee County.

New Household Applicants must meet the 200% Poverty index. EFFECTIVE: May 1, 2022 NEW FINANCIAL GUIDELINES are: Family size 1 - \$27,180; family size 2 - \$36,620; family size 3 - \$46,060. For each additional family member add \$9,440.

Distribution for Shiawassee County will begin August 2, 2022.

The procedure will be drive through the first day only. No food will be placed on the front or back seats of the vehicle. "Trunks" should be open before driving up to receive the food.

If you do not already have someone designated to pick up your food, you may call the CACS office at 989-723-3115 and let us know who you are designating to pick it up. If you are not registered, please call the office at 989-723-3115 to pre-register.

Available hours are 9:00 a.m. to 12:00 p.m. and 1:00 p.m. to 4:00 p.m.

## Project Connect 2022 Offers Drive-thru and In-Person Options

Back to school "Project Connect" will once again be serving families across Clinton County with three drive up events and one in-person event. Backpacks, school supplies, new socks and underwear, food, community resource information, and hygiene kits will be provided for school age children in need. Drive up events are scheduled for Bath on Tuesday, August 9th from 9 to 11AM at Bath Middle School parking lot, Ovid & Elsie on Thursday, August 11th from 9 to 11AM at the Ovid-Elsie High School parking lot, Maple Rapids on Tuesday, August 16 from 5 to 7PM at the Maple Rapids Community Ball Field, and the in-person event in St. Johns on Thursday, August 18 from 3 to 6PM at the Clinton County Fair Grounds. Families should choose the event that is most convenient for them and they MUST REGISTER AHEAD OF TIME by July 31st to participate in the event in their area. Last year Project Connect served 230 households with approximately 600 children. School age children received

backpacks with school supplies, new pairs of socks and new pairs of underwear and each family received a food box. Free haircuts will be offered at the St. Johns location only this year however, there will not be any used clothing available this year.

Project Connect is a service for Clinton County individuals and families with limited resources and is supported by many human services agencies, programs and businesses in Clinton County. To support Project Connect, the Clinton County Council for the Prevention of Child Abuse & Neglect is partnering again this year with Dean Transportation and Kroger's of St. Johns to do a "Stuff the Bus" with school supplies on Wednesday, August 3rd, in the Kroger Parking lot from 9AM to 3PM. Anyone wishing to donate but cannot participate in the Stuff the Bus event may drop off school supplies, new socks or new underwear at the Caring & Sharing Family Life Services and CAN Council office at 1000 E. Sturgis St., Suite 5, St. Johns, Monday thru Thursday 9AM to 4PM or call us for an appointment or pick-up. All donations from Stuff the Bus will be used for Project Connect.

### Village of Ashley Blight Ordinance 2011-03 (as amended)

**AN ORDINANCE TO PREVENT, REDUCE OR ELIMINATE BLIGHT, BLIGHTING FACTORS OR CAUSES OF BLIGHT WITHIN THE VILLAGE OF ASHLEY, GRATIOT COUNTY, MICHIGAN; TO PROVIDE FOR THE ENFORCEMENT HEREOF; AND TO PROVIDE PENALTIES FOR THE VIOLATION HEREOF; PURSUANT TO THE ENABLING AUTHORITY THEREFORE PROVIDED BY ACTS 344 (MCL 125.71 ET SEQ.) AND 246 (MCL 41.181 ET SEQ.) OF THE PUBLIC ACTS OF 1945 AS AMENDED.**

**THE VILLAGE OF ASHLEY, GRATIOT COUNTY, ORDAINS:**

#### Section 1. PURPOSE

Consistent with the letter and spirit of act No. 344 of the Public Acts of 1945, as amended, it is the purpose of this Ordinance to prevent, reduce or eliminate blight or potential blight in the Village of Ashley by the prevention or elimination of certain environmental causes of blight or blighting factors which exist or which may in the future exist in said township.

#### Section 2. CAUSES OF BLIGHT OR BLIGHTING FACTORS

It is hereby determined that the following uses, structures and activities are causes of blight or blighting factors which, if allowed to exist, will tend to result in blighted and undesirable neighborhoods. On and after the effective date of this Ordinance, no person, firm or corporation of any kind shall maintain or permit to be maintained any of these causes of blight or blighting factors upon any property in the Village of Ashley owned, leased, rented or occupied by such person, firm or corporation.

#### A. Motor Vehicles

1. Any parking, storage or accumulation of inoperable motor vehicles on any private property, unless that storage or accumulation is inside a completely enclosed building, or a fence made of such material as would hide said accumulation from view, or if such accumulation and/or storage is accomplished in such a manner as to conceal same from view from adjacent private or public property, including public or private roads.  
2. No such storage or accumulation shall be permitted when such storage presents a hazard to public health or safety.  
3. Nothing contained herein shall prohibit the storage, out-of-doors, of motor vehicles commonly licensed for farm use, whether such license is currently in effect or not, or recreational motor vehicles and trailers, whether currently licensed or not.  
4. For the purpose of this Ordinance, an inoperable motor vehicle is defined as a motor vehicle not in operating condition and eligible for use in accordance with the requirements of the Michigan Vehicle Code. These requirements include, but are not limited to, an engine that runs, four wheels and four tires capable of holding air, current license plates, and a working battery.

#### B. Building Materials

1. The outdoor storing of building materials is permitted at any retail or wholesale building supply establishment located in a commercial or industrial district. The outdoor storage of building materials is permitted in other zoning districts when stored for the purpose of construction for which construction, a valid building permit has been issued by the appropriate county or village building official and where said materials are intended for use in connection with such construction.  
2. For the purposes of this Ordinance, the term "building materials" is defined to include lumber, bricks, concrete, cinder blocks, plumbing materials, electrical wiring or equipment, heating ducts or equipment, shingles, mortar, cement, nails, screws or any other materials used in constructing any structure.  
C. In any area, the storage or accumulation of junk, trash, rubbish or refuse of any kind without a land-fill permit, except domestic refuse stored in such a manner as not to create a nuisance for a period not to exceed thirty days. The term

"junk" shall include parts of machinery or motor vehicles, unused stoves or other appliances stored in the open, remnants of woods, metal or any other material or other cast-off material of any kind whether or not the same could be put to any reasonable use.

D. In any area the existence of any structure or part of any structure, which, because of fire, wind or other natural disaster, or physical deterioration is no longer habitable, if a dwelling, nor useful or any other purpose of which it may have been intended.

E. In any area, the existence of any vacant dwelling, garage or other outbuilding unless such buildings are kept securely locked, windows kept glazed or neatly boarded up and otherwise protected to prevent entrance thereto by vandals, or other unauthorized persons.

F. In any area the existence of any partially completed structure unless such structure is in the course of construction in accordance with a valid and subsisting building permit issued by the County or Village and unless such construction is completed within a reasonable time.

#### Section 3. ENFORCEMENT AND PENALTIES

A. This Ordinance shall be enforced by such persons who shall be so designated by the Ashley Village Council.  
B. Any violation of this Ordinance shall constitute a nuisance per se. Violation of, or any failure to comply with, the provisions of this Ordinance shall be deemed a misdemeanor and shall be punishable by a fine not to exceed five hundred dollars (\$500.00) or by imprisonment but not to exceed ninety (90) days or both. Each day that a violation of this Ordinance is continued or permitted to exist without compliance shall constitute a separate offense punishable upon conviction in the manner prescribed in the Section, provided no person shall be imprisoned for a period in excess of ninety (90) days.

C. In the event a Court Order is entered ordering the abatement of such nuisance, the designated enforcement officer may, if the Defendant fails to obey such Order, take such measures as necessary or as directed by the Village designee to abate such nuisance and the entire cost thereof including all costs and attorney fees shall, at the option of the Village designee, become a lien against the premises upon which the nuisance was located and shall be added to the tax rolls, or become a deficiency Judgment to be enforced by levy, execution, garnishment or otherwise.

#### Section 4. SEVERABILITY

Should any provision or part of the within Ordinance be declared by any court of competent jurisdiction to be invalid or unenforceable, the same shall not affect the validity or enforceability of the balance of this Ordinance which shall remain in full force and effect.

#### Section 5. EFFECTIVE DATE AND ADOPTION

A. This ordinance shall become effective eight days after its publication as required by law. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.  
B. This Ordinance was adopted by the Village Council of the Village of Ashley, Gratiot County, Michigan at the Regular meeting thereof held on July 14, 2022.

## WIC Fruit and Vegetable Benefit Increase

The Shiawassee County Health Department Women, Infants, Children (WIC) Program is reminding pregnant women and mothers of children under the age of five that congress has increased the fruit and vegetable benefits through September 2022.

Families participating in the WIC Program can now receive:

- \$24/month for children
- \$43/month for pregnant and postpartum women
- \$47/month for breastfeeding women

The increase in benefits assists families in Shiawassee County build nutritious diets and get a healthy start. These benefits also promote a wider variety of fruits and vegetables as children are trying new foods and developing their taste preferences. Since the food and vegetable increase, more children are consuming healthier food providing positive nutrition education within our community.

The Shiawassee County Health Department WIC Program is accepting new families! Eligible participants include:

- Women who are pregnant, breastfeeding, or have had a baby within one year
- Infants (birth to one year of age)
- Children from 1 year of age to their 5th birthday
- Single fathers, grandparents with guardianship, foster families, and others who meet the income guidelines

The WIC Program works to provide families with nutrition education, breastfeeding support, and shares referrals for healthcare, immunizations, and other eligible programming.

### Wolfpack, Ovid-Elsie Players Dot All-Area Softball Team for 2022

LAINGSBURG — No fewer than 11 local softball standouts have been showcased on the 2022 All-Area honor team.

The annual all-star squad, as chosen by the Owosso Argus-Press, is dominated by Laingsburg on the 1st Team and Ovid-Elsie on the 2nd Team. In addition, two other Wolfpack players were named to the Honorable Mention contingent.

The 1st Team features Hailey Bila, a centerfielder for coach Jeff Cheadle's Wolfpack. Bila, who is committed to play next season at Michigan State University, led the area in home runs with 14 and runs-batted-in with 72. She pulled the most astonishing feat of any area player this season, hitting two grand slams in one inning vs. Webberville on May 19. Overall Bila batted .534 with seven doubles and eight triples to go with her four-baggers. A sure-handed fielder, Bila was a first-team All-CMAC, All-Region and All-District player.

The All-Area pitching corps, after Player of the Year Macy Irelan from Owosso, featured both LHS hurlers on the 1st Team.

Addyson Buchin, a freshman righthander for the Wolfpack, compiled a 2.05 earned run average over 102 1/3 innings, striking out 136 and walking just 21. She gave up 30 earned runs and crafted a 13-6 won-loss record. Buchin was a second-teamer in the CMAC and also captured All-District and All-Region honors. In the box, Buchin batted .468 with 52 hits, 37 RBIs and 15 doubles, helping the Wolfpack reach the D3 regional finals.

She was joined on the 1st Team by Kailey Cataline. Forming a solid 1-2 punch with Buchin, Cataline posted a 13-1 record with a 3.26 earned run average. She struck out 64 and walked 27 in 77 1/3 innings, and gave up 36 earned runs. The Wolfpack captured CMAC honorable mention honors along with All-District distinction. The senior also played the third base position and batted .345 with 29 hits and 21 RBIs.

Hailey's sister, Ashley Bila, a sophomore, captured first-team all-CMAC, all-district and all-region recognition. She ranked third in the area in batting average at .623 and was third in hits with 66. Bila had 24 stolen bases and 30 RBIs as the All-Area 1st Team shortstop.

Ovid-Elsie's Maddisyn Miller was named the 1st Team catcher. She batted .495 on the season which ranked 10th best in the area. She slugged 52 hits and drove in 51 runs, which was good for fourth in the area. Her on-base percentage was .569 and her fielding percentage was .950.

Ellie Baynes was an Honorable Mention All-Central Michigan Athletic Conference pick for Cheadle's Wolfpack, which closed the season at 26-6 overall.

## Marauders' Bowen, Janes and Wolfpack's Randall Lead Locals on All-Area Baseball Team

OVID-ELSIE — Jake Bowen and Corbyn Janes represented Ovid-Elsie, and Laingsburg's honoree was Ty Randall as the Owosso Argus-Press announced the All-Area boys baseball team for 2022.

Both Randall (shortstop/pitcher) and Bowen catcher/1st base) were feted on the 1st Team. Janes was selected as a 2nd Team pitcher. In addition, the Wolfpack's Ethan West and Nick Regan were Honorable Mention picks.



### Here We Go Around the Mulberry Bush

Andy,

Today, when I got home from work, my kids were purple ...lots of purple fingers, lips, hair streaks and clothes. They found our Mulberry trees in the back woods. They picked and nearly filled several 3 gallon tubs and probably ate just much. Couple of questions: Is it ok to eat wild berries? Is it a bush or a tree? Can I make jam out of the berries? And, if so, how do I get the tiny green stems off the berry? Purple Kids Mom

Dear PK Mom,

Your email made me laugh, out loud. It reminded me of some childhood memories when I visited cousins on the farm. I am glad the berries they found were for human consumption. Summer time is a great time to teach your children about which berries are just for birds and which are safe berries for eating. So glad they didn't get into the poison ivy, this time of year it's everywhere along with ticks. We use Googlepictures.com and print off pictures to educate our family and kids that visit. Yes, it is ok to eat berries from the wild but not if the bush or tree or plants are near heavy traffic roads...too much carbon from the exhaust. Be Cautious.

The answer to your other interesting question... It's is both, a bush and a tree. The one in my yard is a tree with both high and low branches. I know it is at least 40 years old. We try to pick every year, before the birds spread the word around about the location of the yummy purple sweet fruit, which dries up fast in the July heat wave. I often see Mulberry bushes at trail heads or growing over an arch in older farm yards. I remember singing the song "Here We Go Around the Mulberry Bush" and dancing and singing underneath the branches that hung to the ground. If you don't remember the song...it is found in most beginning piano books and it is still sung at pre-school. Or ask your grandma.

Next question...yes it makes delicious jam. I use the recipe off the Sugarless Sur Jel® using the same amounts: 1 box, 5 Cups of berries and 1 Cup of white grape juice. (The berry is sweet but so is the 7 Cups of Sugar the other recipe, which is needed to set up the jam) Before you lightly mash the berries, the stems must come off...I use my Great Ol' Aunt Hilda's method...I bite the stem off of each berry. It is tedious but worth it. After about a dozen berries I spit out the stems into the trash. Yup, now I have done it and gave my secret method away...but tweezers will also work. Be sure to wash off the berries and sterilize the jars.

My grandchildren and friends pick berries when they go kayaking this time of year and before they have the kayaks cleaned and hung up, I have Wild Mulberry cobbler in the oven. Crumble 1 stick of soft butter, 1 C. oatmeal, 1/2 Cup of Sugar pour over the "Bush" Mulberries (no stems) and bake at 350 degrees for 20 minutes. Serve with a scoop of ice cream.

Today, I found an "I love you grandma" note on my table. You guessed it... written by my 12 year old granddaughter with Mulberry juice from the berries. It's a keepsake. Tomorrow we make jam.
