

Luckily, three individuals from the business were not at their desks at the




Bovan, the matriarch of the business, was home sick, owner, Jennie Martin was at lunch and son, Luke Martin had just left for lunch. "Had Bev or Jennie been here, surely the outcome of this incident would have been more than just building damage, it could have been life threatening," said business owner Gregg Martin. The vehicle hit a safe that was placed between two desks at the front of the office. It sent the car to the right and to the back of the office. "Had that car not hit the safe and changed the trajectory of the car, I believe my husband would have been severely injured," explained Jennie Martin.

Our family is so blessed to live in such a kind and caring community and thankful that no one was injured," explained Martin.

ELSIE - The monthly meeting of Ovid-Elsie Area Schools was held Monday, February 20, 2023 in the O-E High School Auditorium. The evening was highlighted by the selection of Mr. Randy Barton as the Ovid-Elsie Area Schools Superintendent.

CCRESA Superintendent Scott Koenigsknecht introduced himself as the new superintendent effective July 1, 2023. Koenigsknecht is originally from the Clinton County area. He gave an overview of his career experiences and is currently employed at the Michigan Department of Education. His goal is to visit each school district in Clinton County annually.

Building department updates. Mrs. Parsons, Leonard Elementary principle, reported that the winter data collection has been completed and students have been assigned groups to improve academic growth and success; parent/teacher conferences have been completed and the kindergarteners celebrated 100 days of school. In addition, a kindness project is

currently underway.
Mrs. Ormesbee, EE Knight principle, updated officials on the happenings at EE Knight. The parent/teacher conferences have been completed, a successful book fair was held and 1,918 items were collected for the Elsie Food Pantry and this week students will celebrate Bus Driver Appreciation Day and will reinforce bus behavior and expectations. Finally, preparations are underway for Reading Month with a superhero theme.

Mr. Ormesbee, O-E Middle School, reported that Valentine's spirit week was a true celebration and that school dances and open gym have been a success. Mr. Grandstaff's song writing class presented to their peers and had an opportunity to work with a professional song writer from Nashville and created and published a song. Also, parent teacher conferences will take place in mid-March.

Dan Davenport, Technology Director, updated officials on the \$83,000 grant which will be used to purchase one-to-one devices for three grade levels k-2. The purchase will replace all of the older devices at pre-inflation prices. A great purchase. The department is also working on fiber to connect EE Knight to insure network connectivity. In addition, moving forward with bus garage break-in insurance claim.

Mr. Powell, O-E High School, reported that the sophomores hosted a winter formal which was a huge success and this week is FFA Week and Charity Week.

Officials were presented a Benchmark Goal Reporting 98b by Mr. Randy Barton, interim superintendent. NWEA assessment is used and is aligned with the State standards. On the average students are at 64% which is not unusual with the district's demographics in the majority of the category's students are making improvements. Students did show improve-

Monthly action was taken to approve the consent agenda that included: approval of the meeting agenda, approval of minutes from the January 26, 2023 regular meeting, the February 2, 2023 and February 6, 2023 special meetings; and the financial reports. Action was taken to move financial reports to the last new business item, as requested by Kevin

Financial reports were reviewed as requested by Kevin Nash. Nash would like to see additional clarity because the bank balances do not align. A refined report will be available at the next meeting. The monthly financial statements were approved.



Spartan Tragedy

The Weekly Sportsman wanted to write this column a week ago but pressed pause for numerous reasons. First, it was too soon after the active shooter event at Michigan State University and many in our community were either still in shock or starting the grieving process. Secondly, the Weekly Sportsman was hoping that what was being reported about the alleged suspect's criminal history was inaccurate. This column will not mention the alleged shooting suspect by name because he simply does not need to receive any more notoriety. Because politicians are using this tragedy to rush\facilitate the passage of a gun control package in Lansing along with protesters visiting the steps of the Capitol Building twice this week it is now appropriate to discuss why this may have actually happened.

There are never any clear answers to why these mass shootings occur. Sure, after some time it comes out that there was a possible motive but what is really disturbing at this point is not only a lack of a really clear motive but that this incident could have been stopped. Were there warning signs or red flags observed by the suspect's father and neighbors? Yes. Was there a history of mental health issues? Yes. Does MSU have some security issues with their antiquated buildings? Yes. Was there a history of criminal behavior and shoddy prosecutorial efforts? Yes, most definitely, and that is the most disturbing part of this whole tragedy when you drill down and learn the details.

Hindsight is always 20/20 and it is almost too easy to play the would've, could've, and should've game. That being said,

most readers will become very angry when they learn that this whole event could have been prevented with current felony firearm laws already on the books in Michigan. The story starts back in 2016 when



Carole Siemon was elected Ingham County Prosecutor. During the next six years of her tenure she did not hide the fact that her office would pursue criminal justice reforms by limiting the prosecution of felony firearm possession charges. She proclaimed that this would reduce racial disparities in the criminal justice system. In 2021 she went even further saying she wouldn't prosecute secondary firearms violations from traffic stops. Fellow democrats like Lansing's Mayor Andy Schor and Ingham County Sheriff Scott Weigglesworth along with many local police chiefs wrote editorials and held press conferences warning against the harm she was doing. Sheriff Wrigglesworth said these policies were not worth the cost of a single human life.

The shooting suspect was previously charged in 2019 with illegally carrying a concealed firearm and should have a felony on his record and served time, however, he was allowed to plea it down to a misdemeanor with probation. He completed probation by 2021 and was legally allowed to purchase more firearms. And he did. Siemons kept him out of prison at the cost of the MSU tragedy. It doesn't matter what new laws legislators pass to prevent these mass shootings when current laws aren't enforced and prosecuted right now.

But what did the Son of David say about this "now" retirement strategy? 




