

For those of us who believe in the gospel, we used to be slaves to sin.

Jesus says, "Very truly I tell you, everyone who sins is a slave to sin."- John 8:34

Romans 3:23 says that all have sinned and have fallen short of the glory of God.

So today will be a big baking day. I need to get the pie dough done as soon as I get in the door. It is good to have daily goals and to be dizzy. It would be better if I got over this procrastination mode that has settle on me.

Right now everything is setting by the door and ready for me to grab and go. I still need to finish this missive up and to finish getting dressed. I seem to be moving in slow motion this morning. I'm still counting my blessings. I hope that you all have a memorable Easter filled with many of God's blessings.

MDHHS Screening Reminder

LANSING, Mich. – The Michigan Department of Health and Human Services (MDHHS) is reminding Michigan residents of all ages to perform routine breast health checks and monitor changes in their breasts as part of National Young Cancer Awareness Week. This advice reflects the fact that 9% new breast cancer diagnoses happen in adults under age 45.

"If you notice concerning changes in your breast, contact your health care provider," said Dr. Natasha Bagdasarian, MDHHS chief medical executive. "While changes in breast tissue don't necessarily mean cancer, it's important to take a proactive approach to ensure any concerning health issues are caught and treated as early as possible.'

Changes to look out for include:
A lump or abnormality in the shape or feel of the breast.

A lump in the underarm area.

Swelling on all or part of the breast.

Irritation or dimpling of skin.

Nipple retraction (nipple turning inward).

Rash or redness.

Spontaneous discharge from the nipple.

If you are uninsured or underinsured, contact the Breast and Cervical Cancer Control Navigation Program (BC3NP) for help with follow-up on identified breast changes. The program provides free breast and cervical cancer screening and diagnostic services across the state for low-income individuals. Women diagnosed with breast or cervical cancer may be eligible for a special Medicaid program that pays for cancer treatment. MDARD Encourages Continued Vigilance Against Disease

LANSING, MI - With the sale of baby poultry (chicks, ducklings, etc.) this spring, the Michigan Department of Agriculture and Rural Development (MDARD) is reminding Michiganders who purchase and care for these birds to take preventative measures so both their birds and they themselves are protected from diseases like Salmonella.

These preventative measures include any action people can take to make sure harmful germs are not being transferred from them to their birds or from their birds to themselves.

"The best way to keep domestic birds healthy is prevention," said State Veterinarian Dr. Nora Wineland. "Simple steps such as washing your hands before and after caring for birds, wearing boot covers or shoes dedicated to a coop, and having no outside visitors to your flock can help ensure birds are not being exposed to germs that could cause serious illness, like highly pathogenic avian influenza (HPAI). Making these actions routine is key to preventing disease and keeping Michigan's flocks healthy."

HPAI is a highly contagious virus that can be spread in various ways from flock to flock, including by wild birds, through contact with infected poultry, by equipment, and on the clothing and shoes of caretakers. In 2022, Michigan had 22 confirmed cases of the disease in domestic flocks of various sizes; and this year, two more cases have already been detected—one in a backyard flock and one in a hunting preserve.

According to the U.S. Centers for Disease Control and Prevention (CDC), the public health risk associated with HPAI remains low. In addition, no birds or bird products infected with this disease will enter the commercial food chain.

Another disease-causing germ linked to live poultry is Salmonella, a bacteria found in the droppings of poultry, which can cause illness in people.

In 2022, the CDC reported numerous cases of Salmonella that were linked to backyard poultry, involving 1,230 people across 49 states. Even if birds look healthy and clean, they can still be carrying the Salmonella bacteria; and measures need to be taken to prevent illness.

No matter the type of germ, species of poultry, or size of flock, following these preventative measures are fundamental to protecting your health and the health of your flock:

Preventing contact between domestic poultry and wild birds by bringing poultry indoors to a barn/coop or ensuring their outdoor area is fully enclosed.

Washing your hands before and after handling birds and/or their eggs as well as when moving between different coops.

Disinfecting boots and other gear when moving between coops.

Not sharing equipment or other supplies between coops or other farms.

Cleaning and disinfecting equipment and other supplies between uses. If it cannot be disinfected, discard it.

Using well or municipal water as drinking water for birds. Keeping poultry feed secure so there is no contact between the feed/feed ingredients and wild birds or rodents.

Not touching birds to your face.

Keeping poultry away from areas where food or drink is prepared, served, or stored.

Handling and cooking all eggs and poultry properly.

Monitoring a flock for multiple sudden deaths, a drop in egg production, a significant decrease in water consumption, diarrhea, sneezing/coughing, or an increase in sick birds.

If avian influenza is suspected in domestic birds, contact MDARD immediately at 800-292-3939 (daytime) or 517-373-0440 (after-hours).

It is also recommended to remain outdoors when cleaning

any equipment associated with raising or caring for poultry, such as cages, feed, water containers and other materials. Then, store the cleaned equipment in an area where it cannot be accessed by wild birds or rodents before its next use.

Spring Evaluation Camps for College Football Hopefuls

EAST LANSING – The Michigan High School Athletic Association, in partnership with the Michigan High School Football Coaches Association (MHSFCA), will be hosting firstever Spring Evaluation Camps to provide athletes with aspirations of playing college football opportunities to show their pm and games begin skills and abilities to college coaches at one of five locations.

The one-day camps will take place between May 16-19 at Jenison High School, DeWitt High School, Jackson High School, Brighton High School and Detroit Country Day High School. The MHSAA's involvement will allow for the opportunity for Division I college coaches to attend, and representatives from college football programs at all levels are expected.

Athletes who will be juniors or seniors in Fall 2023 may register to participate via a link on the Football page of the MHSAA Website at https://www.mhsaa.com/sports/football.

"This is an attempt by the MHSAA to help our athletes get exposure during the spring evaluation period in a way that does not intrude on spring sports," said Brad Bush, an MHSAA assistant director and past high school and college football coach. Cost is \$20 per player, and each registrant will receive a shirt to wear based on the athlete's graduation year and registration number so college coaches in attendance can monitor their camp performance. College coaches also will receive registration information for each athlete in attendance

All athletes must have a coach from the athlete's school staff present at the camp, and that coach must be a member of the Michigan High School Football Coaches Association.

MHSFCA executive director Andrew Pratley called the Spring Evaluation Camps a tremendous opportunity for high school athletes in Michigan.

"We are very excited with the partnership with the MHSAA that allows our kids the opportunity to wear a helmet and do drills in front of college coaches in the spring at a minimal cost," Pratley said. "College coaches are thrilled, and it's a unique opportunity to have the rules waived by the MHSAA at these events only in order to showcase the tremendous talent all over the great state of Michigan.'

The Michigan High School Football Coaches Association (MHSFCA) has been devoted to the promotion of high school football since its inception in March 1972. The MHSFCA has more than 2,500 members and provides several educational and development opportunities for members and their athletes, including an annual coaching clinic, an annual leadership conference for coaches and potential team captains, and the annual summer East-West All-Star Game for graduated seniors. Additionally, the MHSFCA's Leadership Development Alliance is in its third year of training coaches and offering veteran members of the association as mentors.

The MHSAA is a private, not-for-profit corporation of voluntary membership by more than 1,500 public and private senior high schools and junior high/middle schools which exists to develop common rules for athletic eligibility and competition. 2nd Annual Laingsburg Alumni Legacy Award Golf Outing Now Taking Registrations


LAINGSBURG — A Laingsburg success story in the making is picking up steam.
