# **Local Pole Vault Showdown Ends with O-E's** Tokar Repeating as State Champ KENT CITY — Over the course of two seasons, the battle between Ovid-Elsie's Tryce Tokar

and Laingsburg's Jack Borgman has turned into quite the rivalry.

Pole-vault speaking, of course.

The two might live barely 15 miles apart, but in two track-and-field campaigns the local duo have established themselves as the best vaulters in the state of Michigan.

Tokar and Borgman went at again June 3 at the MHSAA Division 3 State Finals in Kent City. A few days earlier, at the Lansing Honor Roll Meet, Borgman topped 15-feet to break his LHS record and nip Tokar for individ-

The Ovid-Elsie sophomore returned the "favor" at the State Finals . vaulting 15 feet even to break his own O-E HS standard, and repeating as the Division 3 state champion. Borgman was close behind, clearing 14'9" as the



Stayed tuned, folks. They're both underclassmen and return to their teams in 2024. In the team competition, Ovid-Elsie was tied for 21st with 10 points. Laingsburg last won the boys State Title in 1967, but was out of the team race this go-round.

Ovid-Elsie's Clay Wittenberg tied for ninth in the high jump (6-1). The Marauders' Beau Price placed 19th in the 400 meters.

In the girls Division 3 state finals, Laingsburg's Madison Phillips placed sixth with a personal-best 10-0 in the pole vault. Ovid-Elsie's Alexis Spitzley placed 9th in the 800 meter run.



#### Rabbits and Squirrels Declared Nuisance by NRC & DNR

The two most commonly hunted small game animals in North America, and most certainly Michigan, are the rabbit and squirrel. For the last several centuries, from colonial times to modern day, these species have been relentlessly pursued with extreme vigor to provide the primary and or supplemental protein necessary for subsistence living in bad times as well as gournet dining during good times. Generations ago many young hunters learned to hunt by chasing this quarry on weekends and during breaks from required schooling. Now all of that tradition has possibly come to an abrupt halt with the passage of Wildlife Conservation Order Amendment No. 6 of 2023 because rabbits and squirrels have now been declared a nuisance and it is open season year round.

The DNR has openly admitted that due to staffing issues they can no longer adequately handle complaints about damage caused by small wildlife. In the past, on site inspections followed by the permitting process has taken way too long so if these small game animals are present and about to do damage you are allowed to trap or use regular hunting methods year round with no bag limits. Thoughts?

Dear Andy,

My husband and I recently moved here for his job. We live in a small town several miles from the city where he works. We have 3 children under the age of five. I am trying so hard by myself every day to make sure my children receive proper nutrition, good learning experiences, live in a safe environment and keep the house clean and organized. I love my life, but now that it is so full of activities, settling in our new home, making new friends, and raising the children, I am beginning to think I am unqualified and overwhelmed. Maybe I should go back to work and hire a professional nanny.

Now that the weather is nice, not too hot and not raining, my children want to play every day for hours in the morning and again in the afternoon. The only time I get anything done is when they are napping, which isn't always at the same time. We transferred here from a dry climate, and we decided we could afford for me to stay home for a few years with the children. I am loving that part of our decision to be here. But, my support group is in Texas. So, I am on the phone after their bed-time

My biggest concern and worry are about my children getting bitten by mosquitos or spiders or bees and tiny ants that are everywhere in my sidewalk cracks. I have seen so many different bugs since we moved here. I have had several bad dreams about us being attacked. Silly, I know! I don't want to use repellents with dangerous chemicals on our skin or in our play areas. What do you suggest? Nervous stay-at-home mom

#### Dear Mom,

At least you took time to write to me and obviously took time to read your local paper. First of all, talk to your family doctor to have assurances you are taking care of yourself. Being too anxious can cause long-term health problems for you. As for the children and household responsibilities...it will get done eventually. Ease up on yourself. It's an admirable profession to raise your own children.

Ask your husband to help, too. He will want specific assignments, such as reading to the children or watching them play while you fix dinner. I understand he works hard and is gone the majority of the day; your situation will likely not be that way forever. So, I recommend you engage Daddy so that he does not become distanced from home responsibilities. Take time for YOU, and for you and your husband. Children grow up fast without instruction manuals. You do not need to be an overachiever mom. There is a book written on every concern any mom could ever have. Check Amazon listings or your local bookstore (which is a great get-away with coffee and no children).

Make your summer meals simple. Get a sandbox and age-appropriate outdoor toys. You may want to hire a neighbor teen to help a few hours a week. Call your local High School, they often can make some recommendations of someone who lives near you. Look for free concerts, farmers markets, or a splash park and playground, near you. Most small towns, near big cities offer opportunities for fun and activities for children of all ages. Check your local library for reading and art fun for kids.

One more suggestion, order your groceries online and have your husband pick them up on his way home. As for mosquitoes and bug repellent, I like the twisty bracelets that can be placed on the ankle over a sock. They come in assorted colors and the compound is not a spray. Go to ERMPRODUCTS.COM/FREE. The company will send you samples of their newest products recommended for children and sensitive skin. Always cover them with UV sun lotion for children, before they go out to play.

As for bees, teach your children not to run or panic. Stay CALM. Bees are attracted to the smell of fear and your breath. Teach them not to swat the bee and to cover their mouth. Bees will fly away within 10 seconds, if not bothered. Just in case: Keep baking soda and water handy to use as a paste to bring out the stinger or serum from a possible sting. Watch for immediate breathing problems or severe swelling in case an allergic reaction occurs. If you have a reaction, take your child to your family doctor or clinic immediately.


