45 Years: Lady Wolfpack Rallies, Claims First Regional Crown Since 1978

NEW LOTHROP -- In 1978, a roster loaded with talent that included the likes of Carrie Koonter, Lisa Mahoney, Robbin Sawyer, Sue Hurst, Barb Britton, Debbie and Brenda Wrobel, Ann Walters, Lessa Potter, Kathy Sparkes, Annette Brust, Kim Nickols, Lori Kriebehl, Lisa Argersinger and Sandy Putnam led Laingsburg to its first -- and only -- softball State Championship.

For the first time in 45 seasons, the Lady Wolves took a big step in that same direction of winning it all, with a gritty Division 3 Regional crown, winning over Leslie and New Lothrop, respectively.

Addysin Buchin, as she has done all season, pitched the Wolves to both victories. Opposite an outstanding Leslie team (33-6), Buchin allowed just three hits, striking out six and walking one. She also led LHS in hits, going 2-for-3 against Blackhawk ace Ada Bradford. Savvy Stirm drove home two clutch RBI for the Pack, and Haley Konieczny added the other RBI in the 3-1 victory. Ashley Bila added a walk and Ella Merrell was hit by a pitch, critical plays in a Wolfpack offense that had just enough (4 hits) to get past the Hawks. All three runs came in a critical bottom of the 6th rally after Leslie opened a 1-0 lead in the 4th.

The 9-5 triumph over the host Hornets (27-15) -- for the Regional hardware -- featured a 6-run rally in the top of the 4th frame, and three more runs in the 6th to put the game away. Ashley Bila was safe on a bunt down the third base line; Bella Latuszek lined a run-scoring double and Buchin reached on a fielder's choice. Stirm stroked a run-scoring single to right field and Konieczny drove in a run on another fielder's choice. Two more Laingsburg runs scored on a dropped ball in the outfield.

Down 9-1, NL fought back with 4 runs on Brynne Birchmeier's grand slam homer in the 6th before Buchin put out the fire. The sophomore righthander yielded 11 hits and four walks, striking out a pair.

Latuszek, Harper Strouse and Buchin each drove in two RBI, with Bila adding Laingsburg's other hit. Sparkplug Bila walked twice.

Elsie Village Council Proceedings

ELSIE – The regular meeting of the Elsie Village Council was held Tuesday, June 13, 2023 at the Duplain Township Hall. The evenings highlights included possibilities for the expanding lagoon site facilities and the former Elsie Junior High building.

Randy Redmer, president of Michigan Waste and Environmental Services, Inc., presented an information regarding the municipal sewer system, and waste water systems. The current waste water system is oversized for the system and could be transformed from a cost burden to sewer system receiving station which could be revenue generating. This would involve changing the permitting. Noting that there is a need in the area for this service. Redmer stated, "That there is a need and the capacity is here. This could be a steady revenue stream for the Village." The firm also has a working relationship with EGLE and the regulatory agencies involved with the proposed venture. There would be costs involved in the transition but this would be a joint venture with cost sharing. The evening was an informational meeting, presenting an option for the Village officials. This venture could generate hundreds of thousands of dollars annually. Michigan Rural Water is very supportive of such a move. Again, this was an informational presentation.

Concerns included the odors coming from the plant and the trucking going through the park. And is the current equipment up to par to sustain such a project. Village officials want an outline of the pros and cons of the project. Redmer offered to setup a field trip to one of their other facilities.

Action was taken to move forward with a fact-finding study of the proposed project. Officials took formal action to approve the appointment of Paula Breining to the Elsie Public Library Board. Breining is filling a recent vacancy.

In other actions officials took annual action to approve the L-4029 Millage request of 13.6603 mills, which reflects a renewal. Once approved summer taxes will be prepared and sent to village property owners.

Shane Grinnell, village manager, presented the treasurer's report and indicated that he will have a possible candidate to fill the vacant treasurer position at the next regular meeting.

Chief Bryce presented the monthly Elsie Police report. The Elsie Police Department continued on page 7

As a young girl, I remember playing many sports with my brothers. I remember Billie Jean King, Chris Evert and Nancy Lopez. But, I never enjoyed the sports they played. So growing up with four brothers, my only options were the sports we played in the yard. That was until Title IX was passed.

Title IX gave me an opportunity to compete in sports at school. During that time, it taught me the discipline it takes to play as a team and refined the raw athletic ability I had.

As an adult, I officiated and coached two sports, I got to witness first-hand the improvement of the skill level of female athletes. I coached at the Middle School level to help instill making a commitment to ones school, but more importantly ones teammates. I also got to witness high school female athletes play in a crowded gymnasiums. That was something I never experienced as a player.

As a parent, I got to see the growth of the second generation of female athletes. Not only did the skill level improve, but so did the playing conditions, equipment and opportunities as well. I don't remember my daughter, Casey ever playing or practicing in any facility less than a high school gymnasium. Athletes were receiving scholarships to colleges. Summer camps and leagues became the norm for athletes. I spent the summer traveling watching very high level softball. Watching college scouts watching my daughter's team was the best. Now my daughter is working with the third generation of Title IX athletes at Northwood Institute in their softball program.

I never dreamed a NCAA tournament game would draw a viewership of over a million people. When I was in high school, I never dreamed there would be professional women's leagues. As an MHSAA official, I worked quarter, semi and finals in volleyball. Later, I became the television timeout coordinator for the finals in volleyball at Western Michigan University. MHSAA sport events was a venue no matter your gender, everyone was paid the same at that event. That wasn't the case within the walls of all schools and in the workplace.

Sometimes I think of how different my life would have been without sports. I just wrote about a few things in my life that would have never happened if it weren't for Title IX.

Sporting Clays & Rifle Poker Shoot

Every once in a while the Weeksly Sportsman is fortunate to be invited to a sporting clay shoot somewhere in Michigan. Most of these fundraising events follow a similar routine; checkin, safety briefing, warmup, shoot, lunch/dinner and awards, however, the last one had some

extra shooting activities. A few weeks ago these extra shooting activities, such as a rifle poker shoot, made a pleasant seven hour round trip to Charlevoix Rod & Gun Club even that much

The event was a political fundraiser for newly elected and serving Representative Neil Friske from the 107 District which includes the area on both sides of the Mackinac Bridge. The course



was a very challenging 12 station oval shaped layout with all sorts of shots. The clays seemed a bit fast at some stations and often almost impossible to hit. The Weekly Sportsman was very relieved to see some shots called "rabbits" because they are ground based targets that bounce up and down. Often the hardest to hit, the Weekly Sportsman often considers these a gimme and the shooting often brings comments from team members about who the real rabbit hunter is among the group. Each station is manned by a friendly club worker and the walk between each station is just right. Golf cart transportation is also available.

Following the sporting clay shoot the Weekly Sportsman felt energized because of what was up next despite having the shoulder pounded 50 times

with 12 gauge shells. Quick to put the shotgun and shooting gear away, out came in one hand a Remington 700 ADL in .223 equipped with a Score-High bench rest follower and fitted with a Weaver 10x scope. The other hand held a MTM green plastic ammo box with Winchester 45 grain JHP's that clock in at around 3600 feet per second. Usually when this rifle is uncased it means there is a woodchuck putting life in jeopardy by making a public appearance and playing the odds but this time a different kind of odds were going to be played.

A rifle poker shoot is an interesting game that definitely requires skill but also some luck and it doesn't matter if you are like the Weekly Sportsman and don't even really know what a good poker hand looks like. For \$20 you purchase a paper target that is approximately 12x24 inches and hung vertically like a portrait consisting of 52 very small dots. On the back side is a deck of cards printed so the center of each card has a corresponding dot on the front side. The first part is easy... place five shots on top of five dots or as close as you can get them. Spread your dot

selection out just in case you're off as you don't want two shots on the same card. All skill?

Before each shot, the Weekly Sportsman could subconsciously hear his father's voice calmly saying "headshot... headshot... headshot... now one more headshot." A rangemaster retrieved the target and showed me the cards I had "drawn" which didn't really mean anything except I had five cards and it was some kind of flush. All luck? Apparently so because that flush won the Weekly Sportsman a new .22 rifle.

If you are ever in Charlevoix during the summer on a Wednesday, Saturday, or Sunday consider stopping by the Charlevoix Rod & Gun Club, 11330 US-31 just a few miles north of town. The sporting clays course along with other shotgun sports such as trump, skeet, wobble, along with five stand are open to the public. Unfortunately, you probably won't be able to win a new rifle but you will have a great time.

conducted 18 traffic stops resulting in 8 citations. Complaints have decreased compared to the previous month with only 76 calls for service. EPD participated in two county wide multi-jurisdictional trainings during the month. The training included a legal update pertaining to recent changes in criminal law and police procedures and converting to an electronic warrant request submission system through the Clinton County prosecutor's office.

Action was taken to approve the month ELPD police report.

Shane Grinnell, village manager, reported that the Dodge Charger was placed on the Ranger Bid site with no response. It was relisted on the Municipal Bid site.

In addition, a quote for sidewalks has been received from Morton Outdoor Contracting. Officials reminded that property owners pay 50% of the cost. Residential areas include: 130 N. Ovid, 322 N Ovid, 201 E Pine, 143 E Pine, and 210 N 2nd streets. Also, a number of options for the former bank property. Officials approved the recommendations and the property owners will be contacted. The downtown area will be a priority with the goal to have repairs made prior to the Elsie Dairy Festival.

Also, a, used LED sign has been secured at a cost of \$400. Programming is in progress.

Grinnell wrapped up his report with an update on the possible Elsie Junior High School project. The developer, Ken Harris did a walked through of the building, the walls appear sound. His initial comments were full of possibilities. The challenge is securing the building, under the new regulations the cost on the foreclosure is back taxes plus and the State has a minimum bid of \$50,000 for the first auction August 11, 2023. If it is not sold then at second auction there is no minimum bid, the auction is slated for October 2023. This is a major challenge. Discussion followed. It was decided to reach out to State officials, MEDC and other entities in securing the building at a more reasonable price. Val Vail-Shirey, county commissioner, also offered assistance and information regarding the building.

Officials addressed requested from the Department of Public Works. Action was taken to approve the purchase a new snow plow not to exceed \$7,000.

In other DPW actions officials approved the Spicer Group proposal which will be split between two fiscal years. The cost of \$32,500, which reflects the worst-case scenario. The work includes a water reliability study and general plan. Officials approved the storm drain and manhole cover project \$27,900, all completed at one time to be efficient and cost effective not to exceed \$29,000.

Brook Wooley, Elsie Dairy Festival Committee, updated officials on the status of the festival and provided each with the brochure. Village officials will have the stage in place Wednesday

Monthly action was taken to approve the meeting agenda with the addition of Randy Remer sewer proposal, Paula Breining appointment to the library board and Val Vail-Shirey County Commissioner, and Elsie Dairy Festival update, approval of the May 10, 2022 regular meeting minutes and the treasurer's report. Rabies, Animal Bites and Wild **Animal Encounters**

St. Johns, Stanton, Ithaca, MI – The Mid-Michigan District Health Department (MMDHD) is reminding residents the dangers of animal bites, whether wild, stray, or domestic, as animals may be infected with rabies. Rabies is a deadly but preventable viral disease, and most cases are in wildlife, including bats, raccoons, skunks, and foxes. Rabies can spread to people and pets through an infected, or rabid, animal's bites or scratches.

It is important for residents NOT to interact with (pet, play with, etc.) wild or stray animals. Tom Clark, Director of Gratiot County Animal Control says, "If you encounter a stray dog, don't run away, make any sudden movements, or look them in the eye. Quick movements can trigger their 'prey drive.'

Residents may also encounter wild baby animals, such as a deer, fox, or racoons. It is important to leave the animals alone.

The law requires all animal bites be reported to local Animal Control and your local Health Department. When a bite occurs, make sure to capture the following information:

- •Address of where the bite occurred
- •Name and phone number of the owner of the biting animal
- •Rabies vaccination status of the biting animal
- •A good description of the biting animal

If a domestic animal bites a person, it doesn't necessarily mean the animal will be put down, nor will the owner face punishment. Local Health Departments and Animal Control Officers need specific information surrounding the incident to best provide education and to assist in determining possible rabies exposure. Domestic biting animals need to be quarantined for 10 days but may not need to be removed from their owner unless surrendered or dangerous.

In Michigan, rabies most commonly occurs in bats, therefore, it is important to prevent bats from entering living quarters or occupied spaces in homes, churches, schools, or other similar settings. In situations where a bat has been in close contact with people, if possible, safely confine the bat and contact your local Health Department to determine if it should be tested for rabies. A tutorial on how to catch a bat can be found on YouTube, titled: "How to Safely Catch a Bat" published by NYSDOH NY. If testing is required, the brain of the animal must be intact. The local Health Department or Animal Control can provide you with best practices to safely deal with the bat.

If residents are unable to contact their local Health Department or Animal Control, and the captured bat is no longer living, the animal should never be put in the freezer. Freezing will delay test results from the state lab. Specimens must be refrigerated until ready to ship.
