

Recycling Lets the Light Shine In

Laingsburg's Community Cleanup on May 21 allowed many residents to take advantage of the opportunity to get rid of lots of trash (not all of it "trash"!), and volunteers from the GLR stepped up to sort the loads of scrap metal, cardboard and electronics—including over 60 TVs!—that were thereby diverted from the landfill. But you don't have to be from Laingsburg to bring your recyclable materials to the Greater Laingsburg Recyclers' drive-thru recycling facility on Woodbury Rd.: everyone is welcome. The facility is open four times a month, the 1st and 3rd Tuesdays (June 6 and 20), 4-6 p.m., and the 2nd and 4th Saturdays (June 10 and 24), 9 a.m. to 1 p.m., but will be closed Sat., July 4 for the holiday.

The GLR is always looking for ways to expand what can be collected for recycling—having recently added denim to the list—and reusing (check out our freebie shelves and tiny free library). The latest addition is Brita brand water filters, packaging, pitchers and bottles—the logical alternative to buying bottled water, which is costly for both your pocketbook and the environment (e.g., the 29 billion water bottles purchased in the U.S. every year require about 17 million barrels of crude oil to produce). See below to get the extensive list of what is accepted

The GLR co-sponsored a recent Community Solar Forum, with local pastors Tiffany Newsom (Laingsburg United Methodist Church) and Dr. Tom Rundel (Laingsburg First Congregational Church) acting as hosts. GLR chair Terry Link facilitated the forum that featured representatives from the Great Lakes Renewable Energy Association and Michigan Interfaith Power and Light, who explained various possible approaches communities can take to add solar energy to churches, schools and government buildings, as well as private residences. Others who may be interested in organizing their own community forum can contact Terry Link at link@msu.edu for more information .

Laingsburg Middle School 6th grade science classes toured the Greater Laingsburg Community Recycling Center in May to learn more about reducing, reusing and recycling in their

community. The GLR is hoping to expand upon its partnership with Laingsburg Schools in the future and is also open to assisting school systems elsewhere in the area to reduce their waste and encourage their students to think about this environmental and civic responsibility.



Pauline was a devoted farmer's wife who loved spending time with her family. She enjoyed putting puzzles together and baking.



If you are looking to purchase firewood, now may be the best time to negotiate the lowest price because demand is low and folks in the firewood business usually have some inventory on hand. Remember that you usually get what you pay for and in a perfect world you would almost always purchase hot burning hardwoods such as; white and red oak, yellow birch, white ash, hickory, apple, and sugar maple. Next in line consider medium burning woods like; elm cherry, red and silver maples, and white birch. You should always stay away from the following low heat burning softwoods; pines, cedars, aspen, poplar, and cottonwoods. Not only is their heat value low but they can also cause dangerous creosote to build up in stoves and chimneys

More often than not you may find some mixed stacks of hardwood at a reduced price.

Green wood does not burn unless it is cedar but expect a lot of smoke and low heat value. Unseasoned wood or green wood usually contains around 50% moisture when harvested and won't burn well until moisture level is lowered to around 20%. This takes time and proper storage which equates to splitting and then at least six months of being stacked and exposed to direct sunlight and wind. Resist the temptation to cover with a tarp to keep rain away as this actually prevents moisture from escaping the wood and causes it to start rotting. How will you know when wood is properly seasoned???? Look for the color of wood to turn gray and become almost odorless. The ends should show some signs of radial cracking and the bark becoming loose along with feeling a little lighter. The Weekly Sportsman likes to bang pieces together to hear a distinctive vibrating echo. This takes some experience but once you hear that sound there is no question much like knowing what real silver coins sound like when dropped on each other. And of course the ultimate test is to see if it burns!

Now, the Weekly Sportsman will tell you that the best firewood for cutting, splitting, and burning is ash followed by maple and then cherry. Oak may burn hot but like elm it can be very heavy when wet and extremely hard to split along with not look as aesthetically pleasing when stacked next to your fireplace or burner.

Time to invest some sweat equity now to stay warm next winter!

The following preamble and resolution were offered by L. Ordiway and supported by M. Perrien:

WHEREAS, the City Council has determined that it will be necessary to issue bonds of the City pursuant to the Revenue Bond Act, Act 94, Public Acts of Michigan, 1933, as amended, for the purpose of paying all or a portion of the cost of the public water system improvement project described in the Notice attached to this resolution as Exhibit A, as well as all other necessary and related improvements (the "Project"); and

WHEREAS, Section 33 of the Revenue Bond Act, Act 94, Public Acts of Michigan, 1933, as amended (the "Act"), requires the publication of a notice of intent to issue the bonds necessary to produce the monies required to finance all or a portion of the cost of the Project; and

WHEREAS, the cost for the Project is estimated to not exceed Nine Million Eight Hundred Twenty Thousand Dollars (\$9,820,000); and

WHEREAS, not to exceed Four Million Nine Hundred Fifty Thousand Dollars (\$4,950,000) of the aggregate Project costs, including the costs of issuance for the bonds, is proposed to be financed by the issuance of bonds of the City (the "Bonds") in one or more series to pay the Project costs; and

WHEREAS, the City Council now desires to authorize and approve the Notice of Intent to Issue Bonds required by the Act in substantially the form of the notice attached to this resolution as Exhibit A: and

WHEREAS, in order to proceed with the issuance of the Bonds, it may be necessary for the City to obtain prior approval from the Michigan Department of Treasury to issue the Bonds; and

WHEREAS, the City may wish to reimburse certain expenditures to be made from the general fund or other fund(s) of the City for the Project in advance of the issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The City Clerk, the City Treasurer, or a designee or deputy thereof, shall cause a notice, in substantially the form as attached hereto as Exhibit A, to be published in the Meridian Weekly, a newspaper of general circulation within the City of Ovid. as a display ad of at least 1/4 page in size.

2. Pursuant to Revenue Bond Act, Act 94, Public Acts of Michigan, 1933, as amended, the Home Rule City Act, Act 279, Public Acts of Michigan, 1909, as amended, and the Revised Municipal Finance Act, Act 34, Public Acts of Michigan, 2001, as amended ("Act 34"), the foregoing notice and method of publication thereof are hereby determined to be adequate to notify the City's residents and electors of their referendum rights and of the nature of the debt obligations proposed to be issued.

3. Pursuant to the provisions of Act 34, the City Council hereby resolves to submit to the Michigan Department of Treasury, if necessary, an Application for State Treasurer's Approval to Issue Long Term Securities, and the Mayor, or a designee thereof, is hereby authorized to complete, sign and file with the Michigan Department of Treasury the same and to pay any fees associated therewith

4. To the extent advances to pay Project costs are required to be made from the City's General Fund or other fund(s), the City shall reimburse the General Fund or such other fund(s) not earlier than the date on which the expenses are paid and not later than the latter of:

(a) the date that is eighteen (18) months after the expenses are paid, or

(b) the date the Project is placed in service or abandoned, but in no event more than three (3) years after the expenses are paid.5. All resolutions and pails of resolutions insofar as they conflict with the provi-
