## Czechoslovak Harvest Festival August 6th

The public is invited to the annual Harvest Festival on Main Street in Bannister, on Sunday. August 6, 2023. This event seeks to celebrate and preserve old world heritage and traditions of harvest time in Czechoslovakia. A dinner consisting of breaded chicken, ham, dressing, dumplings and cabbage, potatoes and gravy, kolache and all the other trimmings will be served from 11:30 AM until 2:00 P M. Adult dinners will be \$15, children under twelve \$5, and preschoolers are free.

Chairman, Tom Bradley, reports that opening ceremonies begin at 2:30 PM as costumed participants march onto an outdoor platform carrying decorated rakes, wreaths and scythes. Traditional dances and songs will be performed by members of the Bannister ZCBJ Czechoslovakian Folk Dancers under the direction of Diane Bradley.

There will be free drawings for children's bikes, as well as drawings for teen and adult prizes. The YELL! group will host free games for children following the program. A dance will begin at 4:00 PM with music by Virgil Baker and Just 4 Fun Band with Frank Moravcik from Cleveland. The beer tent will open at noon and food will be available throughout the day.

Also scheduled for Sunday, Aug. 6th, at 10:30 am is a Heritage Mass at St. Cyril's Catholic Church in Bannister. The Mass remembers and honors the Czech and Slovak founding fathers of St. Cyril's as well as all the ethnic groups that make up the parish. Everyone is encouraged to wear costumes representative of their own nationality.

#### Ovid-Elsie Area Schools

ELSIE – Dr. Wayne Petroelje attended his first Ovid-Elsie Area Schools Board of Education meeting in an official capacity as superintendent. The meeting was highlighted by the adoption of student handbooks and a PowerPoint presentation by Mary Thompson regarding committee suggestions.

Mr. Jason Tokar, high school principal, reported on the effectiveness and successes of the AP courses offered to Ovid-Elsie high school students. The testing results reflected 39 of 54 tests or 77% of students received a passing score, which is better than the 21-22 school year. In addition, 23 out of 23 students passed the English Literature tests. Petroelje noted that this a wonderful reflection of the students and the staff.

Chris Winters, athletic director, reported on the state of athletics at Ovid-Elsie. A huge thank-you for the continued board support. It was a very successful year for Ovid-Elsie athletics. There were district champions, region champions, and a State Championships. The coaches participated in a summit setting four pillars for athletes in the 2023-24 school year: 1) success in the classroom; 2) the integrity of the athletes on the field; 3) community service; and cleanup events in the Ovid and Elsie communities and 4) winning spirit and camps are important. The coaching staff vacancies are being filled. Finally, boys' soccer is being reinstated with Chris Parker as the coach.

Winters presented the recommended Ovid-Elsie Athletic Handbook revisions: the 2nd offense will no longer be a yearlong suspension but a 75% suspension or 50% with 20 hours community service and 8 hours counseling; 3rd offense – 1 year suspension; 4th a complete suspension from all sports during their high school career. Next, the foreign exchange student policy - prefer sub-varsity level with special considerations to be evaluated on a caseby-case basis; age will be a consideration; prior playing experience; preference level; transportation issues; and proactively evaluate the criteria for a varsity letter.

Dr. Petroelje updated officials on the status of Marauder Kid Learning Zone business Noting this is an excellent program for the children of this community. The biggest expense is the salaries involved and when added it is very difficult to run the program in the black if the district took over this program. There is an individual in the community who would be interested in entering into an agreement to run the program, leasing the facilities from the school district, two rooms. "This is a fortunate situation." More information will be available at a later date.

Petroelje further reported that he met with leadership, and administrators of all the various programs in the district and will wrap-up these meetings at the end of the week. In addition, he would like to meet with the individual school board members as well. A survey has been sent to each board member as a starting point for Petroelje those discussions

Finally, will be looking for an administrator for EE Knight Elementary School, unfortunately the previous principle has secured another position elsewhere.

OE maintenance staff will be represented by a different union due to severing ties with the current association

The tax levy (L-4029), is annual action and is set at 17.8795, om non-homestead property. The levy has been in effect since February 26, 2013, and lasts for ten years and then will go to the voters for a renewal. If it is not renewed there will be a loss of 1 million dollars in operating funds. The renewal will be placed before voters in 2024.

The district student handbooks were presented for approval and each handbook was addressed separately. All were approved as presented noting that the k-12 are aligned and follow similar guidelines. The elementary, middle school, high school and alternative high school and athletic handbooks were approved.

Officials offered an employee contract to Jenna Collins, MLA instructor at Ovid-Elsie Middle School.

Officials then took action to accept, with regrets, the following resignations Mallory Huhn 8th grade math teacher, and Alisha Ormesbee as elementary principle.

The recommendation to establish committees was presented by Mary Thompson in a power point format. The intent is to relieve the workload of administrators and staff, and to be more active in the planning process. Committees proposed: policy, goal setting; building and ground, finance, transportation, and curriculum. There was a lengthy presentation with explanation. No action taken

Monthly action was taken to approve the following: the meeting agenda, the minutes of the June 26, 2023 regular meeting, the payment of expenditures and financial reports, and the school bond qualification and loan program.

#### Free Family Night at IQhub: Robots in Action

Join us on Tuesday, July 25th for the IQhub's second, free family night of the summer! From 6:00 pm to 8:00 pm, the IQhub will be open with special evening hours that feature demonstrations and displays by the Michigan State Police Bomb Squad and Consumer Energy. Robot Exploration is the IQhub's summer exhibit that runs until Friday, September 1st. Visitors are welcome to see all of the robot display currently set up at the IQhub. Regular museum hours are Tuesday through Friday, 10 am to 4:30 pm and as always, admission is free. The first 40 kids will get a "robot" to take home!



See the Michigan State Police bomb squad vehicle up close and in action! Currently, the bomb squad consists of 15 members assigned to seven regional teams. These teams respond statewide to suspected explosive devices and Weapon of Mass Destruction (WMD) incidents. Squad members are "Certified Bomb Technicians" and "HAZMAT" Technician Level trained. The squad is an integral part of the Michigan Regional Response Team Network (RRTN), which was established to provide quick response capability in every region of the state to WMD/Terrorism incidents. Each team is equipped with specialized bomb squad and hazmat equipment including bomb suits, x-ray equipment, a robot, and an explosive containment transport vessel. The bomb squad responds to approximately 500 calls for service each year. People will see the specialized bomb squad robot, the hazmat bomb suit and talk to one of the bomb squad members.

With 87,097 miles of electrical distribution lines to patrol, Consumers Energy uses the latest drone technology to "keep their eyes on the lines". Consumers Energy pilots are trained and certified to fly various drones, called "UAVs" or "unmanned aerial vehicles". These UAV's are mainly used as a flying camera and pilots patrol miles and miles of distribution lines. Drones are also used for aerial inspections at Consumer's Ludington Pumped Storage facility and reservoir (it's really like a small man-made elevated lake), power plant equipment, bridge inspections, wind turbine inspections, storm damage assessment and other hard to access places. The UAVs help Consumers Energy do the work quicker with less cost, yet provide increased data and improved accessibility. Outputs include 4k pictures, LIDAR scans, corona images (heat signatures), thermometer readings and more. Visitors will learn from a Consumers Energy pilot about the certification program and safety in flights as well as enjoy multiple drone demonstrations! ### **Elsie Village Proceedings**

ELSIE – The regular meeting of the Elsie Village Council was held Tuesday, July 18, 2023. Monthly action was taken to approve the meeting agenda with addition of DPW on call payments; approval of the June 13, 2023 regular meeting minutes; financial reports and the monthly expenditures.

Tom Frink, village president, reported that currently DPW employees receive \$25 for being on call which is not acceptable. It was recommended by Sam Frink to pay on call employees \$100 a week sitting fee. The recommendation was approved by officials.

Police Destinee Bryce reported that the Elsie Police Department conducted five traffic stopes resulting in six citations. In addition, the department responded the theft of a bicycle stolen from the resident's yard. Noting that the bicycle was recovered. Elsie officers were dispatched to a careless/road rage incident that occurred at the intersection of Main and Ovid streets. The vehicle was located westbound on M21 at a high rate of speed. The Elsie Police Department was able to conduct a traffic stop on the vehicle where the driver was cited. It was noted that the Dairy Festival went great with few complaints and the Clinton County Sheriff's Posse was amazing.

Finally, police activity for the month of June consisted of traffic crashes, careless driving complaints, family disputes and several 911 hang ups.

Chris Ormes, Department of Public Works, reported that the Village is down one pump at the lift station probably due to flushable wipes jamming it up, it was recommended that residents reframe from using them. Spicer Groups has begun the studies of the system as contracted. Storm drains and catch basins have been ordered and on Maple Street, sink holes are popping up. The department dealt with a few complaints regarding the cemetery, which have been addressed. The staff is trying to keep up with mowing and maintenance with 2.5 employees.

Ormes discussed the condition of the Village of Elsie signs that are in rough shape. He asked for council direction. Ormes was directed to review the options and present at the next meeting.

Val Vaiol-Shirely, County Commissioner, reported that an evaluation of the Clinton County Prosecutors office had been completed resulting in the proposed increase in wages to bring them up to the average standards for the positions.

Dairy Festival representative Brook Wooley presented a final report on the 2023 Dairy Festival, it was a successful event with a few rough spots. The carnival was very interactive and participated in festival events. The Village was thanked for their continued support.

Next, a request was made by the Elsie United Methodist Church for a street closure of Church Street from W. Main to W Oak streets, Tuesday, August 1, 2023 5 pm-9pm for National Night Out and a community block party. There will be music, food, activities and participation of the Elsie Police Department, Elsie Area Fire Department and Clinton Area Ambulance. Officials are encouraged to attend the event.

The training is an opportunity to learn more about the program, and volunteer opportunities

that are available. There are multiple volunteer opportunities; volunteering for a person with health/medical challenges in the volunteer's own community, providing respite for the family caregiver, helping at the office in Owosso, helping with events, helping with special projects.

If these dates, time, or location are not convenient for someone interested in participating, a mutually convenient time and location can be set up. I'd ever hear, especially by a policeman. It was a shock. Crazy. All of it was.

I had just extinguished the fire in this horrible vehicle wreck. It was dark, chaotic, and scary, but soon enough the road was filled with fire engines, ambulances, and multiple police cars. It was clear that there were fatalities. Something else was also clear.

As I stood there, helpless, watching the Jaws of Life twisting metal, I thought the only thing that makes sense right now, that matters, is the gospel message. They were gone. I am going. You are going. Like King David, we are all going away. Reservations matter.

The Bible makes it clear – crystal, 100 percent clear – that we can know for sure how to get to Heaven. It is not a guessing game. It is a sure hope. Consider the Apostle John who saw Jesus die and come back to life, as much an eyewitness as I was that night:

"He who has the Son has the life; he who does not have the Son of God does not have the life. These things I have written to you who believe in the name of the Son of God, in order that you may know that you have eternal life (1 John 5:12-13).'

John says that we can know for sure, and that there are two types of people – those who have the Son and those who do not. This is not an intellectual nod to some fact; it involves your will. A white flag surrender, kneeling in your heart, submitting to the King of Kings in faith in His death. The result? A Spirit invasion, like a demon possession, but with a righteous spirit, the Holy Spirit. He will literally enter your body, as Paul says:

"In Him, you also, after listening to the message of truth, the gospel of your salvation - having also believed, you were sealed in Him with the Holy Spirit of promise, who is given as a pledge of our inheritance, with a view to the redemption of God's own possession, to the praise of His glory (Ephesians 1:13-14).

His Spirit is a pledge, a down payment, that God will keep His promise to redeem you from death. It's as if God has deposited \$599,000 dollars on a \$600,000 home. He has pledged to buy it. He's not walking away, in too deep with blood money. His blood.

Jesus said, "Truly, truly I say to you, he who hears My word, and believes Him who sent Me, has eternal life, and does not come into judgment, but has passed out of death into life (John 5:24)." Death is dead? My death? Yours? Yes, absolutely (Romans 6:23)!

Sounds nuts? Like asking to land a helicopter in your yard, but this question is not: "Is the Holy Spirit inside of your body right now?" If not, don't kid yourself. The Bible says you do not have eternal life. You're definitely going, so why not ask Him to come inside and rescue you. It's a simple 911 call (Romans 10:13). Reservations matter.

## Rep. Filler: Alcohol Sales at College Stadiums Will Allow Modern, Safer Game-Day Experience

State Rep. Graham Filler, R-Clinton County, celebrated as the governor signed into law a measure that will permit universities in Michigan to sell alcohol at certain on-campus sporting

Filler has been leading the Legislature's bipartisan effort to make the change for two years - introducing legislation in the House in 2022 and again this year. The legislation signed today. Senate Bill 247, was the Senate's version of Filler's plan. The new law allows the governing boards of Michigan's public universities to apply for liquor licenses to sell alcohol at athletic events.

"Imagine sitting in the stands at Spartan Stadium on game day with a cold beer in your hands surrounded by all the contagious energy of the crowd – that's the kind of experience that unites fans from all walks of life," Filler said. "But the ability



for college sports stadiums to sell alcohol is not just about creating a more enjoyable experience for fans, it's also about fostering a responsible and safe environment. By promoting responsible consumption, implementing age verification measures, and offering diverse beverage options, we can create an unforgettable experience where fans revel in the game while enjoying their favorite drinks in moderation."

Of the 14 schools in the Big Ten, 11 allow alcohol sales at football games as of 2023, and most have seen positive results with decreases in the number of alcohol-related incidents. After Ohio State started selling alcohol stadium-wide in 2016, university police reported a 65% drop in alcohol-related incidents inside its sports venues.

Michigan's new law allows the Michigan Liquor Control Commission to issue up to five tavern licenses or three Class C liquor licenses to a university to be used for scheduled events at a facility customarily used for intercollegiate athletic events.

If you drive up and down Meridian Rd. between Laingsburg and Ovid, through to Elsie, Bannister and Ashley, it doesn't take you long to realize you're on a dividing line.

Small, state-placed signs let you know you're entering "Shiawassee County" or "Clinton County or "Gratiot






Actually, you're in a place fairly notable -- the Michigan Meridian. This newspaper is named




mouth of the Auglaize River on the Maumee River, which was the site of Fort Defiance (now Defiance, Ohio).





OWOSSO— Laingsburg's Ashley Bila hit at a .525 clip, leading the Wolfpack and Ovid-Elsie honorees on the 2023 All-Shiawassee Area Girls Softball Team.

The squad is announced annually as chosen by the Owosso Argus-Press.

The area's highest on-base percentage and homre run total belonged to Hailey Rolfe of Chesaning, who was named the area's Player of the Year, nosing out Bila for the award.

Bila is speedy left-handed lead-off hitter and Division 3 honorable mention all-state shortstop. She delivered 62 hits, batted .525 and had an on-base percentage of .659 this year, setting the table for the Wolfpack en route to a state semifinals run. She drew 43 walks and struck out just five times all season. Bila stole 43 bases and fielded .943 at short. She had 74 put outs and 70 assists while making nine errors. Bila has already set Laingsburg career school records in runs scored (244) and hits and still has one more year of high school softball ahead of her.

There were several other local players feted:

Wolfpack ironhorse pitcher Addyson Buchin, a righthander, was an honorable mention MHSSCA all-stater in Division 3, and led the Wolfpack all the way to the state semifinals. She crafted a 35-6 won-loss record while posting a 1.50 earned run average over 219 innings. Her 35 wins is a school record, as are her 258 strikeouts. Buchin walked just 41 batter. The 10th-grader also batted .391, with 50 hits, 14 doubles, 49 RBI and an onbase percentage of .471 as an All-Area 1st Teamer.

Bella Latuszek, a key run producer for Laingsburg and a second baseman clubbed 49 hits and drove in 53 runs while batting .380. Latuszek drew 17 walks and her on-base percentage was .440. Latuszek posted a fielding average of .929 this sea-

Freshman Harper Strouse, the Wolfpack catcher ranks as one of the best defensive catchers in Jeff Cheadle's tenure at Laingsburg, the coach said. That steadiness was one of the keys in the Wolfpack's success as she prevented passed balls and steals, he said. Strouse committed just five errors all season with 239 putouts and 15 assists. She caught six runners stealing. Strouse also jolted 36 hits and drove in 36 runs while batting .327 with an on-base pecentage of .417.

Mark Chatterley's life-sized ceramic figures seem to have emerged from the earth's crust, the creations of a fire god millions of years ago. After building a kiln to accommodate his life-size, free-standing figures in one piece, as well as entire groupings, Chatterly set himself free to explore "the archetypal images that go beyond culture and time that Jung wrote about."

Chatterly has emerged as one of the strongest ceramic sculptors of our time. His constant exploration of the human expression and relationships expressed

through his highly personal groupings of humans and animals has contributed to the force taking ceramics from the level of craft to that of high art. Chatterly has shown in gallery and museum exhibitions throughout the USA and in Asia. He has completed a number of public art commissions and he has cast several of his large works in bronze.
