





rifle rimfire ammo for self defense. The irony of course lies in the fact that the Weekly Sportsman is a rimfire connoisseur and prefers .22's for concealed carry purposes.

Similar to Federal's recently introduced Punch load, CCI's new Uppercut is specifically designed for compact self defense and trail handguns with 2.5 to 4 inch barrels. Initial ballistics indicate a 32 grain bullet with a jacketed hollow point that features nose skiving to produce maximum expansion and deep penetration despite only traveling at 950 feet per second. The unwaxed bullet seated in a nickel plated case will help prevent fouling and improve feeding in all conditions.

The Weekly Sportsman has been unable to find this new ammunition at local retailers and most websites are taking orders. It appears the cost will be around \$12-\$15 for a box of fifty rounds housed in the normal CCI clear hard plastic cases. As soon as it becomes available the Weekly Sportsman will report on accuracy along with expansion performance when shot into jugs of water.



For God to come and love the poor, the unknown, the nobodies and use us in the Kingdom is a wonderful, beautiful act of God.


