# Elsie Area Fire Auxiliary Puts Support Vehicle on the Road

ÉLSIE – The Élsie Area Auxiliary, with the support of the Elsie Area Fire Fighter Association has purchased a used ambulance to house the items necessary to provide necessary support for EAFD fire fighters. The Elsie Area Fire Fighter Association holds an annual dance, pop bottle drives and other fund-raising projects to help support the Elsie Area Fire Department financially.

The vehicle was purchased for \$7,000 from Elk Rapids Township Department. Originally Elk Rapids had planned to put the vehicle up for bids with a minimum bid of \$26,000. The vehicle was received the beginning of September. The lettering application was paid for by Stay Dry Basement Waterproofing & Foundation Repair of Elsie. This is a community driven project. The vehicle is now road ready.

The vehicle will contain tents, heating and cooling fans as well as food and beverages. The auxiliary provides support for fire fighters at a fire scene and are prepared to assist with area disasters. They belong to MABAS – Mutual Aid Box Alarm System, giving them authorization to respond when activated and called.

The Elsie Area Auxiliary is always seeking new members – men, and women. Those interested do not need to be associated with the fire department. They are a volunteer group who provides support for the Elsie Area Fire Department and where needed. Applications are available at the Village office and a background check is required.

This is a transition from a trailer that is becoming difficult for members of the auxiliary to work with. The trailer was donated by Elsie Masonic Lodge #238, which was very appreciated and noting that the department will repurpose the trailer.

#### Ovid-Elsie Area Schools

ELSIE – The regular meeting of Ovid-Elsie Area Schools was held Monday, October 16, 2023. The highlight of the evening was the 2022-2023 financial audit.

Officials were presented a review of the 2022-23 audit by Lewis & Knopf. The dis-

Officials were presented a review of the 2022-23 audit by Lewis & Knopf. The district has received a "clean" unmodified audit which is the highest level of assurance possible for the district's financial statements. There were no control issues reported. Actual versus budget was right on.

Under action taken officials accepted and approved the Ovid-Elsie Area Schools 2022-2023 financial audit as presented.

Ms. Delo presented the curriculum and instructional department updates and highlights. Professional learning opportunities are being scheduled for Ovid-Elsie staff. On October 6, 2023 staff had choices and speakers were brought from the RESA and beyond, the overall evaluation 4.2 out of 5. There are amazing things happening in the district with students and staff. The goal is to "Share of Story" with each other and the community. "Positivity" is contagious. OE has expectations – be respectful, be responsible, and be your best. Staff have been challenged to share the positive, the board and the community are also encouraged to share the positive.

Delo, k-5 literacy curriculum is being addressed this year. The current curriculum is no longer supports by the parent company.

"This mortal must put on immortality... (1 Corinthians 15:53)."

With about six months to live, Abraham Lincoln revealed his fixa-

tion with the poem "Mortality" to the American painter, Francis Carpenter. In 1864, he spent six months at the White House painting the Great Emancipator. Lincoln never met William Knox, but he liked his words so much that he memorized this poem at a young age:

O, why should the spirit of mortal be proud? Like a swift-fleeting meteor, a fast-flying cloud, A flash of the lightning, a break of the wave, Man passes from life to his rest in the grave.

The hand of the king that the scepter hath borne; The brow of the priest that the mitre hath worn; The eye of the sage and the heart of the brave, Are hidden and lost in the depth of the grave. The saint who enjoyed the communion of heaven,

The sinner who dared to remain unforgiven, The wise and the foolish, the guilty and just, Have quietly mingled their bones in the dust. For we are the same our fathers have been:

We see the same sights our fathers have seen, We drink the same stream and view the same sun, And run the same course our fathers have run. They loved, but the story we cannot unfold;

They scorned, but the heart of the haughty is cold; They grieved, but no wail from their slumbers will come; They loved, but the tongue of their gladness is dumb. Tis' the wink of an eye, tis' the draught of a breath,

From the blossom of health to the paleness of death, From the gilded saloon to the bier and the shroud, O, why should the spirit of mortal be proud?

The Greatest Emancipator – Jesus – died to make us free and immortal. So, why dare "to remain unforgiven" when mortals can become immortal? Good question. The answer is in Knox's question...pride. We think we're good enough, but compared to a holy God we all fall short (Romans 3:23). We are not good enough. We are broken; thus mortal.

The only solution was God had to die for us, and if we will humble ourselves and receive Him (John 1:12-13), we can be immortal, born twice. Knowing we are mortal, and will die, I ask Lincoln's favorite rhetorical question a third time... "O, why should the spirit of mortal be



#### **Sleepless in Clinton County**

Dear Andy, I cannot sleep at night. I get out of bed at least 6 times a night. I walk, make lists, clean, fold clothes and try drinking warm milk to relax. I am at a loss counting sheep until 3:00 am and then I get up at 7:00 am to start my day. I am groggy until lunchtime and require a lot of caffeine every morning. Any peaceful thoughts? Sleepless in Clinton County

Dear Sleepless,

A good night's sleep is imperative to a productive next day. According to Neuroscientist Tara Swart, MD, adults need seven - nine hours of deep sleep and children need ten to twelve hours every night on a schedule. Some of Dr. Swart's best suggestions include: No television, no nightcaps, no late-night snacks and no binge-watching Netflix's at least an hour prior to bed-

Alcohol before bedtime impairs the quality of sleep necessary to function throughout the next day. A glass or two of wine with or after dinner but no drinking after dinner or into the evening. Also, many people think watching a movie or television is relaxing but after a long workday, using electronics, reading a book, being on the computer and texting should stop at least hour or more before bedtime. (Regardless of your age.)

Teens especially must stop using electronics 2 hours prior to bedtime. Early to bed, Early to rise will calm your mind to get into a comfortable state of mind so your brain can power down and be ready for the next day to function properly. I have read some studies that have reported that up to 70% of middle school and high school students are sleep-deprived. It affects their attention span and consequently their grades, memory, and learning abilities.

No late-night snacks. Food stimulates brain activity. Stop eating at 6:00 pm to lose weight. Caffeine can be a significant stimulant that can last up to 16 hours for some people. You may need to drink more water and cut out the coffee and colas throughout the day. Do it gradually to avoid withdrawal

Some great ideas to get some sleep without a prescription or an expensive otc supplement: Smell lavender before bedtime. I put some oil on my wrists so I can peacefully nod off quickly. Lavender oil and floral are powerful neuromodulators. It relaxes you and lowers your blood pressure. If you are going to drink milk, drink nut milk with a pinch of turmeric which is full of magnesium that helps reduce your stress hormones and calms the nervous system.

A good night's sleep can regulate your circadian rhythms and contribute to a healthier immune system. Use honey to boost your immunity and sweeten your fruit and drinks. All good sleep needs to be in a quiet dark room without stimuli. Having a nightly routine that includes a hot bath or shower before bedtime which could contribute to a better night's sleep. If these suggestions do not work, see your family physician to determine if there is something more serious than over-activity contributing to your sleepless nights.

If you continue to have difficulties, you may have some caffeine in some of your nighttime prescriptions. Be aware of Melatonin in some products. After long-term use, it may have a side-effect of vertigo for some individuals. Check with your doctor, if you continue to have sleepless nights. Recently, I found I needed an antacid to keep from having reflux which was causing restlessness. Good Night. On my way to spray Lavender mist on my pillow. Good Luck, and Sweet Dreams. The Biden Administration has recently ordered that no commercial sales will be allowed of ammo from the Lake City

Army Ammunition Plant (LCAAP). This 3,935-acre facility is located near Independence, MO and is owned by the US Government, but operated by Olin Winchester. Currently the LCAAP produces 5.56x45mm NATO, 6.8mm, 7.62x51mm NATO, .50 BMG, 9x19mm NATO, 10mm, and 20mm. In the past, Biden and Obama have tried to artificially manipulate the ammunition market by large federal contract purchases or bans on the sale of extra product. But no politicians in Washington are screaming about this recent decision. You don't need to be a genius to understand that the conflicts in Ukraine and Israel probably have something to do with this decision. What does this mean to civilians and law enforcement wanting to feed their AR's, pistols, and rifles? Well, over 30% of 5.56 ammunition sold on retail shelves comes from this plant.

In addition, to supplies being reduced from LCAAP there was a fire/explosion last week at Hornady during the mixing process of primer compound. One employee was killed and others severely injured. Although it is unclear what this means it is probably pretty certain to also cause supply issues.

So how will it start? Within a week or two 5.56x45 and 7.62x51 will start drying up followed by 9x19mm handgun ammo. On top of deer hunters stocking up, shelves will start to





Barb and I sat on the deck and watched the three kittens bounce and jump around, we laughed at their antics.

This morning Pam stopped by with three bags of inspirational books and Bibles that will be passed on to missionaries. I didn't do much at the shop, just discussed things and put smiles on faces. We have a cheeky bunch of regulars that guffaw at many things. They are a hoot to have and help us all be more positive. What would be do if they weren't there to tease us? Onwards, I had to pick up our co-op order and take it home. It only involved one fifty pound bag of flour this week. Glad that I had most of it moved into the house before the rain came.

Tomorrow I will get to sleep in and spend the day running errands, maybe have lunch with the ladies. May God bless you with the time to spend with friends and family. Enjoy !!!
