

Team Prancer: Local School Professional Realizes Christmas Dream at The White House

LAINGSBURG -- For many of us, one certain Christmas in our lives has been a marker for a dream come true.

After all, Christmas is all about dreaming -- of good tidings of great joy -- is it not?

For Karen Perry, local school professional and longtime Laingsburg resident, a happenstance incident last summer led to a once-in-a-lifetime opportunity.

Meet Karen Perry, official White House Christmas decorator.

It all started on social media. "Believe it or not, I was scrolling through Facebook in August and saw a post about being a volunteer decorator at The White House," Karen explains. "I thought, that can't be real! So, I did some digging around and low and behold, it was legit.

"The initial application just consisted of very general information about myself and I had to write a short essay on why I wanted to be a part of the volunteer team. Lastly we would be notified in September if we were conditionally selected and I was."

Mrs. Perry still had to pass a background check and would again be notified in October that she made the team. "And here we are today!," she explains. "There were 3,000 applicants, with 300 volunteer decorators picked along with designer teams. Teams were predetermined ahead of time. I was on Team Prancer along with 22 others. Our team consisted of interior decorators, military moms, wives, and those (like herself) in education."

Their official contact was the Deputy Director of the White House Visitors Office that they could correspond with. Each morning the teams reported at 7:30 to the entrance gate on 15th street and Alexander Hamilton Place, providing their ID and confirmation email to enter the grounds. Next was security, scanning ID and bags and going through a metal detector. Then they were free to proceed to the East Wing entrance. "All of our personal belongs, including our

phones, had to be left in the coat room. This was the procedure every day," Karen explains.

Her husband, Doug, traveled to D.C. with her, and toured the city while Karen was busy at The White House.

Decorating took place on the ground floor which consisted of every room and hallway with the exception of the Map Room. Areas included the Diplomatic Reception Room, Library, China Room, Vermeil Room, Coat Room and the Ground Floor Corridor.

Decorating proceeded to the 1st floor, or State Floor. Volunteers were in the State Dining Room, The Cross Hall, Grand Foyer, Red, Blue, and Green rooms, and lastly the East Wing Room. Private rooms of the doctor office and The First Lady's office were also decorated.

The project was massive. There were over 142,000 lights inside and out. 34,000 ornaments, 14,975 feet of ribbon, and 22,000 bells, and 98 REAL Christmas trees. Volunteers began the week of Thanksgiving, Monday, November 20 through Wednesday the 22nd, then resumed November 24 through the 26th, working from 7:30-5:00 each day.

"The first 2 days consisted of making ornaments for the First Lady's tree and The Gold Star Tree. We created small books to celebrate the 200th anniversary of Twas The Night Before Christmas," she says. "The end result looked like they were open and very old. These were placed into the First Lady's Christmas tree in her office. The Gold Star Tree, which honors the fallen service men and women of our military, we hand painted the edges of every star to create an older look. The remaining time we decorated the two Christmas trees in the Diplomatic Room, this room is the entrance from the South Grounds for the family and dignitaries. Our group was also involved with decorating the doctor's office tree and the coat room tree."

HGTV was on site filming for their Christmas special, White House Christmas 2023 (check local listings). Karen's team got to meet Jonathan Scott and Drew Scott. "The volunteers were part of the filming which was interesting to watch the process," Karen says.

What was the favorite part of her day? "It's hard to pick just one," she says. "Just being in The White House and seeing all the history, knowing that I walked the floor of so many influential people was mind boggling.

"The camaraderie of all of those I met in our group and the magical childlike feelings walking through the hallways and rooms at the reveal -- those are memories I will always cherish," Karen explains. "I hope this isn't a one-in-a-life-time experience ... I will apply every year in hopes of returning, but acceptance is not guaranteed."

Karen is a design afficionado, as owner of The Vintage Dish Rentals. She and Doug rent their styled china for special occasions like weddings. "We get to really put our design ideas into that," she says.

What does Christmas look like at the Perry home? Oh, it's festive. "Yes, Christmas is one of my favorite times of the year. I do a lot of decorating inside my house, and try to have a Christmas tree in every room whether big or small," she explains.

Ovid-Elsie Area Schools Board of Education Meeting

ELSIE -- The Ovid-Elsie Board of Education held its final meeting of 2023 Monday, December 18, 2023. Highlight of the evening was Ovid-Elsie High School updates and accomplishments presented by Jason Tokar, OE High School principal.

Mr. Tokar noted that the high school is off to a great start. He updated officials on the graduation rate trends, 2021-22 reflection a 100% graduation rate which is rare but usually the district averages in the high nineties. The growth index regarding the M-Step, MI-Access and SAT overall growth index is typically in the high eighties and low nineties. Test scores were reviewed with OE students ranking third in like schools with an SAT proficiency of 39% and in English ranking sixth with 64.8%. OE high school students participate in a variety of extracurricular activities like National Honor Society, National Art Honor Society, FFA, band, drama, Business Professionals of American, Middle School performing arts, Quiz Bowl, Language Art Teams, robotics, CAD classes, dual enrollment, AP courses, yearbook, and international students. In addition, students are participating in school outreach which includes blood drives, The Learning Spot (NHS tutoring), local food drives, community Christmas support and a variety of athletes in action activities. Finally, the PBIS program is making an impact regarding student behavior -- Be respectful, responsible, do your best, 94% participation. It was noted that 2019-2021 data is unavailable due to statewide assessment exemption due to the pandemic. Attendance is a focus for the remainder of the year and beyond.

Dr. Wayne Petroelje, reported that the non-homestead millage renewal will be on the February 27, 2023 ballot. He stressed that this a renewal request. There will be a Q & A set in January regarding the renewal request. Petroelje has met with Dr. Brooke Wooley regarding the documents in the Live Binder, documents that may need updated, deleted or archived. The documents include past agendas, minutes just to name a few examples. It was decided to narrow the scope to seven documents, updated or putting information all in one space. They will be meeting one more time, then recommendations will be made to the full Board of Education. Second, goal on the timeline is training opportunities, there is training at the RESA in February

The City of Ovid is calling to Establish Ordinance #143 Golf Carts on City Streets on Council Regular Monday, January 8, 2024 at 7:00 PM at the City of Ovid Council Chambers located at 114 E. Front St., Ovid, MI ARTICLE VI. GOLF CARTS ON CITY STREETS

Sec. 32-140. Operation of golf carts on city streets.

A person may operate a golf cart on city streets, subject to the Michigan Motor Vehicle Code, as amended, being MCL 257.657a, in conformance with Public Act 491 of 2014 and by the following restrictions:

- A person shall not operate a golf cart unless he or she is at least sixteen (16) years old and licensed to operate a motor vehicle.
 - The operator of a golf cart shall comply with the signal requirements of MCL 257.648 that apply to the operation of a vehicle.
 - A person operating a golf cart upon a roadway shall ride as near to the right side of the roadway as practicable, exercising due care when passing a standing vehicle or one (1) proceeding in the same direction.
 - A person shall not operate a golf cart on a state trunk line highway (M-21). This subsection does not prohibit a person from crossing a state trunk line highway when operating a golf cart on a city street, using the most direct line of crossing.
 - Where a usable and designated path for golf carts is provided adjacent to a highway or street, a person operating a golf cart shall be required to use that path.
 - A person operating a golf cart shall not pass between lines of traffic, but may pass on the left of traffic moving in his or her direction in the case of a two-way street or on the left or right of traffic in the case of a one-way street, in an unoccupied lane.
 - A golf cart shall not be operated on a sidewalk constructed for the use of pedestrians or on or across a cemetery or burial ground.
 - A golf cart shall be operated at a speed not to exceed fifteen (15) miles per hour and shall not be operated on a highway or street with a speed limit of more than thirty (30) miles per hour except to cross that highway or street.
 - A golf cart shall not be operated on the Fred Meijer CIS Rail Trail.
 - A person operating a golf cart or who is a passenger in a golf cart is not required to wear a crash helmet.
 - This article does not apply to a police officer in the performance of his or her official duties.
 - A golf cart operated on a city street under this article is not required to be registered under the Michigan Vehicle Code for purposes of section 3101 of the Insurance Code of 1956, 1956 PA 218, MCL 500.3101.
 - As used in this article, "golf cart" means a vehicle designed for transportation while playing the game of golf. A golf cart is not required to meet the vehicle safety requirements of a low-speed vehicle for approval under this article.
 - The operator of a golf cart shall obey all sections pertaining to traffic in the Michigan Vehicle Code and the Uniform Traffic Code.
 - Golf carts shall not be operated on a road or street in a negligent, careless, or reckless manner so as to endanger any person or property, or to obstruct, hinder, or impede the lawful course of travel of any motor vehicle or the lawful use by any pedestrian of public streets, sidewalks, paths, trails, walkways, or parks.
 - Violation of any of the provisions of this section shall be penalized as a civil infraction as described in Sec. 1-13.

ARTICLE X. PARENTAL RESPONSIBILITY

Sec. 20-300. Definitions.

For the purposes of this article, the following words and phrases shall have the meanings respectively ascribed to them by this section:

Criminal acts shall mean those acts which violate state laws, this Code or other ordinances of the city and shall include traffic violations.

Habitual offender shall mean one who commits two (2) or more criminal acts, or three (3) or more traffic violations within a twelve-month period.

Minor shall mean any person under the age of seventeen (17) years residing at the home of the parent, guardian or other person as defined in this article or as interpreted by state law.

Parent shall mean the mother, father, legal guardian or any other person having the care, custody and control of any minor or such other adult with whom a minor may be found to reside with.

Parental neglect shall mean failure to supervise to a degree of parental control which would result in the minor committing any criminal act as defined herein or to permit a minor to become delinquent as defined in the state probate code pertaining to juveniles.

Sec. 20-301. Legislative findings.

The city council finds that offenses against the laws of the United States, the state and the ordinances of the city by persons under the age of seventeen (17) years are increasing at an alarming rate; that in a great many of the cases a lack of proper supervision and control of the minor child by his parents or guardian is evident; that the increasing problem of criminal offenses by children will not be solved by sanctions imposed upon the children alone but that it is necessary that sanctions be imposed upon parents whose neglect of their duty to properly supervise and control their children is a proximate cause of the delinquency of those children.

Sec. 20-302. Parents contributing to child becoming neglected or delinquent.

Any parent, legal guardian or other person having the care or custody of a child under the age of seventeen (17) years who shall by any act, or by word, or by failure to act, or by lack of supervision and control over the child, encourage, contribute toward, cause or tend to cause the child to become neglected or delinquent so as to come or tend to come under the jurisdiction of the Juvenile Division of the Probate Court as defined in Section 2, of Chapter

12a of Act No. 288 of the Public Acts of 1939, as added by Act No. 54 of the Public Acts of the first session of 1944, any amendments thereto, whether or not such child shall in fact be adjudicated a ward of the probate court, shall be responsible or guilty of an offense.

Sec. 20-303. Malicious Mischief Generally.

(a) It shall be unlawful for any person to willfully destroy, remove, damage, alter or in any manner deface any property not his or her own, or any public school building, or any public building, bridge, fire hydrant, alarm box, street light, street sign, traffic control device, railroad sign or signal, parking meter, or shade tree belonging to the city or located in the public places of the city, or mark or post hand bills on, or in any manner mar the walls of, any public building, or fence, tree, or pole within the city, or destroy, take, or meddle with any property belonging to the city, or remove the same from the building or place where it may be kept, placed, or stored, without proper authority; or disturb, tamper with, disconnect or damage any city water meter without proper authority.

State law reference(s)-Malicious mischief, MCL 750.377 et seq.

Sec. 20-304. Aiding and abetting minor to violate the law generally.

a) Any person of the age of seventeen (17) years or over, assisting, aiding, abetting, allowing, permitting or encouraging any minor under the age of seventeen (17) years to violate the provisions of the state law, including the Probate Code, this Code or other ordinances of the city, regarding minors, being their first offense, shall be responsible of a civil infraction. Any subsequent offense committed by the person shall be guilty of a misdemeanor.

Sec. 20-305. Aiding and abetting minor to violate specific state laws.

a) Any parent, legal guardian or other person having the care or custody of any child under the age of seventeen (17) years who shall assist, aid, abet, allow, permit or encourage the minor to violate the provisions of Sections 1 and 2 of Act No. 41 of the Public Acts of 1960, as amended, either by overt act, by failing to act or by lack of supervision and control over the minor, is guilty of a misdemeanor. The fact that a child under the age of seventeen (17) years is apprehended while on the public streets, highways, alleys or parts thereof during the hours defined in said Act No. 41, shall be prima facie evidence of a violation of this section on the part of the parents, legal guardian or other person having the care or custody of the minor child.

b) Any person who shall by any act, omission, or by any word, procure, counsel, aid, abet, encourage, contribute toward, cause or tend to cause any minor to become delinquent so as to come under or tend to come under the jurisdiction of the juvenile division of the probate court, as defined in MCL

712A.2, whether or not such child shall in fact be adjudicated a ward of the probate court, is guilty of a misdemeanor.

Sec. 20-305. Notification of responsibility.

(a) Whenever a minor shall be arrested for the commission of any criminal act within the city or becomes delinquent as defined in the Michigan Probate Code, the parent of such a minor shall be immediately notified by the police department advising the parent of such arrest, the reason therefor and his responsibility under this article.

(b) A record of such notification shall be kept by the city police department.

Sec. 20-306. Penalty.

(a) The first violation of Sec.20-304 of this Chapter shall be a civil infraction, the Court shall impose a fine of fifty dollars (\$50.00) as provided for in Section 7.04 of this Code and any other costs or fees permitted or required by law, unless the person is specifically charged under Sec. 20-305 of this Chapter as a misdemeanor. If said person is charged under Sec. 20-305 of this Chapter, the penalty shall be as described in Sec. 20-306(b).

(b) Upon the second or subsequent violation of any provision of this Chapter shall be a misdemeanor, the Court shall assess fine of not less than two hundred dollars (\$200.00) nor more than five hundred dollars (\$500.00) in addition to any costs or fees permitted or required by law. In addition to such fines and costs, the Court may impose a jail sentence of up to ninety (90) days. In addition to such fine the Court shall, unless it makes a specific finding that probation is inappropriate, exercise its authority to sentence the Defendant to a term of probation with such conditions as the Court deems appropriate.

Such conditions may include participation in, and completion of, programs or therapies deemed appropriate by the Court in light of the facts of the particular case community service and/or work crew. Restitution shall also be required to make whole any victim or third party who has suffered financial loss in connection with the charged violation. Should the Court choose not to sentence the Defendant to a term of probation or should the Court suspend all or any portion of a fine, costs or restitution assessed against the Defendant, the Court shall so state on the record and shall state the reason or reasons for its action. In addition to the penalties provided for in this subsection, the Court may also impose any penalties otherwise provided for by law.

Sec. 20-307. - Parental Duties.

(a) It is the continuous duty of the parent of any minor to exercise reasonable control to prevent the minor from committing any delinquent act.

(b) No parent of any minor shall fail to exercise reasonable parental control over such minor. The exercise of reasonable parental control shall include, but is not limited to, the following:

- Keeping drugs out of the home and out of the possession of the minor, except those drugs duly prescribed by a licensed physician or other authorized medical professional.
- Keeping firearms out of the possession of the minor except those used for hunting in accordance with local ordinance and state law and with the knowledge and supervision of a parent.
- Requiring the minor to observe the curfew ordinance of the City of Ovid.
- Requiring the minor to attend regular school sessions and forbidding the minor to be absent from class without parental or school permission.
- Arranging proper supervision for the minor when the parent must be absent.
- Preventing the minor from maliciously or willfully destroying any property which belongs to any other person.
- Forbidding the minor from keeping stolen property or alcoholic beverages.
- Seeking help from appropriate governmental authorities or private agencies in handling or controlling the minor, when necessary.
- Assisting and cooperating with governmental authorities in their efforts to handle or control the minor, including production of the minor for juvenile court appointments and hearings.

At the regular meeting of the City of Ovid Council held on December 11, 2023 at 7:00 PM, Council Member L. Perrien made the motion to adopt and enact Ordinance #142 Parental Responsibility.

Council Member M. Olger seconded the motion.

Ordinance #141

City of Ovid

Clinton County, Michigan

ARTICLE II. OPERATION OF OFF-ROAD RECREATION VEHICLES ON CITY STREETS

Sec. 32-24. Operation of off-road recreation vehicles (ORVs) on city streets.

Except as set forth herein or otherwise provided by law, an individual may operate an ORV on city streets subject to the Michigan Motor Vehicle Code, Act 300 of 1949, in conformance with Public Act 451 of 1994 and by the following restrictions:

(a) No person under twelve (12) years of age shall operate an ORV.

(b) A person under the age of eighteen (18) years of age shall not operate an ORV unless the person is in possession of a valid driver license or under the direct supervision of a parent or guardian and the person has in his or her immediate possession an ORV safety certificate issued pursuant to Part 811 of the Michigan Natural Resources and Protection Act or a comparable ORV safety certificate issued under the authority of another state or a province of Canada. These requirements are in addition to any applicable requirements of state law in MCI 324.81129, as may be amended.

(c) All ORV operators eighteen (18) years of age or older shall have in their immediate possession a valid drivers license.

(d) A person shall not operate an ORV at a speed greater than twenty-five (25) miles per hour or a lower posted ORV speed limit or in a manner that interferes with traffic on the street. In no event shall a person operate an ORV at a rate of speed greater than is reasonable and proper, or in a careless manner, having due regard for conditions then existing.

(e) Unless the person possesses a valid driver license pursuant to MCI 257.25, as amended, a person shall not operate an ORV if the ORV is registered as a motor vehicle, and either is more than Sixty-five (65) inches wide or has three (3) wheels.

(f) ORVs shall travel single file except that an ORV may travel abreast of another ORV when it is overtaking or passing, or being overtaken and passed by, another ORV.

(g) ORVs shall display a lighted headlight and lighted tail-light at all times.

(h) A person shall operate an ORV with the flow of traffic on the far right of the maintained portion of the street, in a manner that does not interfere with traffic on the street.

(i) Operation of ORVs is not allowed on the Fred Meijer CIS Rail Trail.

(j) A person shall not transport any passenger in or upon an ORV unless the manufacturing standards for the vehicle make provisions for transporting passengers.

(k) A person shall not operate an ORV unless the vehicle is equipped with a braking system that may be operated by hand or foot, capable of producing deceleration at fourteen (14) feet per second on level ground at a speed of twenty (20) miles per hour; a brake light, brighter than the taillight, visible from behind the vehicle when the brake is activated, if the vehicle is operated during the hours of one-half (-) hour after sunset and one-half (-) hour before sunrise; and a throttle so designed that when the pressure used to advance the throttle is removed, the engine speed will immediately and automatically return to idle.

(l) An individual who is operating or is a passenger on an ORV shall wear a crash helmet and protective eyewear that are approved by the United States department of transportation. This subsection does not apply to an individual wearing a properly adjusted and fastened safety belt if the ORV is equipped with a roof that meets or exceeds United States department of transportation standards for a crash helmet.

(m) An ORV shall not be operated on any state trunkline (M-21) right-of-way, except that the operator of a vehicle may cross a street, county road, or highway, other than a

limited access highway, at right angles, for the purpose of getting from one (1) area to another, if the operation can be done in safety. The operator shall bring the vehicle to a complete stop before proceeding across a street, county road, or highway, and shall yield the right-of-way to oncoming traffic.

(n) These requirements are in addition to any applicable requirements of state law in Part 811 of Act 451 of 1994, the Natural Resources and Environmental Protection Act, as may be amended.

(o) Equipped with at least one (1) mirror securely mounted and positioned on the ORV in such a manner to be able to clearly view traffic approaching from behind. It is lawful for city employees or city contractors to operate a city-owned ORV for any purposes within the scope of city operations.

Sec. 32-25. Responsibility.

(a) The operator of an ORV involved in any accident resulting in any property damage, personal injury, or death shall report such accident to the local police immediately.

(b) The operator of the vehicle is liable for damages to private property caused by operation of the vehicle under this chapter, including, but not limited to, damage to trees, shrubs, or growing crops, injury to other living creatures, or erosive or other ecological damage. The owner of the private property may recover from the individual responsible nominal damages of not less than the amount of damage or injury.

Sec. 32-26. Penalties.

(a) A person who violates this section is responsible for a civil infraction and subject to a fine of not more than \$500.00 and/or impoundment of the vehicle. In the event an ORV is impounded, the owner of the ORV must pay the cost of transportation, towing, storage, and prove ownership of the ORV before it is released to that owner.

(b) In addition to the fine provided for herein, a court shall order violators of this section to pay the cost of repairing any damage to the environment, a street, county road, or highway, or public property as a result of the violation pursuant to MCI 324.81131(17).

(c) The city treasurer shall deposit fines and damages collected for violations of this section into a fund to be designated as the "ORV Fund." City council shall appropriate revenue in the ORV Fund as follows:

(1) Fifty (50) percent to the Ovid Police Department for ORV enforcement and training.

(2) Fifty (50) percent to the Ovid Public Works Department to be used for repairing damage to streets and the environment that may have been caused by ORVs and for posting signs indicating ORV speed limits or indicating whether streets are open or closed to the operation of ORVs under this section.

At a regular meeting of the City of Ovid held on December 11, 2023, Council Member E. Brown made the motion to adopt and enact Ordinance #141 Operation of Off-Road Recreation Vehicles (ORV). Council Member L. Perrien seconded the motion. Upon Roll Call Vote the Following voted AYE: L. Ordway, L. Perrien, M. Olger, W. Lasher, E. Brown, M. Perrien, E. Starn. Upon Roll Call Vote the Following voted NAY: None. Adopted on this 11th day of December 2023.

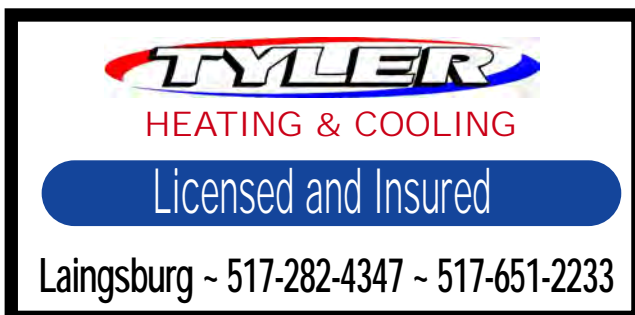

Future of the Township/Your Tax Dollars

Letter to the Editor:

OVID TOWNSHIP RESIDENTS

The integrity of the Ovid Township, and the overall availability of services are in jeopardy and need your assistance. Here are the reasons for my concerns:

1. The roof on the Township Hall has been in need of repair since March 2021 (verified in the Board Meeting minutes for that month). The issue has been pushed from one board meeting to another, with no resolution – 33 months total. Supervisor West has been recommending a steel roof, but the other Board members voted against this without adequate supporting documentation. At the December Board meeting Trustee Hibbard reported that a special meeting had been held on November 16 2023, and the Board decided to replace the roof with a polymer asphalt roof, but a contractor and cost still had not been determined.

2. Supervisor Jennings West reported that earlier on Thursday the Clinton County Road Commissioner had provided the Supervisor with a map of the township roads and bridges that were in various degrees of damage. Instead of being concerned with the issue, Clerk Barrett Pluger stated that the issue was not on the agenda and should not be discussed. Supervisor West provided pictures of the damaged bridges and the board members agreed that something had to be done, stating that the County was responsible for the roads and bridges. Supervisor West provided the costs for the immediate repairs that were needed as well as those coming in the future. The Supervisor also suggested a Road Millage be placed on the ballot in the next voting event as the Township does not have the funds to pay for such extensive repairs. The Clerk, Treasurer and Trustee all rejected that idea stating that it would never be approved and they didn't want to raise taxes anymore, and that the County was supposed to take care of the roads and bridges. Supervisor West stated that the option was road closures which would negatively impact the township residents, and informed the board members that the Road Commissioner meets with the Township Supervisor, reviews the roads and bridges needing repair, provides the cost to the Township Supervisor, and then the Township has to pay for it. The Board members all disagreed.

3. The Treasurer, Clerk, and at least one Trustee are all against publishing the meeting minutes on a monthly basis, citing cost and a lack of resident interest. The cost is \$80.00/month/, \$960.00/year. Treasurer Hughson and Clerk Barrett Pluger stated that 90 – 99% of the residents do not even read the paper. When asked for the data to support this, Treasure Hughson stated that she knew based on the number of residents who come to her office asking questions. Both the Clerk and Treasurer received pay increases of \$1,110.00 early in 2023, which would have covered the cost of keeping the township residents informed.

The future of the Township, condition of the roads, bridges, and quality of the services available to the residents, needs your help. We need you to come to the board meetings, 7 p.m. on the 2nd Thursday of each month, at the Township Hall, 1015 Baese Court, in the same area as Journey Federal Credit Union and let your voices be heard.

We also need volunteers to consider running for a Board office. We need Board members who are concerned with the needs – current and in the future – and support the Township Supervisor, who display commitment, integrity, and full transparency to the Township residents.

Faith Focus

“Isaiah Hark Dude”

“I am coming and I will live among you... (Zephaniah 2:10-11).”

Christmas Eve always held a wonderful magic for me as a small boy. It almost tingled.

There was a midnight church service with carols, incense, and candles, and then home to try to sleep before the cascade of presents filled our living room. I didn't quite understand it all, but Jesus and Santa had a major role. It was like a jigsaw puzzle with no box lid to see how to finish the puzzle, but I got cool toys. That much I understood.

As I got older, that magic faded. I understood more — Santa was my parents and the picture on the lid was a nativity scene of an important baby who would die on a cross, but now I got clothes. For me, Christmas became more like a big birthday. Where was that special magic? I still didn't see how it all fit together. Now the puzzle pieces seemed to be flipped over, all gray. The answer had to be in that other jigsaw puzzle — the Bible.

There was an answer in Isaiah 48:16...“Draw near to Me, hear this: Since the beginning, I have not spoken in secret. From the time it existed, I was there. So now the Lord God has sent Me, and His Spirit.” So God had intended all along to come to us. Christmas was not a secret (Isaiah wrote this about 700 years before Jesus was born, but God had planned it well before that, from the very beginning of time). Sounds magical, but why?

According to Isaiah, that manger baby in swaddling clothes was sent by God...and was God Himself — Immanuel means God with us (Isaiah 7:14). A Christmas carol flashed to mind, “Veiled in flesh, the Godhead see; hail th'incarnate Deity (Hark! The Herald Angels Sing).” More lyrics helped flip the puzzle pieces over to see God's big picture, “God and sinners reconciled!” Ah, it's about reconciliation with God (Isaiah 61:1-2).

So, the picture on the lid was the Bethlehem nativity, but in the background was the point, Jesus on the cross. Our sin separated us from God (Isaiah 59:2). God came as a baby, the King of all kings, to die for us to end sin and death (Isaiah 53:1-12), “Born that man no more may die; born to raise the sons of earth, born to give them second birth.” His death would remove our sin, raise us up from the dead like Jesus, and reconnect us to God in a new way (John 3:1-15). So Easter was in Christmas? That's tingle-magic too!

But if Christmas holds no magic for you, and it's all gray, try flipping over these Isaiah pages. You just need to hark... which means, “Dude! Listen up!” Or as the Spirit said through Isaiah, “Come near to Me, listen to this...I have not spoken in secret.” That means Hark, and that's looking up these Bible passages. You can start with Isaiah 9:2-7.

Harking is really that simple. Just read. Christmas is not a secret. Then, just receive His reconciliation gift by faith, like a small child (John 1:12-14). Isaiah. Hark. Dude!

Wolfsack Mat Team Captures Sand Creek Individual Tourney

SAND CREEK -- Laingsburg's Wolfsack varsity wrestling team outdistanced Jackson HS by more than 60 points to claim the Sand Lake Individual Tournament here.

Coach Shawn Baynes' Wolves accumulated 227 team points to easily get past Jackson (163 points), the host Aggies 143, Adrian 142.5, Reading 136.5, Blissfield 115, Hillsdale 114 and Onsted 112.

Teams from Grass Lake, Grosse Ile, Riverview, Concord, Morenci, and Camden-Frontier rounded out the field, which gives prep grapplers a barometer for wrestling strength from around the state and helps prepare them for later tournament action.

Marlon Graham (9-2) helped lead the Wolves, placing 1st and totaling 28.0 team points.

Cole scored 19 points in the first half en route to a 30-point night, including 5 rebounds and 9 steals in just 24 minutes of action. Ava Bates also hit double digits with 12 points, 4 rebounds, and 3 assists while Braeden Tokar (4 assists) and Ellyanna Carman (3 rebounds, 3 steals) each chipped in with 7 points each. 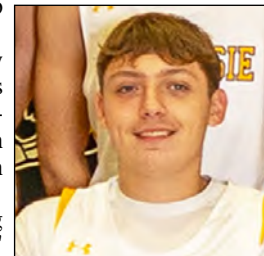
