#### **Elsie Lions Host Annual Wild Game Dinner**

ELSIE — A packed house was on hand January 8 as the Elsie Lions Club hosted its 30th Annual Wild Game Dinner at the Elsie American Legion Hall.

Dinner-goers were able to dig in on a wide variety of wild game selections, including bear, elk and venison. The Lions provided potatoes, rolls, milk and coffee ... so that no one left hungry.

Following the dinner, Elsie Lions president Rick Jones introduced guest speaker Terry Kemp, a longtime member of the Commemorative Bucks of Michigan (CBM). The nationally accredited group has received accolades for decades, including in hit movies such as Jeff Daniels' "Escanaba In Da Moonlight."

Kemp gave a thorough history on the creation of CBM. He has been involved with the organization since its inception in 1981.

CBM was first created to measure record bucks in Michigan. It eventually became Michigan's official record keeping organization for not only deer, but also bear, elk and turkey.

Each species is listed in the permanent records by weapon: firearm, muzzleloader, crossbow, bow & arrow and handgun. On an annual basis those categories are also broken down even farther into youth, women, seniors and all entries. Every three years a record book has been published, "Michigan Big Game Records" listing the complete CBM permanent records with a county-by-county breakdown.

Kemp also had several copies of the organization's periodical magazine, Buck Fax, for local hunting enthusiasts to peruse.

One of the highlights of the evening was the Lions' Raffle for a Savage Axis 350 rifle, which was won by Bruce Levey of Elsie. Several other raffle prizes for children and adults were handed out.

#### **Elsie Village Council Meeting**

Elsie – The regular meeting of the Elsie Village Council was held Tuesday, January 9, 2024, officials discussed the budget process.

Monthly action was taken to approve the minutes of the December 2023 regular meeting, the meeting agenda with the additions of Clinton Area Ambulance Service resolution and budget, and the approval of the monthly financial reports. Officials took action to approve expenditures totaling \$44,919.73.

Kory Witt, trustee, updated officials on the activities at Clinton Area Ambulance. The Clinton Area Ambulance Association 2024 budget was presented for review and Village approval, in addition, a resolution to purchase a new ambulance presented for approval. Both were approved by officials, after discussion.

Chief Bryce, reported on the November and December Elsie Police Department activi-

Chief Bryce, reported on the November and December Elsie Police Department activities. Three major investigations are in the works more information will be available at a later date. The last few months have been very busy. Year end – 569 complaints handled by the department for 2023.

Shane Grinnell, presented the manager's report. The new clerk/treasurer Tiffany Frink is transitioning into the position well. There is a part-time vacancy in the DPW position due to a recent resignation. The permanent part time was posted with seven applications received. Noting, that four interviews will be scheduled.

Next, Elsie Village Council belongs to the Michigan Code Enforcement Association, which offers online courses to completed for certification which will open doors for resources for the Village. Being affiliated with the Elsie Police Department is a huge asset.

Chris Ormes, Department of Public Works, updated officials on the department's activities. Ormes presented an overview of the needs of the department for the next fiscal year. Catch basins will be delivered January 15, 2024, installation is uncertain.

A budget committee meeting was set for January 30, 2024, 7 pm. Members of the committee are Joe Ondrusek, Sam Frink, and Dorothy Ornelas.






#### Michael "Mook" Rodriguez





#### ARTICLE VI. GOLF CARTS ON CITY STREETS

Sec. 32-140. Operation of golf carts on city streets.

A person may operate a golf cart on city streets, subject to the Michigan Motor Vehicle Code, as amended, being MCL 257.657a, in conformance with Public Act 491 of 2014 and by the following restrictions:

- (a) A person shall not operate a golf cart unless he or she is at least sixteen (16) years old and licensed to operate a motor vehicle
- (16) years old and licensed to operate a motor vehicle.
  (b) The operator of a golf cart shall comply with the signal requirements of MCL 257.648 that apply to the operation of a vehicle.
- (c) A person operating a golf cart upon a roadway shall ride as near to the right side of the roadway as practicable, exercising due care when passing a standing vehicle or one (1) proceeding in the same direction.
- (d) A person shall not operate a golf cart on a state trunk line highway (M-21). This subsection does not prohibit a person from crossing a state trunk line highway when operating a golf cart on a city street, using the most direct line of crossing.
- (e) Where a usable and designated path for golf carts is provided adjacent to a highway or street, a person operating a golf cart shall be required to use that path.
- (f) A person operating a golf cart shall not pass between lines of traffic, but may pass on the left of traffic moving in his or her direction in the case of a two-way street or on the left or right of traffic in the case of a one-way street, in an unoccupied lane.
- (g) A golf cart shall not be operated on a sidewalk constructed for the use of pedestrians or on or across a cemetery or burial ground.
- (h) A golf cart shall be operated at a speed not to exceed fifteen (15) miles per hour and shall not be operated on a highway or street with a speed limit of more than thirty (30) miles per hour except to cross that highway or street. (i) A golf cart shall not be operated on the Fred Meijer CIS Rail Trail. (ii) A person operating a golf cart or who is a passenger in a golf cart is not
- (j) A person operating a golf cart or who is a passenger in a golf cart is not required to wear a crash helmet.
- (k) This article does not apply to a police officer in the performance of his or her official duties.
- (I) A golf cart operated on a city street under this article is not required to be registered under the Michigan Vehicle Code for purposes of section 3101 of the Insurance Code of 1956, 1956 PA 218, MCL 500.3101.
- (m) As used in this article, "golf cart" means a vehicle designed for transportation while playing the game of golf. A golf cart is not required to meet the vehicle safety requirements of a low-speed vehicle for approval under this article.
- (n) The operator of a golf cart shall obey all sections pertaining to traffic in the Michigan Vehicle Code and the Uniform Traffic Code.
- (o) Golf carts shall not be operated on a road or street in a negligent, careless, or reckless manner so as to endanger any person or property, or to obstruct, hinder, or impede the lawful course of travel of any motor vehicle or the lawful use by any pedestrian of public streets, sidewalks, paths, trails, walkways, or parks
- (p) Violation of any of the provisions of this section shall be penalized as a civil infraction as described in Sec. 1-13.
