

## **Five Marauders - Boys and Girls - Advance** for Ford Field Wrestling Finals

OVID-ELSIE -- It's on to Ford Field in Detroit for a quintet of talented Ovid-Elsie wrestlers. Who'll be representing both the boys and girls teams.

Seniors Cole Workman and Talan Parsons will be making return trips for coach Kyle Spiess' Marauders.

Parsons, at 113 lbs., is not only headed to Ford Field for the 4th time, but he is a 4-time District and 4-time Regional champion. He recorded his 149th, 150th and 151st wins during Regional action at Howard City. Parsons' individual record improves to 42-1 on the year with the win. He is also the backto-back All-Area Wrestler of the Year, as honored by the Owosso Argus-Press.

Workman finished 2nd at 138 lbs. and advances to the State Finals for his third trip.



## Sparrow Honors Outstanding Nurses with DAISY Award for Compassionate Care

LANSING, MI – E.W. Sparrow Hospital recently recognized three highly skilled nurses with the DAISY Award, celebrating the compassionate and super-human work they perform for those who cannot care for themselves.

Sparrow Emergency Department Nurse Jordan Neill, BSN, RN, received a DAISY Award after being nominated by his peers for going above and beyond to help a patient who had been unable to brush her own hair for months. Jordan traveled to the patient's bedside in the neuro-trauma ICU and gave her a much-needed haircut.

"He treated her like she was at the salon," said Sparrow Nurse Olivia Geers. "He gave her the perfect pixie cut and brought so much light into the patient's eyes that 1 am certain no other person at the hospital could have done."

Kimberly Fleming, BSN, RN, who works on the hospital's surgical specialties unit, was honored for demonstrating the true meaning of compassion: listening to her patients, taking action to help, and advocating for their needs. She recently went above and beyond to treat an 84-year-old patient with dementia with kindness and dignity.

"As my mom's dementia has gotten worse - I have witnessed people discard her, ignore her and act like she isn't a worthwhile person," the patient's daughter said. "Kimmy was so kind and treated my mom with respect - she talked directly to her and there was no judgement, only help, when my mom (and I) most needed it."

Sparrow Emergency Department Nurse Devin Hopkins, RN, was named DAISY Award honoree for taking extra time to listen to the concerns of a patient's family. She even helped them brainstorm how to best continue caring for her at home with Sparrow's palliative care team.

"Devin showed patience and respect with my mom who has difficulty with speech," the nomination said. "Because she listened, Devin was able to ask for my mom's opinions on things and take her wishes into consideration."

The DAISY Award is an international program that rewards and celebrates the extraordinary, compassionate, and skillful care given by nurses every day.

"As a nurse we have the opportunity to make a real difference in the lives of our patients," said Kathy Marble, E.W. Sparrow Hospital's chief nursing officer. "By providing outstanding support, care and compassion, our nurses have now built trust and lifelong relationships."

All three nurses received a certificate of recognition, a DAISY pin to wear at work, and beautiful serpentine stone sculpture carved by the artists of the Shona Tribe in Zimbabwe. The special "Healer's Touch" sculpture, designed for leaders, depicts the relationship nursing managers have with their caregivers and embraces the relationship nurses have with their patients.

Nurses and nursing leaders are nominated for the award throughout the year by patients and patients' families.


## Community Health Care Providers Honor Moolenaar


#### **Neil Stinson Sr.**

Neil Stinson Sr. of Carland passed away peacefully at Sparrow Hospital in Lansing on Sunday, February 18, 2024. He was 84 years old.



### Moolenaar Announces More Michigan Agriculture Support for His Supporting Farm Operations Act

Congressman John Moolenaar announced additional Michigan agriculture organizations have endorsed his legislation, H.R. 7046, the Supporting Farm Operations Act. The Michigan Apple Association and the Michigan Vegetable Council have both endorsed the legislation, which would freeze the wage rate for migrant farm workers, known as the Adverse Effect Wage Rate (AEWR) at the level that was established in 2023. This freeze would go through the end of 2025.

"I am proud to have the support of more Michigan agriculture groups for my legislation to help farmers. The Department of Labor has been raising costs on farmers for years and these unprecedented increases are making it difficult for them to keep working. Farmers and ag groups support my bill because it will help ensure they can pay a reliable work force and still afford to make ends meet," said Moolenaar.

Congressman Moolenaar's AEWR freeze bill is a positive step forward as the legislature addresses the onerous and expensive regulations around H2A and the need for meaningful reform. The Michigan Apple industry is grateful for Congressman Moolenaar's continued support and his work to preserve the United States agriculture industry," said Diane Smith, Executive Director of the Michigan Apple Association.

"Our country must grow food for itself. The next few years will be telling as to how long and to what quantity we continue to grow fruits and vegetables. An AEWR freeze is one step in the right direction to begin to offset current unsustainable labor costs," said Greg Bird, Executive Director of the Michigan Vegetable Council.

The Michigan Apple Association and The Michigan Vegetable Council now join Michigan Farm Bureau, the American Farm Bureau Federation, the National Council of Farmer Cooperatives, the International Fresh Produce Association, and the U.S. Apple Association in endorsing Moolenaar's legislation.

worked with movie stars. I don't recall the job posting, but I guess I fit the bill because I got hired — as a busboy at a private tennis club serving famous people like Bill Cosby.

Now suppose God wanted to hire somebody, what would that job description look like?

Now suppose God wanted to hire somebody, what would that job description look like? God doesn't need anything, but what if it was for us, to solve a problem we had? Isaiah 53:6 says, "All we like sheep have gone astray, each of us has turned to his own way." We've all lied, cheated, or stolen. So what? Nobody's perfect. We're all off the path.

But part of our straying problem is we don't want help. We think we're fine. Sin is no big deal. God says otherwise. "The wages of sin is death (Romans 6:23)." Nobody's perfect means we all work at Sin, Inc. and our paycheck is death. It killed our soul (Ephesians 2:1), our body (Romans 5:12), and separated us from Him (Isaiah 59:2). Even one sin ruins us (James 2:10). So can't we just say we're sorry and be forgiven?

Not really. Sin is in our nature, like an arsenic tattoo. Just asking for forgiveness doesn't erase the stain. We assume we're forgiven because God loves us, but we forget that He's also righteous (holy), which means He must punish all wrongs to remain just and fair (Exodus 34:7). A righteous God has only one way to remove our death tattoo. Blood.

The animal sacrifices in the Old Testament gave us a clue about the gravity of sin and forgiveness. It's costly, gross, takes a life, and is only a temporary fix (that's why they were repeated). What we need is a permanent fix to make us perfect (holy) to be with a perfect (holy) God. All this blood pointed to a future death to do just that (Hebrews 10).

Since God is the only one who is perfect, only His blood can remove sin, which brings us back to God's Want Ad — "Wanted, a perfect man to have the iniquity of all put on him. Must be good with rejection." God's job posting went unanswered until Jesus arrived (Luke 4:14-21), the only qualified applicant to interview (John 14:6). In short, God's love and justice met on the cross and solved a problem we couldn't fix.

"He made Him (Jesus) who knew no sin to become sin on our behalf that we might become the righteousness of God in Him (2 Corinthians 5:21)." Imagine King Charles has to judge Prince Harry for murder. He can't ignore his crime, so he took his place. Sin is a very big deal because the King had to die to remove your tattoo (Romans 5:8).

So how do sheep apply His blood soap? Give up, turn back to God's path, and wash by faith in His mercy as your substitute (John 1:12, Ephesians 2:8-9). His gift of eternal life was expensive, but the good news is it's free at Jesus, Inc. (Romans 6:23). 


## **Wolfpack Seniors Sent Off** Witnessing Athletic History at Laingsburg High School

Have you ever had a humiliating moment? A, "I want to find a hole to crawl into" type of moment?

I'm sure that all of us have done something that we've been called out on. Something bad that was addressed and we needed to confess and ask for forgiveness. Maybe that took place in public, maybe it was a small group or maybe just one-on-one. In any case, those are tough pills to swallow. There are good and not so good ways at being called to account, but in your situation (and mine) at the minimum we would need to admit that we were to blame. Some type of acknowledgment and apology were necessary to make things right.

What if I told you about someone who was humiliated in public in the worst way? That he underwent society's most ameful treatment that one could endure?

You may think, "That's too bad, but he probably deserved it. He must have done something really bad to get that kind of treatment.'

I felt obligated when my out-of-state siblings suggested we send a plant. What do you think is the appropriate thing to do? I was the only one from our branch of the family. And, I hope I can collect the costs before next summer's family reunion. Loving Niece

Dear Loving Niece,

You are not just a loving niece, you are a kind and responsible sister. Send your sibs a self-addressed stamped envelope or your Veno Acct information soon! And...

This is a subject matter that should be talked about at a time when you are not under pressure to feel obligated. Plan with your siblings sooner rather than next time; there will be more situations you will want to do something special at the loss of another loved one, weddings, a graduation, a baby, a Baptism, or some other milestone for family members.

Your attendance at the funeral or visitation and a gentle hug for your cousins is the most appropriate thing to do. When a person cannot make the funeral because they are out of state, a plant is appropriate and nice, if you can afford it. Another thoughtful idea and not typically too expensive is to give a garden stone, often with a comforting message etched into the stone or a framed picture with a heartfelt verse.





### **Rep. Filler Successfully** Modernizes Michigan's Estate, **Probate Process**

State Rep. Graham Filler's plan to update Michigan's laws regarding estates, trusts and wills was signed by the governor.

The bipartisan legislation recognized the need to modernize end-of-life planning laws, which hadn't been updated in decades and did not reflect the current cost of living.

'The weight of end-of-life decisions is heavy enough without the added complexity of outdated laws," Filler said. "I'm glad our laws now reflect the realities of modern life.'

Sponsored by Filler and Rep. Kelly Breen (D-Novi), Public Acts 1-4 of 2024 make multiple changes to trusts, guardians and advocates, and asset thresholds regarding wills and estates, including:

Increasing the value of a vehicle for which a surviving spouse or heir can request a title transfer outside of probate court.

Increasing the amount of a gift a minor can receive without the aid of a guardian or trustee not subject to court approval.

Increases the value of a watercraft for which a surviving spouse or heir can request a title transfer outside of probate

Each of the four bills earned unanimous support in the House and Senate before being signed into law.

"I am immensely grateful to Rep. Breen and Gov. Whitmer for their commitment to bipartisanship," Filler said. "Working together, we were able to modernize state law and align it with the needs of our communities.'

## **Rep. Filler Introduces Plan to Support Volunteer** Firefighters, Emergency **Medical Personnel**

State Rep. Graham Filler today introduced a plan to recognize the service and commitment of the men and women who volunteer as firefighters and emergency medical responders throughout Michigan.

Filler's plan would offer a tax credit to Michiganders who serve their communities with volunteer or paid on-call fire departments and life support agencies.

House Bill 5432 creates a \$2,500 tax credit for firefighters or EMS personnel who serve at least 10 hours a month as a volunteer with a fire department or life support agency in Michigan. Under Filler's plan, the tax credit would be collected when volunteer emergency workers file their taxes beginning with the 2024 tax year.

Filler said the tax credit could also help recruit and retain first responders in rural communities, which often rely heavily on part-time or volunteer agencies

House Bill 5432 was referred to the House Tax Policy Committee for consideration.
