Protect Young Eyes Event Well Attended

OVID - On Wednesday, February 28th, parents and citizens from the community attended a presentation by the Protect Young Eyes© (PYE) group at Heartland Church in Ovid. The speaker Dan



Armstrong, PTE© advocate and father of 5 children gave an outstanding two-hour program on how and why families needed to create a Tech-safe environment for their children growing up in our complex digital society.

At PYE© their research, education, and advocacy give families proven solutions, so they can be prepared with a plan of action that reflects family values and the protection needed while online. PYE© mission is to create a safer digital space with parental and adult involvement with controls while children are on apps, cell phones, or being entertained on their devices.

Armstrong revealed staggering statistics on the negative effects of technology at a young age and the dangers and consequences, of this and the next generation of children who are struggling to survive. Some challenges include a lack of social skills, posting inappropriate pictures, and communicating with dangerous strangers online. Armstrong discussed ideas to build digital trust within the family by modeling behaviors.

One of the many suggestions included getting permission from your children to agree on the posts of family pictures on your site or FB. Let them help choose if they want your view-

to shorten the coyote season from year round to nine months. Since 2016, the season has been year round but some participants within the sport of pursuing coyotes fear admonishment from the open public. Dear Mom, You didn't mention the age of your son. However, my advice is for any age of children and electronics. Know what they are doing. Learn it yourself. As they get older the interests become more diverse. Wanting a cell phone, iPad, laptop, internet. Monitor your children. Try an app for a week before you approve it for them. Too much inappropriate information at their fingertips.

It is never too late to develop communication practices with your children. Create a relationship with your child letting them know they can do or see anything, and you want them to know that they need to tell you when something seems off or questionable. Create a home environment that allows your children to know they can trust you to understand. Four-year-olds to 14 are targets for inappropriate activities. Use the words they understand so they know what is wrong. Protect your child. It doesn't just happen to teens and adults.

March is Reading Month. Most schools challenge the students to read 20 to 40 minutes each day at home. They have contests at school and recognition with rewards. You could make the same challenge by offering an additional 20 minutes on the video game or another coveted reward in exchange for reading. To increase comprehension or better understanding of his reading he likely needs more practice. He may not have the skills needed and does not realize it.

Find a book you can read together. Let them pick a book or magazine...if it is a subject they are interested in, it will encourage them to want to read it. Some strategies could include echo reading - that is when you read a passage and after listening and following along with you as you are reading; then he reads the same passage. Hearing someone else read fluently will give him the confidence to read aloud. Increased understanding will also increase his vocabulary. Increased vocabulary will increase his comprehension. Make every month reading month and he will be advanced before he knows what hit him.

In my experience, kids think things are great at school and never seem to tell their parents when they are struggling. To be academically prepared in school, it starts with reading and flashcards at home. There should always be vocabulary and math flash cards available for them to practice. (They sell them at the dollar stores but you can have your child make them.) Make vocabulary words from the words he struggles with when you read together. Always study for the weekly spelling tests by writing them twice, 2 times a week or every night of the week, as homework. Making their own flashcards and sentences with the words will involve them in a learning activity. This advice is for all students, not just video junkies or TV watchers. Be a bigger part of your child's success. If you still have a student struggling, find a tutor. Our kids are worth our investment. Ask_Andy@aol.com

Laingsburg's State Title Dream Dashed by Talented Lumen Christi

JACKSON -- The cosmic cards are shuffled. Fate deals its' hand.

Jackson Lumen Christi, hosting the MHSAA's version of the Sweet Sixteen -- the Regional Finals -- on its home floor, was the better team here March 7, Zander Woodruff with a 55-47 victory over Laingsburg.

The phrase is repeated so often it has become cliche: you get this far, there are no bad teams left in the tournament. On this one night, the host Titans looked like the better team from the

You've heard of

Audretsch March Madness? For coach Tim Beebe's Wolfpack, call this one March Malaise. As fate would have it, the Wolves locker room caught whatever sickness bug was floating around. Some players missed practice the day before the game and weren't feeling their best.

It showed. The Pack, 25-0 entering the contest, didn't have the usual spring in its step. Beebe knew he was starting the race with half a tank of gas -- and it affected what the Wolves were

The Titans opened up an early 12-10 lead, upped it to 25-18 at halftime, then stood ready for a momentous 3rd quarter. LHS cut the gap to 27-23, when Christi took over the game. Led by underclassmen Kadale Williams and Lundon Hampton -- just a freshman -- the Titans ran their fastbreak game to perfection and mixed in the occasional three-pointer. Yet, it was their defense that tilted the outcome. Rarely getting an open look at

the basket, Wolfpack misses turned into Titan rebounds, and when you mix in some costly turnovers, the hosts' quick-break game was off and running.

"Their defense was outstanding," said Beebe. "We had trouble all night getting any kind of open shot."

Facing a double-digit deficit in the 4th quarter the

Wolfpack braintrust had to wonder how much was left in the tank when they were forced to slap a full-court press on the Titans. It worked -- to an extent. Ferociously trapping any inbounds pass adn taking advantage of Lumen Christi's poor free throw shooting, Laingsburg got within 50-44 with :59 seconds left. Another fast-break bucket and three-point later, the Titans rendered the gas tank empty.

"Out guys played their hearts out," said Beebe. "We battled and battled all the way to the end. I'm so proud of our guys and what they've accomplished. They won 50 of their last 52 games. It just wasn't our night."

As fate would have it.

Williams and Amarion Clay were the long-range threats behind the arc and led LC with 15 and 11 points, respectively.

Facing that air-tight defense, the Wolves scratched and clawed, earning every one of their 47 points. In his final game, LHS career scoring leader Zander Woodruff again led the Pack with 28 points. Cam Ballard scored 6, Ty Randall 4, Mitchell George 2, Elliott Wilsey 2 and Jackson Audretsch one.

Of that group, only George returns next season.

Wolfpack fans exited the Lumen Christi fieldhouse silently, knowing they had witnessed a run of hardwood greatness they'll probably never experience again. As fate would have it, the State Title dream was over, stopped two games short last season, and three games early in 2023-24.
