Ovid City Proceedings

OVID – The regular meeting of the Ovid City Council was held Monday, June 10, 2024. Officials addressed a variety of issues including to purchase cell phones or not for city officials. In the end the consensus was there would be no advantage to purchasing individual phones for officials.

The attorney presented an update to the golf cart ordinance, the state law states carts cannot be on the road ½ before sunset and ½ before sunrise, this law supersedes a local ordinance. Action was taken to be available for public review. In addition, officials addressed a proposed vegetation ordinance amendment specifically addressing the property between the street and the sidewalk, who maintains the property. Homeowners and residents are required to cut the grass. Next, a proposed street openings referring to driveway approach and lawn extension, ordinance amendment. Both will also be made available for public review.

Police Chief Lisa Rousseau presented the Ovid Police Department monthly report and added to the printed report MICOL mandatory training each department will receive up to \$500 per full time employee. This is a month of training opportunities. Recommended that the City Ovid develop a vision mission statement and goals that would benefit the employees of the city. The chief requested assistance from Bill Lasher and Larry Ordway to address the lack of communication and ability to work together between the Ovid Police Department and the Ovid-Middlebury Fire Department. Rousseau noted that a member of the Ovid Police Department will be on scene of all fires within their jurisdiction.

Next, the Department of Public Works reported to the city council. A water valve was requested for the sewer system, and for discharge of sewer, and was approved. A tree bid was received for the cemetery to take care of the storm damage, \$5925, which was also approved. A request for commercial water purchase by the contractor for on the M21, a Consumers Energy project. Up to 1,000 gallons every other day. The request was denied until a policy is developed. Finally, the request to replace the light pole on N. Main Street, approximately \$6736, this will be turned into the insurance company with a decision at the next meeting.

Public Comment – Joseph Kioski was present to update officials on his work at Gumaer Park for his Eagle Scout project. He requested a city timeline on the tree removal and the types of trees to be replanted. It was noted that City has approved removal, still considering which trees to replant. The types of trees will be at Kioski's discretion with input from MSU Extension. Bids for tree removal were addressed later in the agenda. Kioski would also be installing a memorial bench and requested a location for the bench. It was noted that 170 trees will be removed.

ELSIE – The regular monthly meeting of the Elsie Village Council was held Tuesday, June 11, 2024. Numerous updates and action items were presented for approval.

Shane Grinnell, village manager, presented a report of his activities. Road paving will begin June 21, 2024 pending on the weather. The tree removal project in the business district has been completed and four benches have been delivered and will be installed before the

The final walk around and inspection has been completed with Consumers Energy and the Village lighting in the park. Within the next seven to ten days the project should be completed.

Memorial Day remembrance was a success. There were no complaints regarding Riverside Cemetery and the preparation prior to Memorial Day. A special thanks was expressed to Kaden Huss and the DPW crew for a great job grooming for the holiday.

Starting in July Tim Farr from Capital Catalyst and Shane Grinnell will be setting up a regular meeting schedule to bring business owners, community groups and businesses together to update opportunities with grant writers and availability to help get projects kicked-off. The meeting will be scheduled one hour prior to the regular council meeting every other month. Participation by village officials is encouraged.

Mr. Randy Redmer, the lagoon project representative, will be present at the next regular council meeting to update officials on the status of the project. A packet was provided regarding the possible road improvements that will need to be made. It was noted that improving the current driveway designation is the most cost effective and would meet the needs of the project. The investor will work with the village regarding hours of operation and park usage.

The L-4029, 2024-25 tax request was presented for approval. The request was approved unanimously.

Code enforcement is underway addressing blight issues. Seven residents were given written notice regarding blight concerns.

Police Chief Destinee Bryce presented the Elsie Police Department monthly report. The department conducted eight traffic stops resulting in one citation. Complaints have decreased from last month with a total 53 calls for service. Police activity for the month of May consisted of child abuse/neglect, criminal sexual conduct, identity theft and several suspicious situations.



Melissa Schutt, representing the Clinton County Transit updated officials on the happenings of the Blue Bus. It was reported that use in the City of Ovid has increased by 40%, there is a very flexible schedule regarding ridership and serving the community. Currently Ovid City residents utilize transit 74% use for work, 6% medical, 20% for shopping and recreation. Growth has increased at a greater rate than anticipated, so the service is stepping back and surveying community needs. Renewal of mileage for Clinton County Transit is on the August 5, 2024 state primary ballot. More information can be found on the bluebus.com website. A huge thank-you extended to officials for their continued support

A meeting with the engineer and contractors regarding the water project will take place Tuesday, June 11, 2024, with the major focus the schedule of the project. The City of Ovid will be represented by the DPW Director, the mayor of the city will not be present and did not designate another official, which prompted debate. No action taken.

New business included the adoption of the millage rate resolution 2024-09. Approved by roll call. A second resolution was adopted, Consumers Energy 2024-10 and agreement for light pole on M21 apartment.

Two issues regarding the water project were presented for discussion and approval. Payment #6 for the water project which was approved. Next addressing unpaid vendors and invoices from the water project. Mayor Bill Lasher presented two invoices that should be paid from water project funds and then reimbursed to the city by the contractor, Montgomery. The total of both is approximately \$20,000. If necessary, the city will take the money from the water project bond.

Cell phone for council members a request for additional information was made by councilman Lyle Perrien, at a previous meeting. This is a very basic flip phone, \$12.00 per month with limited data. The discussion included that either an official phone or a personal phone can be included in a FOIA request. No action taken to purchase for city officials.

The tree bids, 170 trees need to be removed at Gumaer Memorial Park, the bid was awarded to Above All Tree Service, in the amount of \$17,500. Noting that three bids were received ranging from \$17,500 to \$52,000.

The Planning Commission presented a quote to upgrade Boyer Park, which is located in the business district. The quote prompted discussion. Officials wanted more details and want to see a rendering of the proposed \$20,000 project. Officials opted to hold off until July, and requested that the committee come back with additional information.

Val Vail-Shirey, Clinton County Commissioner, District 1, reported that the stand-alone battery storage ordinance did not pass the commission. The next meeting of the Commission is County employee wage increases was approved. The Planning Commission meeting is slated for Thursday, June 13, 6:30 pm, at the Court House. The continued feedback from the City of Ovid is appreciated.

Monthly action was taken to approve the May 13, 2024 minutes with corrections, monthly financial reports and expenditures. Officials took formal action to approve budget amendments as requested. Summer tax preparation is under-



Rep. BeGole Bill Creates New **State Firearm Designation**

State Rep. Brian BeGole, of Antrim Township, issued the following statement after standing up for the Second Amendment rights of law-abiding gun owners throughout the state, as well as in Shiawassee, Genesee and Saginaw counties, with the introduction of House Bill 5792. The plan names the AR-15 as Michigan's official state firearm:

"Millions of people across the country and thousands in Michigan own an AR-15. This distinction recognizes these lawabiding gun owners who are often vilified just for having a firearm as a hobbyist or to keep their homes and families safe.

'In addition, many police agencies in Michigan use AR-15 platform rifles to keep our communities safe. As officers retire. they often continue to use this rifle as civilians because of its practicality, versatility and reliable track record.

'More and more often, AR-15 owners are ostracized and criticized for their perfectly reasonable and legal decisions to possess a firearm. That's just not right.

'I believe this recognition will go a long way in removing that stigma, which is creating an environment for laws and bills that erode our Constitutional protections, increase government overreach, and ultimately make us all less safe.

I will continue to stand for our Second Amendment rights and with responsible gun owners in the House, while fighting against measures that seek to infringe on those rights.

Michigan would join 10 other states where a state firearm has been designated: Alaska, Arizona, Indiana, Kentucky, Pennsylvania, Missouri, Tennessee, Texas, Utah and West

The grant funds, established by Public Act 411 of 2012, are aimed to promote the sustainability of land-based industries including food and agriculture, forestry, mining, oil and gas production, and tourism. Currently established priorities include infrastructure development, workforce training, business development, and rural capacity building that benefits rural communities.

"The Rural Development Grant Program focuses on supporting the rural communities and businesses within Michigan by encouraging the promotion of sustainable industry practices," said MDARD Director Tim Boring. "This grant program allows many communities to establish stronger businesses and create more opportunity within their communities.'

Eligible counties include those with a population no greater than 70,000 residents or micropolitan statistical areas. Preference was given to projects in Marquette County.
