## Federal Flood Insurance Now Available in Duplain Township

ELSIE – Duplain Township has joined over 22,000 communities nationwide that are allowed to purchase federally backed flood insurance. This availability follows the community's adoption and enforcement of ordinances to reduce flood losses and acceptance by the National Flood Insurance Program (NFIP).

Duplain Township is now a participant in the NFIP effective on MAY 17, 2024. Residents will be able to purchase flood insurance up to the limits under the regular phase of the program. However, there is a 30-day waiting period before flood insurance coverage goes into effect. For single-family dwellings, the building coverage limit is \$250,000 and the content coverage limit is \$100,000. Renters can also protect their belongings by purchasing contents coverage. For commercial properties, the building and contents coverage limits are both \$500,000.

Lenders must require borrowers whose properties are in a designated flood hazard area to purchase flood insurance as a condition of receiving a federally backed mortgage loan in accordance with the Federal Disaster Protection Act of 1973.

The NFIP is implemented through the Federal Emergency Management Agency. There are over five million flood insurance policies in more than 22,000 participating communities nationwide.

## Ovid-Elsie Area Schools

ELSIE – The regular monthly meeting of the Ovid-Elsie Area Schools Board of Education was held Monday, June 24, 2024. It was an evening of amending the 2023-24 general fund operating budget and the food service operating budget following reviewing the proposed 2024-24 budget for both accounts.

The teachers who completed the probationary status are now Michigan tenured were recognized: Amy Fanning, Nicholas Hufnagel, Johnnie Lewis, Leyna Miller, Michelle McDowell, Hannah Ramirez, and Guy White.

Chris Winters, athletic director, introduced coaches and student athletes and presented an update and highlights of the 2023-24 athletic season. Spring and winter athletes were in attendance and were recognized.

Shawn Pardee, food service director, gave her annual report. State review completed in February and in May the department did very well and will be implementing two action steps. There will be a change in cleaning supplies in all schools and they will be ecofriendly. In addition, there will be improvements made to the refrigeration systems with alerts transmitted to the director's phone. The department hired a chef, Chef Jeff who will be working with the middle school and high school menus to improve options and to encourage additional participation in the program. He has been surveying students to give them a voice on the food that is served. It was noted that he is a dietician and nutritionist.

Followed, by PBIS report and perception reviews presented by Amber Foster. Documents are available on the Ovid-Elsie PBIS website, this is an approach not a system where students and staff are rewarded for positive behavior. Attendance improved by 12%, and suspensions reduced by 38.6% during the 2023-24 school year. Areas that need growth are students treating each other with respect, recognition for good work, and preparing students for future work. The action plan includes, recognizing students and staff, expand PBIS Team for more representation, the district will incorporate character building/life skills, conflict resolution and problem solving in the curriculum. The program is also on the website.

Dr. Wayne Petrolje, superintendent, presented the monthly report. At the end of this calendar year there are three members whose terms expire Eric Jones, David Huff, and Michael Schiffer. Packets are available at the Clinton County Clerk's Office for interested candidates the deadline is July 23, 2024, 4 pm. Next, the superintendent is up for review and evaluation, Tuesday, August 6, 6-9 p training for board members at the CCRESA. Next, he covered the conflict-of-interest policy of the district as it applies to members of the board of education. If a conflict exists the individual must disclose and must recuse themselves and abstain from some votes and issues.

Under the topic of old business, the NEOLA policies were presented for the second reading of 13 policies, one is a new policy. Officials took action to approve the 13 policies as presented.

Under the topic of new business individual and small group contracts were presented for review and approval. It should be noted that two failed to be approved and will be addressed further at the July meeting. A one year contract, 2024-25, was approved for Cody Staley Director of Building and Grounds, beginning July 1, 2024; a three year contract for Shawn Pardee as Director of Food Service was also approved. The one year 2024-25 for Chris Winter Athletic Director and additional human resources responsibilities the job description would be developed thorough out the year, effective July 1 approval failed due to the addition of HR position and the lack of clarity.

Melissa Jones, school nurse, the contract was extended; Morgan Alexander elementary social worker was extended a three-year contract noting that funding is provided by grant funding; Amber Foster, emotional and mental health coach, the contract was extended, as well.

New employees: Halley Lindloff high school mathematics teacher; Shane Tyler building engineer at the high school effective July 1, and Paul Kebler custodian at the middle school effective July 12; Sonya Seidel high school custodian; Jim Borton part-time custodian at the high school effective July 1.

Office assistances made up of three staff members the proposed contract included \$13 per hour and a single health plan, if not covered by another health plan. The assistants work 5-7 hours per day, 180 days per school year this contract will be revisited in July. Discussion focused on offering healthcare to this group of part time employees and no other units.

Officials addressed the revised budget of the 2023-24 general fund operating budget. The committed loan of approximately \$900,000 for the football field improvements was added to the budget, also succession cost of turf in 8-9 years. Ending the year in the black of \$60,000 plus. Next, the 2024-2025 general operating budget was presented and approved, negative deficit of \$28,000, a very close to balanced budget. Eric Jones, thanked the budget committee for a job well done.

Revised and proposed food service budgets were approved. Revised food service operating budget 2023-24, noting food service is in spend down mode. The projected 2024-25 food service operating budget, \$900,000 expenditures which exceeds revenue, still in a spend down mode.

Ovid-Elsie Budget projection appropriations were brought to the board for review and approved. This is internal accounts, currently the district has 75 accounts involving student services, debt services, trust and agency funds and new capital project fund. A revised budget 2023-24 was presented for each and a proposed budget for 2024-25. This is a new report, officials will be updated on a regular basis on these accounts.

Additional compensation recommendation one time \$125 paid through payroll for those employees who received a revised W2 for the 2021-22 school year. Through roll call vote the recommendation passed.

The 2024-25 calendars were approved the k-12 and the Ovid-Elsie Alternative High School calendar. The first day for staff is August 19, and first day for students August 21, 2024. Calendars will be posted on the district

New hires and contracts were approved as were the resignations of Joe Longstreet special education teacher at the middle school; Kevin Somers retiring Operations Manager and Program Director for WOES.

Four master agreements – Food Service, three-year agreement, salary three steps and longevity; Transportation three-year agreement, bus drivers, language changes, salary regular rates, field trip rates, athletic trips and washing and cleaning hourly rates; and Administrative Assistants, language changes, salary seven steps over a twenty-year period and longevity. Custodial Maintenance four-year agreement, language updates salary schedule remains the same 2% minimum-3% maximum increases yearly.

Monthly action was taken to approve the consent agenda excluding expenditures and financial reports included: approval of the minutes of the May 20, 2024 regular meeting and the June 10, 2024 finances committee meeting. In addition, approval of teachers recommended for continued probationary status; the annual MHSAA membership resolution and approval of the FFA annual field trip requests.

Public Comment, Dwight Nash thanked the board and Ovid-Elsie Schools for their support after the untimely death of Gwen Nash, a former OE staff member.

# Update on City of Ovid Project

Letter to Editor

Street paving for those streets where water lines were replaced will start on Tuesday July 9th. Those streets are Main St. from M-21 to Second St. Elm St., and Clinton, Front, Williams, and Pearl, from Main St. to East St. Each street will have the remaining asphalt removed and the base prepared for the new asphalt to be laid down. The entire width of the street will be new asphalt.

Main St Street will have half the street done at a time. This will keep Main St. open while the paving is done on the other side. The repaving and right of way restoration should take about two weeks with the completed streets open as soon as their work is completed.

This is part of replacing 25,500 feet of water mains, originally installed in 1954. Work still to be done is replacing the ancient water mains on west Elm St. and west Clinton, west Front, west Williams, west First, West St, and Fitch St.

To date 120 galvanized water lines from the sidewalk to the home were replaced with new water lines at no cost to the homeowner as part of the project.

Seventy five percent (75%) of the projects cost is a grant from the State with twenty five percent from the water system revenue. The project is scheduled to be completed by August of 2025.

# Opposed to Recent Article

Letter to the Editor:

In a recent issue of the Meridian Weekly (June 23, 2024) there was an article about recent election legislation that passed the Michigan House. The article was "submitted by Denny Schwarze." The headline, "Rep. BeGole: Recount Reforms Pushed by Democrats will Weaken our Election Laws", might well have been written by the author, who as it happens, works for the Republicans in the House of Representatives. It gives the impression that it is written by an independent journalist. It is not.

This is a tactic that has become normalized in sending press releases to small independent newspapers like the Meridian Weekly, where the small staff does not have the resources to verify backgrounds and interests of the authors. If Sen. Sam Singh, a Democrat, was to use a similar approach, wouldn't readers want to know that the John Doe who "submitted" it worked for Singh?

Back to the issue at hand, election reforms dealing with recounts. The House Fiscal Agency itself reported its analysis of the bill, which the author of the article chose to ignore:

*"In 2016, Green Party presidential candidate Jill Stein requested a recount of ballots in Michigan, even though she received approximately 1.07% of the vote in the state.*

*Additionally, two petitions were filed in 2022 requesting state-level recounts of Proposal 2 and*

*Proposal 3 due to alleged voter fraud. Neither petition requested a recount of enough votes to impact the results, and the cost of conducting the recount was reportedly much higher than the collected deposit. The recount of Proposal 2, which was originally approved by over 860,000 votes, resulted in a net change of six "No" votes, and the recount of Proposal 3, which was originally approved by over 580,000 votes, resulted in a net change of 111 "Yes" votes.*

*Although many feel that these recounts were frivolous, they were required to be conducted because the petitions were filed legally. As a result, it has been suggested that the Michigan*

*Election Law be amended to discourage similar requests and to clarify recount procedures."*

In other words, the legislation addresses frivolous and costly recounts that allege fraud without any evidence OR where the vote isn't even close enough to produce a different result. Rep. BeGole and Mr. Schwarze are on the bandwagon of suggesting any defeat of a candidate of their choosing must be due to fraud. If they can convince enough people to believe that our election system is easily manipulated by repeating these unproven claims of fraud, then our democracy, as fragile as it is, is indeed in deep trouble. Be skeptical of what you read.

# Michigan Cherries

Quite the coincidence that the same week Michigan cherries are coming into season a secret cache of preserved cherries and other fruits are discovered at Mt. Vernon. Stored in what appears to be "hooch" jars they could be some of the famous cherry bounce Martha made for George and his journeys. Hopefully this discovery, along with the examination of the fruit and pits, will show more about the cherry trees cultivated at Mt. Vernon over 250 years ago.

Unfortunately, it is very unlikely that anything could be propagated from the pits but efforts will probably be made.

The first tart cherry trees in Michigan were planted in 1852, followed by the first commercial orchard in 1893, and now Michigan ranks #1 in the country for tart cherry production. Over 75% of the nation's tart cherry crop is produced in Michigan. When sweet and tart cherry production figures are combined Michigan ranks #4 in overall production. While the Michigan sweet cherry production numbers are lower, it is hard to argue that any other sweet cherry tastes better.

When one starts eating them it is nearly impossible to stop and who doesn't like sucking the pits clean and then going for spitting distance. Other than served fresh, sweet cherries are also great for easily cooking down for dessert and ice cream toppings or sauces for meat entrees like pheasant breasts and venison steaks. On the other hand, tarts are best served in pies, cobblers, along with other baked goods, not to mention health healing products.

Where to find these little Michigan treasures? Sweet cherries are usually pretty easy to find every summer from late June/early July until about mid August. They are all picked by hand and store very well which allows many weeks of sales at roadside stands and farmers markets. This year expect to pay around \$8- \$9/quart... tarts are a whole different story. Most tarts are either the variety Montmorency or Balaton that are harvested by a shaker machine and immediately cooled in cold water at the orchard. From there they are then shipped in large square metal tanks stacked on flatbed trucks to the processor. Some orchards handpick or offer u-pick options but either way they need to be kept in cool water until they are placed in refrigeration. If you try sourcing from a farmers market don't be surprised if you have to order a week in advance especially if you are looking for a large quantity. Average price for a quart of tarts is usually a dollar or two below the sweet cherry price. When it comes to pitting tart cherries, sometimes a sharp paring knife and your fingers will work better than a cherry pitter!

## Can Pancakes Be Recycled?

Well, maybe not recycled exactly, but the uneaten ones can be composted. Huh?

Every year, on the last Saturday of July, the Laingsburg Business & Community Association (LBCA) hosts the Pancake Breakfast in downtown Laingsburg. The event includes an antique car show, crafts, other fun activities, and the inevitable bags of trash produced by such events. But this year things will be a little different. The Greater Laingsburg Recyclers got the LBCA's permission—and blessing—to make this a “ZERO-WASTE event,” with throw-away utensils, plates and cups being replaced by certified compostable items. These will be combined with left-over food items and all of it will be hauled away by My Green Michigan (an offshoot of Hammond Farms) to be turned into the rich compost used by many of us to enrich our gardens, thereby diverting from the landfill 90 percent or more of the waste!

This event will require the efforts of quite a few volunteers, especially because we are also open for recycling that Saturday. If you're interested in helping us change the waste paradigm, let us know—we'd love to have you join us. Folks can also help by bringing their reusable beverage containers for water, coffee, etc. Help us make this a day to celebrate—and repeat year after year. And we can always use more volunteers for regular collections; the more help we have, the more we can accomplish.

In the meantime, the GLR's recycling facility will be open in July as usual on the 1st and 3rd Tuesdays (July 2 and 16), 4-6 p.m., and 2nd and 4th Saturdays (July 13 and 27), 9 a.m.-1 p.m. See below for info on how to view the long list of materials we accept and how to sort them. Some things are easy, but plastics not so much. Take PET #1's: we accept transparent clear, green and blue bottle and jar types but NOT clamshells (e.g., berry and salad containers) and no #1's that are opaque or shiny. Confusing, right? We don't make the rules, we follow them. If you're new to this, start with one or two items and work your way up, and don't expect to get everything right the first time, particularly because the rules keep changing on us!

Another item worthy of note: Do not bring us or anyone else your old cell phone until you have “wiped” it clean to ensure your safety. Remove the SIM card if it has one (you may be able to reuse it on another phone) along with any SD cards. Do a factory reset; go into settings and sign out of all accounts and erase all personal information. Full instructions (<https://nordvpn.com/blog/how-to-wipe-phone/>) can be found online. The same would be true for other electronic items containing personal information.

### Wolfpack's Woodruff, with LHS Record 54 Points, Makes TV-6 Awards Contingent

LANSING -- Scoring a school-record 54 points in a high school basketball game will get you noticed.

That's exactly what happened to recently-graduated Laingsburg High School alum Zander Woodruff, when it was announced he was the recipient of the WLNS TV-6 Mid-Michigan area Sports High School Award.

The 6 Sports High School Awards were announced on June 20 on a 7 pm broadcast. The event livestreamed on WLNS.COM as the final Team of the Year winner was announced, along with winners in the following categories: Female MVP, Male MVP, Team of the Year, Play of the Year, Coach of the Year, Moment of the Year, Inspiration of the Year, Record Breaking Performance and the Lifetime Achievement Award.

Coach Tim Beebe's Wolfpack boys basketball team was unstoppable during the regular season -- their second-straight undefeated regular season -- but in a game at Freeland the Wolfpack proved themselves against one of the state's best. In the process, senior standout Woodruff broke a school record with an incredible single-game performance.

In one of many season highlights, the Wolfpack, ranked No. 1 in Div. 3, traveled to Freeland to play the Falcons, who came in to play ranked No. 6 in Div. 2. Woodruff was dialed in from start to finish, breaking the school record for points in a game with an astounding 54.

Despite Woodruff's scoring surge, Laingsburg trailed by nine points in the fourth quarter. Head coach Tim Beebe said they changed up their defense and it paid off immediately. Laingsburg closed the game on a 16-0 run to win 72-65.

"That record means a lot," said Woodruff. "Growing up, I've always dreamed of breaking that record, you know? Being the leading scorer here at Laingsburg, you know that means everything to me. As far as personal goals, that's definitely one thing I wanted to set as a freshman. I wasn't on the team my freshman year but I still was able to get it done the last three years."



"That's a really important record," added coach Beebe. "I kept saying the single-game record is just one of those things that if it happens, it happens, but you can't focus on that. But the career scoring record is important because it shows his body of work throughout his three years on varsity, just how much time he's put in and how much he's progressed each year."

In addition, in a 85-43 win over Lansing Christian in early February, Wolfpack scored 43 points that helped the Wolfpack improve to 18-0 at the time. That performance gave him the school record for most career points. The previous record was held by Brandon Woodworth, who scored 1,505 career points from 1994-1997.

Woodruff has announced his commitment to play for Lansing Community College this fall. "First I would like to thank God for giving me the opportunity to play the game I love," he explains. "Next I would like thank my family for pushing me to be a better person every day."

"Finally thank you to all the coaches that have taken their time recruiting me and giving me the opportunity to play at the next level. I am very excited to see what the future holds."

Clark was another of the Wolfpack's excellent versatile players, exceling on offense and defense. Callie totaled 28 points on 11 goals and 6 assists.

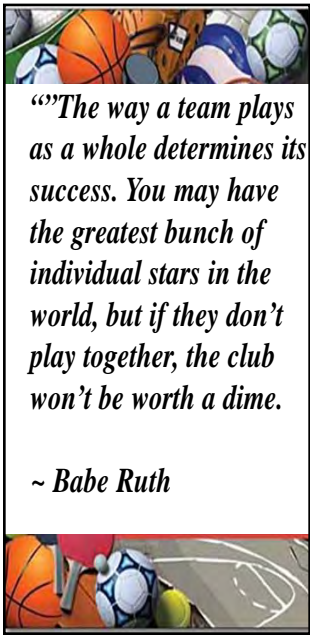
Gutzman, a defensive specialist, still managed 5 goals and 2 assists to total 12 points on the campaign.

Seven LHS Wolfpack Sackers Bring Home Post-Season Plaudits

LAINGSBURG -- The baseball Wolfpack's outstanding 2024 season ended recently with seven of coach Todd Randall's players earning a plethora of post-season awards.

The Wolves capped a 22-13 season in disappointing fashion, falling short of their fourth-straight District championship with a 6-3 loss to Lansing Catholic Central.

The 2023 All-Area Player of the Year, Ty Randall, overcame Tommy John surgery in the off-season to come back with 1st team All League, All District, All Region and 1st Team All State for his 2024 campaign.

Randall owns school records over his 4-year career: batting average in a season (.518), hits in a season (59), hits in a career (189), RBI in a season (47) and RBI in a career (130).

The pitcher/shortstop also owns pitAuching records for wins in a season (11), wins in a career (22), strikeouts in a season (135) strikeouts in a career (296) and ERA in a season. All pitching records were broken in just three seasons on the mound.

Randall's senior season produced the new LHS batting average record, that included 59 hits, 43 RBI, 21 steals and 45 runs scored.

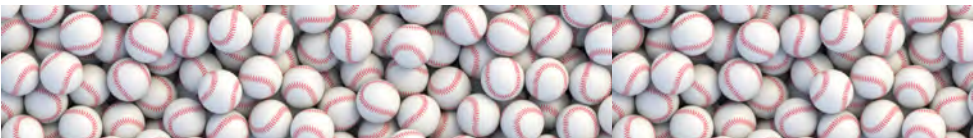
Junior outfielder/pitcher Dom Garcia was awarded 1st team All League, All District, All Region and honorable mention All-State honors in MHSAA Division 3. Garcia hit .387 with 48 hits, 11 doubles, 25 RBI, 21 steals and a team-leading 48 runs scored.

His brother, junior Emillio Garcia, a 1st baseman/pitcher, was named 2nd team All League and All District. Mio batted .345 with 38 hits, 8 doubles, 20 RBI, 20 stolen bases and 45 runs scored on the 2024 campaign.

Third sacker R.J. Garcia was named to the All District team, after batting .404 with 42 hits, four doubles, 28 RBI and 23 runs scored over the course of the '24 season.

Senior catcher Jackson Audretsch earned 2nd team All League and 1st Team All District plaudits. Jack batted .316 with 30 hits, 6 doubles, 20 RBi and 5 runs plated.

Seniors Cam Ballard, an infielder pitcher and Elliott Wilsey, an outfielder, were named to the honorable mention All-CMAC team for the Wolfpack.

## MDHHS Offers Tips to Stay Healthy During Poor Air Quality Days

LANSING, Mich. – As the 2024 North American wildfire season continues and warmer weather increases the risk of higher ozone levels, the Michigan Department of Health and Human Services (MDHHS) is providing Michigan residents steps to take to protect themselves from risks related to poor air quality.

The Air Quality Index (AQI), which can be found on the AirNow website, is a color-coded way for residents to see what the levels of some types of air pollution are in their area. Higher AQI values indicate there is a higher concentration of pollutants in the air and a need for Michiganders to take steps to protect their health.

Residents can also sign up for alerts through the EnviroFlash system. This subscriber system allows you to choose the area you would like to get alerts for, and it will send them directly to your email or through a text message.

Before a wildfire smoke event, MDHHS recommends you:

Familiarize yourself with your forced air HVAC system or your window air conditioning unit. If it has a fresh air intake or outdoor air damper, you will need to close it during a smoke event.

Ensure you have replacement air filters that are rated MERV-13 or higher.

Consider purchasing a portable air cleaner. If you do not have one, you can make a do-it-yourself air filter.

Help neighbors and family members make a plan for possible wildfire smoke.

If you have asthma or other respiratory illnesses, heart disease, diabetes or another health condition that may make you more sensitive to wildfire smoke, talk to your health care provider ahead of time to make a plan.

Children under the age of 18, pregnant people, outdoor workers and older people (age 60+) are also more at risk. Talk to your health care provider ahead of time to make a plan.

Check your local fire risk and read tips from the Michigan Department of Natural Resources for preventing wildfires in Michigan.

During a poor air quality day, take action to protect your health based on the AQI Index. Some recommendations may include:

Reduce the time you are active outdoors.

Consider less intense activities that require less physical exertion.

If ozone levels are unhealthy, schedule outdoor activities for the morning or evening when ozone levels are usually lower.

In the event of wildfire smoke, avoid activities that create more fine particles indoors, including smoking cigarettes; using gas, propane or wood-burning stoves and furnaces; frying or broiling food; and burning candles or incense.

In the event of wildfire smoke, create a clean air room. If you can't stay cool at home, the electricity goes out or too much smoke is still getting in your home, it may be best to seek shelter elsewhere. Call Michigan 211 information on cooling centers.

## USDA Announces Availability of \$25 Million to Help Expand High-Speed Internet Access in Rural Areas

EAST LANSING – U.S. Department of Agriculture Rural Development State Director for Michigan Brandon Fewins today announced \$25 million is now available through the Broadband Technical Assistance (BTA) Program to help local organizations, cooperatives and Tribes expand affordable, high-speed internet projects in rural communities.

"This funding is available on a nation-wide basis, and I urge qualified Michigan applicants to contact USDA," Fewins said. "This is an incredible opportunity to bring high-speed internet into more rural Michigan communities."

The BTA program provides funding to help communities and organizations receive or deliver broadband technical assistance and training that will expand high-speed internet into rural and Tribal communities. This includes providing funding for feasibility studies, network designs, hiring efforts, application development assistance and more.

Under the Technical Assistance Providers category, applicants must propose to deliver broadband technical assistance that will benefit rural communities. Up to \$15 million is available. The minimum award is \$100,000. The maximum is \$1 million.

Under the Technical Assistance Recipients category, applicants must be the recipients of the broadband technical assistance. Up to \$10 million is available. The minimum award is \$50,000. The maximum is \$500,000.

Applications must be submitted electronically using Grants.gov no later than 11:59 p.m. Eastern Time on August 20, 2024.
