## **Ovid Man Creates Alt Ukulele's**

OVID- Last week I met a solemn and extremely tall gentleman holding a 13-inch, 4-string instrument. It was a hand-carved Ukulele. Considering his stature and quiet demeanor, he looked almost like a cartoon character. I could see why his fans and children love him. Dave Raber of Extravagant Ukuleles®, humbly played and sang like a pro. Although he claims not to be that great of a musician. Raber, a 35-year Ovid resident retired from 2nd Chance Wood Co Durand, MI is now following his dream as a "Uku Savant" in design, strumming, and designing original Ukuleles.

Located in the Michigan Livestock office at 110 N. Main, next to Buk's Party Store are some outstanding samples of Raber's retirement passion on display. His talent and stunning handmade instruments are hung on the wall and displayed just as you enter the business. Using refurbished wood, his business has become a successful venture. Some of the wood often has sentimental value to the buyer. Such as a daughter, had one made in honor of her father who owned and operated a Maple Syrup orchard. An original "Alt Ukulele" designed out of wood from her father's Maple tree farm.

As pictured in the photograph, Raber carved a cat eye for the "sound opening" in the shape of a cat eye. The head of the instrument, above the neck of the fretboard, is carved into a cat's head and ears. Many other personalized designs and ideas are available for sale and by special

All of Raber's original ideas are designed out of reclaimed or refurbished wood. One of his favorite Uke's is uniquely carved in the shape of the state of Michigan with the Upper Peninsula as the base for the tuning knobs. Raber has been carving and designing ukuleles

In the interview, Raber explained, "I like to build alternative ukuleles due to the range of creativity in design they offer. More so than with almost any other instrument, ukulele players have accepted and embraced non-standard types that are not built in the usual figure-eight guitar shapes. Raber continued to describe some examples of his craft.

"One of my many interesting requests included a secret compartment with a diamond engagement ring hidden in a Sunflower ukulele." So, if you play the ukulele or want something uniquely different this is the place to shop."

As this interview piqued interest and appreciation of Rabers' outstanding talent, the interview turned into a short Ukulele lesson. Although he does not teach, he gave some basic cord patterns and sent this writer home with one of his old Uke's. After 3 days of practice, a person can plunk out a short song. This inexpensive 4-string instrument is a must for beginning musicians to learn notes, as well as an appreciation for stringed instruments.

## Reps. Filler, Wilson Introduce Plan to Modernize Michigan's Marijuana Laws

State Reps. Graham Filler and Jimmie Wilson, Jr. announced a new plan to modernize Michigan's marijuana laws.

House Bills 5884-85 would merge the regulations for recreational adult-use and medical marijuana into the Michigan Regulation and Taxation of Marihuana Act and repeal the older medical marijuana law.

Township. "By modernizing the regulatory process, we can help businesses cut costs and increase efficiency.

Currently, marijuana licensees in Michigan are regulated under two different state laws: the Medical Marihuana Facilities Licensing Act, created by the Legislature in 2016 to oversee facility regulation and licensing, and the Michigan Regulation and Taxation of Marihuana Act, passed by voters in 2018.

This dual regulatory system has created burdens for businesses as well as the state's Cannabis Regulatory Agency. For example, marijuana licensees must renew both a medical and recreational license annually to grow, process, transport, or sell marijuana.

House Bills 5884-85 will reduce costs for businesses and improve government efficiency by requiring only one license per activity under the Michigan Regulation and Taxation of Marihuana Act. The legislation would not make any changes to the established system for medical marijuana patients and caregivers under the Michigan Medical Marihuana Act of 2008.

'This is about making Michigan an attractive and stable place for marijuana businesses to thrive," said Wilson, D-Ypsilanti. "A single, cohesive regulatory framework will support our growing economy, ensure the safety and quality of marijuana products, and maintain access for medical marijuana patients. This is a forward-thinking approach that positions Michigan as a leader in the industry.

House Bills 5884-85 were referred to the House Regulatory Reform Committee for consideration.

## **Attention: Ovid Township Residents**



## Rep. BeGole: Unemployment Extension will Create More Problems than it Seeks to Solve

State Rep. Brian BeGole opposed a plan that will harm small businesses throughout Michigan and test an already shaky ability to handle fraud at the state level.

House Bill 5827 would increase the maximum number of weeks that an individual may receive unemployment compensation from 20 to 26 weeks beginning on Jan. 1, 2025.

The current 20-week limit was implemented in 2011 due to problems the state's Unemployment Insurance Agency (UIA) was facing at the time, which included debt and high costs. In addition, UIA experienced numerous issues with fraud and its fraud prevention tools during the COVID-19 pandemic when hundreds of thousands of Michigan residents saw their livelihoods shuttered.

A state audit released in December showed that UIA did not do enough to identify and investigate potential fraud as unemployment claims came in and instead paid out over \$245 million to ineligible claimants – including dead people – between Jan. 2020 and Oct. 2022. A separate audit from Deloitte estimated that from March 2020 through Sept. 2021, missteps from UIA cost the state an estimated \$8.5 billion.

"These reviews clearly showed UIA was not effective in administering benefits and their

errors cost job providers, people who needed benefits in a timely fashion, and the state," BeGole said. "Now just a couple years removed from these failures, we're going to heap additional responsibility back onto the agency. This is a misguided plan."

HB 5827 advanced to the Senate for further consideration after being approved by the House along party lines.

## **State Rifle Proposed**

Recently local State Representative Brian BeGole introduced HB 5792 to make the AR-15 the state rifle. There is probably a good chance you may have already heard about this legislative proposal as it has made not only state wide but also national news. You could easily argue, like many others have, that the legislature shouldn't waste time on naming state symbols. Maybe you are opposed to this because the media has tried to make everyone believe that there is no role for the AR-15 in society as it is mistakenly labeled as the choice weapon for mass shootings. Perhaps you believe that the AR-15 and Michigan have no connection and it certainly can't be used for deer hunting in Michigan. The truth is that even if this legislation doesn't see any movement it at least allows some honest discussion about the AR-15 and begins to stop the vilifying of black rifle owners

The AR-15, along with many other similar AR rifles, was designed in the mid-1950's by Eugene Stoner at ArmaLite. Thus the designation AR for ArmaLite Rifle and not assault rifle, a common misconception among liberal media. Yes, the design was modified by Colt and eventually was made into the M-16 rifle. Today's AR-15 rifle has a lot to offer and whether you believe it or not is becoming a very popular choice among firearm owners across Michigan and the country.

Because of its adjustable stock, low recoil, many accessories, and caliber interchangeability with different upper receivers it is a very adaptable rifle for target and recreational shooting, self defense, and of course hunting. Much like veterans returning from WWI and WWII that favored Springfields, Garands and M1 carbines: the AR15 offers the same familiarity for veterans returning home over the last sixty years. Not to mention all the law enforcement retirees who have carried the AR-15 in patrol vehicles and can use the rifle when not on duty or are enjoying retirement.

Also, set aside at least four firearms companies in Michigan manufacturing and selling completed AR-15's. Southern Michigan deer hunters are leading the way in harvest numbers and are using straight wall cartridges like the 350 & 400 Legend along with the 450 Bushmaster which of course all three are easily fired from AR-15 platforms.

The debate over this bill and the AR-15 will continue as well as the education process on how the AR-15 rifle is not evil and can be used in a wide variety of roles. Despite recent efforts of some southeast Michigan journalists to claim that the introduction of this bill resulted in the shooting at the Rochester splash pad, the truth is that there was not a connection with an

AR-15 and that event. The debate and discussion will rage on so fans, supporters, and owners of the AR-15 platform need to stay vigilant and stand their ground.

## "Clinton County Residents **Urged to Oppose Proposal** Allowing Unlimited Dogs, Risking **Unregulated Puppy Mills'**

Letter to the Editor:

We are writing to express our deep concerns regarding the recent proposal by the Clinton County Planning Commission, supported by a county commissioner, which would allow residents to have up to 10 dogs with unlimited puppies under six months old. This proposal marks a significant shift from the original intent of adding conditions and operating standards for the current "private kennel" classification, which covered households with 3 to 10 dogs. Instead, the new proposal aims to eliminate the "private kennel" entirely, pushing the enforcement responsibilities onto individual townships by reclassifying dogs as Class 1 farm animals.

Many townships within the county lack specific nuisance ordinances, and this change could lead to an uncontrolled environment, fostering the creation of additional puppy mills and backyard breeders. This lack of regulation is likely to result in increased noise, odors, and poor health conditions for dogs, creating a negative impact on the quality of life for residents. Additionally, an increase in the dog population will likely lead to a rise in dog bites, increased pressure on already stressed shelters, animal control facilities and other dog-related policing

The original task of setting operating standards and conditions for private kennels was a reasonable and responsible approach, mirroring the practices of other counties in Michigan. It would provide residents with clear guidelines and the ability to address grievances. Owning dogs should be considered a privilege (especially more than 3), and it is essential that residents in surrounding areas maintain their right to peacefully enjoy their properties.

We are requesting that the Planning Commission send the current proposal back and revisit the original task of protecting residents rather than exposing them to potential nuisances and

We urge our fellow residents to attend the public hearing on this proposal, scheduled for July 11 at 6:30 PM at the courthouse. Alternatively, you can share your opinions by emailing PlanningAndZoning@clinton-county.org. Ît is incredibly rare to find townships without laws against dog noise or nuisances, and passing this proposal would result in several such areas, including all of Victor Township.

Let us stand together to ensure responsible pet ownership and protect the well-being of our community.



## **Ovid-Elsie's Workman Commits to** Adrian Bulldog Mat Team



# MDARD Offers Limited Financial Assistance to HPAI-impacted Dairy Farms

LANSING, MI – Today, Michigan Department of Agriculture and Rural Development (MDARD) Director Tim Boring announced immediate financial assistance for Michigan dairy farms impacted by highly pathogenic avian influenza (HPAI) to help advance research on the disease towards aiding farms in recovery. Funding is available for up to 20 farms, up to \$28,000 per farm. This assistance is in addition to funding already available from the United States Department of Agriculture (USDA) to HPAI-impacted dairy farms in Michigan.

Eligible farms must work with MDARD and USDA's Animal and Plant Health Inspection Service's Veterinary Services (APHIS) to complete epidemiological investigations on their farms, participate in dairy herd real-time longitudinal studies research with MDARD and Michigan State University and engage in HPAI A(H5N1) programs related to the Michigan Department of Health and Human Services (MDHHS) if applicable. This funding is made available through MDARD's Emergency Response programming.

"From the beginning of Michigan's outbreak of HPAI in dairy cattle, MDARD has worked closely with our state, federal and industry partners to quickly respond to this virus. We understand our dairy farmers are facing unprecedented challenges, and this action is an important step toward supporting them during this emergency," said MDARD Director Tim Boring. "Our HPAI-impacted farms have been incredibly cooperative in Michigan's One Health approach to combat this disease. The research opportunities through this package will help us advance science in real-time to best develop our continued rapid response."

"Today's bold action shows Michigan continues to be proactive with its HPAI response. I'm glad Michigan dairy farms will be getting much-needed financial support and the ability to participate in real-time research, which will help us combat HPAI in our state moving forward. As this situation continues to evolve, I will remain in regular communication with the Department of Agriculture and Rural Development on how best we can support and protect Michigan farmers and our dairy industry," said State Rep. Reggie Miller, Chairwoman of the House Agriculture Policy Committee (D-Van Buren Township).

MDARD continues to implement a proactive, science-based approach to mitigating the spread of HPAI. Michigan's response has been a one-health approach, working with federal, state and local partners to address both animal and public health concerns rapidly. Three USDA emergency management teams have been on the ground assisting MDARD in day-to-day responses at all impacted poultry facilities statewide. An epidemiological team from USDA is also deployed to further assist in tracing and testing within dairy herds to be able to provide real-time information.

Director Boring took proactive actions by signing an "Determination of Extraordinary Emergency" order May 1, to further protect Michigan's poultry and livestock industries from the ongoing threat of HPAI. Michigan's order enhances USDA's federal order, which was issued April 24.

As part of the disease response, MDARD is working with herd veterinarians to monitor the health of the animals and conduct trace investigations. Additionally, MDARD and various federal, state, and local partners continue to offer personal protective equipment at the request of dairy operations. The department continues diligently working with local, state, and federal partners to quickly respond to reports of HPAI to mitigate the spread of the disease and provide outreach.


