## Clinton County to Hold Fall Waterfoul Hunt at Clinton Lakes County Park Fall 2024

The objective for public hunting of waterfowl in Clinton Lakes County Park is to manage nuisance geese. While geese are a special focus of the hunting program, successful applicants may hunt any waterfowl species, subject only to current federal and state game laws. An equally important objective is to provide area residents with a recreational opportunity to responsibly harvest an abundant source of nutritious food.

The local goose population is found in area parks year-round. Goose droppings deposited on swimming beaches, picnic areas, trails and other areas is unpleasant to view and recreate around. Droppings carried by rainwater into lakes and streams increases the bacteria found in the water which can cause waterborne illness in humans. Once the presence of bacteria reaches unhealthy levels, swimming beaches must be closed to the public.

The year-round resident goose population found in Clinton Lakes and Francis Motz County Parks is estimated at several hundred. In the fall, the population swells to one-thousand or more birds when migratory flocks join the local birds. Unmanaged, the goose population will continue to grow making an existing bad situation worse. The Parks and Green Space Commission will accept applications for a managed waterfowl hunt on ten (10) days in 2024.

The deadline for the drawing is Sunday, August 25, 2024, at 11:59pm. The drawing will be conducted on Wednesday, August 28, 2024, to select seven (7) successful applicants for each of the ten (10) days when waterfowl hunting will be allowed in Clinton Lakes Park. Successful applicants will be provided a Hunting Permit for their approved date/s. Each permit holder may be accompanied by up to two guest hunters, as further defined in the conditions page of the permit.

The location of the 2024 waterfowl hunt is Clinton Lakes County Park, 4665 N. DeWitt Road, St. Johns, MI 48879. The 272-acre park was acquired by Clinton County in November 2013. The park contains a 90-acre lake and a 12-acre lake with a combined shoreline of approximately three miles. Hunting is an important way to manage the flock by providing area residents with an enjoyable outdoor recreation activity and food for the family table, while dispersing geese and other waterfowl across the many other water bodies and wetlands in the area."

### Clinton County Residents' Voices Delay Proposal Allowing Unlimited Dogs

Letter to the Editor,

We are writing to provide an important update regarding the recent proposal by the Clinton County Planning Commission, which would allow residents to have up to 10 dogs with unlimited puppies under six months old. This proposal represents a significant shift from the original intent of adding conditions and operating standards for the current "private kennel" classification. The new proposal aims to eliminate the "private kennel" entirely, pushing the enforcement responsibilities onto individual townships by reclassifying dogs as Class 1 farm animals

Thanks to the overwhelming support from concerned residents, other concerned townships and Michigan Pet Alliance, the Planning Commission chose not to address the amendment as planned at the meeting on July 11, 2024. Instead, they have stated their intention to address it later. This decision is a testament to the power of community voices coming together to protect the well-being of our neighborhoods.

Many townships within the county lack specific nuisance ordinances, and this change could lead to an uncontrolled environment, fostering the creation of additional puppy mills and backyard breeders. This lack of regulation is likely to result in increased noise, odors, and poor health conditions for dogs, creating a negative impact on the quality of life for residents. Additionally, an increase in the dog population will likely lead to a rise in dog bites, increased pressure on already stressed shelters, animal control facilities, and other dog-related policing issues.

The original task of setting operating standards and conditions for private kennels was a reasonable and responsible approach, mirroring the practices of other counties in Michigan. It would provide residents with clear guidelines and the ability to address grievances. Owning dogs should be considered a privilege, especially more than three, and it is essential that residents in surrounding areas maintain their right to peacefully enjoy their properties.

We urge our fellow residents to remain vigilant and ready to voice their concerns when this proposal is revisited. Let us continue to stand together to ensure responsible pet ownership and protect the well-being of our community.



### Wolfpack Senior Bila Caps Historic Softball Career as Area Player of the Year

LAINGSBURG — Most high school players would covet having their name attached to a state softball individual record.

Wolfpack senior Ashley Bila capped her LHS career holding down national records.

Advantage, Bila. Now it's on to a Central Michigan University scholarship for the slickfielding shortstop.

Ashley is now the national record holder for runs scored in a career, finishing the 2024 season with 88 runs scored — 28 more than her closest competitor — giving her 332 for her 4-year career. She also used her plus-plus speed to lead the area in steals with 53. Her 13 doubles and nine triples helped her slug .938 (which combined with her OBP for a 1.676 OPS). She ranks as the No. 1 run-scorer according to the National Federation of State High School Associations.

Bila's talents helped propel Laingsburg to an impressive 33-4 record and achieve the No. 1 spot in the MHSAA Division 3 Rankings by May 7, but the Wolfpack were bested by eventual district champion Lansing Catholic in the semifinals.

Already a Michigan High School Softball Coaches Association Division 3 All-Star, Bila's resume made her a no-brainer for All-Area Player of the Year, as named annually by the Owosso Argus-Press.

Bila was a winning machine over her four years at Laingsburg, contributing to 127 victories and just 24 losses. Laingsburg's career hit leader batted .619/.738/.938 in her senior season, with 60 hits, 13 doubles, nine triples, 53 stolen bases and 88 runs scored.

She wasn't the only player to win All-Area post-season honors, however. Laingsburg's Addyson Buchin, Savvy Stirm, Bella Latuszek and Harper Strouse, and Ovid-Elsie's Maddisyn Miller and Mercedes Grieder earned local plaudits. Grieder will be returning for her junior season to a strong Marauder team.


Buchin, starting 24 games for the Wolfpack and appearing in 28, Buchin was the area leader in wins with 22 and one of just two area pitchers to reach the 20 mark. Handling the thirdhighest innings total in the area at 135.2, Buchin topped all area pitchers in ERA at 1.34 and WHIP at 1.017. Her 169 strikeouts were third-most in the area.

In addition to her work in the circle, Buchin was one of the area's most productive power bats, hitting four home runs and driving in 64 runs, both of which were second-best in the area. Fifth in the area in batting average and third in slugging percentage, Buchin slashed .534/.556/.853 and finished second in the area in hits with 62 and third in doubles with 19.

Only a sophomore, Wolfpack first-sacker Stirm hit in the 2-spot in the Wolfpack order. Going exactly .500 (55-110) at the dish — the eighth-best batting average in the area — Stirm scored 60 runs and knocked in 50.

Posting the sixth-best batting average in the area at .514 (56-109), Wolf second baseman Latuszek was also top-10 in the area in hits, runs scored with 52 and RBI with 54.

Miller was the Marauders' power-hitting backstop and the cleanup hitter, tied for fifth in the area in home runs with three and slugged .687 — the ninth-best mark in the area. Overall, she slashed .434/.515/.687 in her senior year, good for an OPS of 1.202.









### All-Area Baseball Honorees for 2024 OWOSSO -- Local All-Staters Ty Randall and Jake Bowen slugged their way to the top of

the Shiawassee All-Area Baseball Team for 2024.

The prestigious honor team is named annually by the Owosso Argus-Press. O-E's Corbyn Janes, and Laingsburg's Dom Garcia, Cam Ballard, RJ Garcia, Mo Garcia and Elliott Wilsey were also area standout sackers named to the honor squad.

Chesaning pitcher / shortstop Brady Sager took over Player of the Year honors, after Randall captured that plaudit in 2023.

Bowen, Ovid-Elsie's slugging catcher, reached base in better than 68% of his plate appearances, Bowen led the area in on-base percentage and was fifth in batting average at .486. A backstop with pop, Bowen was one of four area players to hit two home runs and one of only six to record 10 doubles.

Janes, firing two-thirds of his pitches for strikes, Janes went a tough-luck 5-4 for the Marauders. He finished his junior campaign with a K/BB ratio of 71/20. Holding the opposition to a .243 batting average, Janes worked the second-most innings in the area at 55 2/3 and had the seventh-best ERA at 2.64.

Randall, the 2023 Area Baseball Player of the Year after setting numerous Wolfpack records on the mound and with the bat, largely focused on hitting this year as he rehabbed from Tommy John surgery, and this resulted in him leading the area with a .518 batting average. A disciplined hitter with power to all fields, the Grand Valley State Lakers signee racked up an area-best 59 hits, nine more than the next closest player, tied for the area lead with four triples, had the area's third-best OPS at 1.303 and was only of only six area players to record 10 doubles

Dom Garcia concluded his season with a 4 for 4 showing in the district championship game loss to Lansing Catholic on June 1, the left-handed-hitting Garcia was the leadoff man for the Wolfpack and helped provide traffic on the bases for Ty Randall and Elliott Wilsey in the No. 3 and 4 spots in the Laingsburg lineup. Hitting .387 (48-124), he scored the second-most runs in the area at 48, was third in hits and third in doubles with 11.

Mo Garcia saw time on the mound in an area-leading 16 games, Garcia was a lights-out presence out of the Wolfpack bullpen. Ten of his appearances came in relief, and he held opposing hitters to a .215 average. Totaling 46 2/3 innings of work and finishing with a 3-3 record, Garcia's 1.393 WHIP was ninth-best in the area and his 43 strikeouts were just outside the top 10. After holding down the No. 2 spot in the Wolfpack batting order, right after Dom Garcia and before Randall, Emilio Garcia put together a very strong batting season for LHS, accumulating a slash line of .345/.471/.418. Fourth in the area with 45 runs scored, he was also seventh in doubles with eight and 10th with his 38 hits.

RJ Garcia, becoming the third Garcia from Laingsburg to appear on the 2024 All-Area Team, hit in the No. 5 spot for the Wolfpack and rounded out a terrific trio of three consecutive lefthanded hitters in the Laingsburg order following Randall and Elliott Wilsey. Slashing .404/.496/.442, Garcia's 42 hits were eighth-most in the area and he was ninth in RBI with 28.

Wilsey, occupying the cleanup spot in a talented Wolfpack lineup and hitting right behind standout classmate Ty Randall, made the most of his opportunities to drive in the traffic on the bases ahead of him, finishing fourth in the area with 37 RBI. Putting together a .271/.368/.381 slash line, Wilsey showed special power in his left-handed swing, as he was one of only four area players to hit multiple home runs.

Senior versatile P/IF Ballard was a three-year starter for coach Todd Randall's Wolfpack, adding honorable mention All-CMAC honors to his 2024 accomplishments.

#### Madaloni, Hart, Kline, Bancroft Lead Local Golfers on All-Area Team




