Elsie Village Council Will Seek Forensic Audit

ELSIE – The regular meeting of the Elsie Village Council was held Tuesday, October 8, 2024. Officials addressed a variety of issues to a full house including setting the Halloween Trick Treating hours, 6pm-7:30pm.

Officials took action to table the establishing of a Brownfield Authority until the November 2024 regular meeting. There is new information regarding additional grant possibilities. Also, officials tabled a decision on the generator requested by the Elsie Library Board.

Diane Jones, MML Insurance representative, presented information on the workman's compensation fund and the MML liability and property pool programs. The pros and cons were presented for officials to consider. It was noted that the Village has been a member since 1982, one of the municipalities who have participated since the onset of the program. Two cost summaries for officials to consider prior to the renewal date of April 1 of each year. The policy does not cover a forensic audit that falls on the entity. Jones noted that a larger deductible was selected for a savings of \$200 April 1, 2024. A question-and-answer opportunity followed.

There is access to village financial account issues that need to be addressed by Thomas Frink, village president, due to the resignation of Shane Grinnell. Officials took formal action to remove former employees from all documents and financial accounts.

At the next meeting there will be a public hearing prior to the November and December meetings at 6:45, regarding the Consumers Energy Resolution. This is an action that is taken periodically.

taken periodically.

Police Chief Destinee Bryce, presented the September 2024 police department report.

The Department conducted five traffic stops. Complaints increased during the month with a total of sixty-two calls that included domestic assaults, civil disputes, and 911 hangups.

September was a month of training for the department. The Department continued MCOLES CPE mandated training – taser recertification, police civil liability, family law and trouble legal aspects and election law updates. The training was provided by the Clinton Area Law Enforcement Core training program that was implemented earlier this year.

In addition, Chief Bryce met with the Clinton County Health Department regrading opioid addiction and task force administration division with suggestions regarding the increase of crimes resulting in addition.

Finally, the department received a renewal if the BVP Grant for bullet proof vests which provides 50% of the funding.

Bryce presented the village manager's report. A Downtown Development Association re-establishment was discussed and a possible village planning commission. Tim Fare, from Clinton Catalyst was present to discuss both suggestions. He noted that he is discussing with the Clinton County Commission regarding a land bank.

October 18 there will be training for the manager and clerk with BS&A the financial and accounting software company. In addition, looking at the bank reconciliations which have not been completed in house since 2018.

The Village office is in a sate of transition since the resignation of the former village manager. It was noted that a reimbursement of \$2,520.52 was made to the Elsie Area Fire Department for Spectrum services of the village, officials approved the action. It was recommended that a forensic audit be conducted of all financial books, the cost will be approximately \$15,000. It was requested that the action be taken before Bryce takes full control of the office. The request was approved. A letter of engagement was presented to secure the services of Maner and Costerisan.

Chris Ormes, Department of Public Works, opened his report by addressing the controversial building addressed at the September meeting. The cost of the repair is \$4,500 plus new doors. Officials approved the request. Maintenance of the water system is ongoing and is looking to the future to address concerns before they become an issue. Preparing for a discharge of the lagoons. Noting that two values need to be considered in the next fiscal budget.

Jason Freeman, presented a Fire Board update noting that this is a time of rebuilding relationships.

Annual action was taken to set the trick-or-treating hours. Halloween hours are 6p-7:30p followed by a party at the Elsie Area Fire Department base.

Jayna Passmore voiced concern about the walking trail at the Village Park and the lack

Jayna Passmore voiced concern about the walking trail at the Village Park and the lack of maintenance. There are cracks and safety concerns. The public is willing to help with park improvements.

Rick Zemla, Fairfield Township Supervisor, thanked the council for the action they are taking and the forensic audit.

Monthly action was taken to approve the meeting agenda with the addition under committee fire board update, and brownfield redevelopment authority and the managers request for a forensic audit. The minutes of the September 10, 2024 regular meeting and the closed session minutes of September 30, 2024 and the financial reports were approved. Expenditures including payroll totaling \$102,892.52 were approved.

Inspired Women Network Offers Free Domestic Violence Awareness and Self-Defense Event

Owosso — Inspired Women Network is hosting Safety for Sisters and Staff Oct. 21 in support of Domestic Violence Awareness Month. It will run from 5:30 to 7:30 p.m. at the Shiawassee Family YMCA, 515 W. Main St., Owosso.

This free event is in collaboration with SafeCenter, Voices for Children, Shiawassee Family YMCA and Owosso Public Safety.

SafeCenter is a shelter for those recovering from domestic violence and sexual assault. Its CEO, Hannah Gottschalk, will share about warning signs and what human resources and other staff members can do if they are concerned about a fellow employee's safety. Located in Owosso and St. Johns, SafeCenter's mission is "Empower. Advocate. Educate. Prevent." It serves all gender identities who have experienced intimate partner domestic violence or sexual assault.

Officer Tim Applegate, defensive tactics instructor with Owosso Public Safety, will also be teaching a basic self-defense class that is open to all. Together with SafeCenter and OPS, Inspired Women Network's goal is to bring awareness to a vitally important, sometimes life-and-death issue in our society. The group believes there is value in learning not only about personal safety, but how to identify and address the domestic violence coworkers, friends or family may be facing.

"What women in particular suffer can be invisible to those around them; they suffer in silence out of fear, shame or guilt," explains Gottschalk. "We have to keep our eyes open for ways we can keep our loved ones and colleagues safe."

Applegate agrees and recognizes an opportunity to empower women with ways to protect themselves.

"Knowing even basic self-defense moves can help fend off violent attacks. Hopefully I'll help people feel safer and more emboldened to start to break the cycle of abuse. These tactics can also be used with any kind of attack, whether in a domestic violence or other personal safety situation."

IWN is the women's leadership program of the Shiawassee Regional Chamber of Commerce. It was born out of a desire by women in the Shiawassee County region to have social, networking and professional development opportunities. Inspired Women Network is generously underwritten in part by an anonymous donor.

acle right then and there. To dazzle them before their eyes.

Instead, Jesus points them back to Scripture (Jonah who died in a huge marine animal and was brought back to life) and connects that to His future death and resurrection. Which will also in time be recorded in Scripture.

Today some are saying the same thing. It's amazing how little changes in 2,000 years.

They say that they will believe in God if He will show them a miracle. Or if He will make a personal appearance to them. Just give me a sign and I'll believe.

Scripture actually has a rebuttal to this claim and that rebuttal is Scripture itself. That is, the Bible says that if people won't believe what is written in it, then people won't believe no matter what kind of sign they are given.

For example, in Luke chapter 16 there is recorded a conversation between someone who has died and is suffering apart from God and Abraham, who is in Heaven.

The person in torment at one point said, "...send Lazarus to my family, 28 for I have five brothers. Let him warn them, so that they will not also come to this place of torment.'

29 "Abraham replied, 'They have Moses and the Prophets; let them listen to them.'

30 "No, father Abraham,' he said, 'but if someone from the dead goes to them, they will

Luke 16:27-31

Dear Sarah, Good Question! Your vote counts and so does every vote. Getting out to vote on November 5th vote or with an absentee mail in ballot will be counted. Voting is the American process of demonstrating our freedom to choose our like-minded leaders.

In answer to your question, for the need, and a definition of an electoral vote is a process of checks and balances. The electoral college is made up of 538 trusted voters who cast their vote in accordance with the popular vote of their individual state. Electoral votes are represented by 2 senators from each state and Representatives in accordance with the State's population, who take an oath to vote along with their state's popular votes. Our forefathers, who wrote the Constitution to include the voting process to be fair. They felt it was too easy for voters to be manipulated in the larger populated areas. There is much controversy if it is still necessary but that would require a Constitutional change.

The candidate who receives the most votes wins the electoral votes for that state. Campaigning in larger states to gain more electoral votes is a popular strategy used by candidates. The winner of the Electoral College vote is designed to vote for the people and the candidates according to their states most popular vote. In 3 times of our history, it has happened that the electoral vote was not in line with the popular vote. To win the Presidency they must receive 272 electoral votes. The electoral college is not a place, it is made up of a group of leaders represented by 2 Senators from every state and Congressional representatives based on the number of voters in each of the states. Electoral votes are counted on Jan 6, 2025 and the President and Vice President elect will be official on Inauguration Day is January 20, 2025.

The US passed the 19th Amendment in 1920. Over 100 years ago. It read: "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex." Get out and Vote to honor the 124th anniversary of woman suffrage. They marched, chanted, and met with representatives of the states to get this passed so women can vote.

The Bath Bees may not be in the league in the league title chase, but they solidified their case for the MHSAA playoffs with a tougher-than-it sounds, 50-25 victory over neighboring Laingsburg here October 4, at the LHS Sports Complex.

The first half was a tussle, the Fightin' Bees clutching a razor-thin 20-18 lead.

He broke through for a 66-yard TD spring to get the Wolfpack within 20-15. Then, before the half ended, Nidefski boomed an impressive 42-yard field goal and it was nearly knotted up at 20-18.

Tossing aside its successful passing attack, the Fighting Bees launched their ground assault in the third quarter. It was effective. Bath took back control on rushing TDs of 44 and 38 yards, and added both PAT running conversions, to forge a 36-18 advantage.

Then came the special teams' highlights. Leandro Dolega-Caceres put the Wolves back on the board with a 100-yard kick-off return. Nidefski's PAT made it 36-26. But on the next kick-off, Bath returned the favor with a 100-yard scoring sprint of its own. Another two-point conversion tallied the score at 44-25 to end the third quarter.

The Bees completed the scoring on a 15-yard rush in the final period, final score 50-25.

Rowley ran wild on the Bees with 174 yards on 20 carries, including the two TDs. Dylan Witgen added 49 yards on 14 rusheds. Rowley hit 50% of his 6 passes, but for just 9 yards. Collin Logghe led the Wolfpack in receiving.

Dakota Allen, Caceres, Logan Holm, Logghe, Josiah Hawes, Tucker Dunn, Witgen, Dylan Koenig, and Harvey Montgomery were all in on tackles for the Wolpack defense.
