### Ovid-Elsie Area Schools

ELSIE – The regular monthly meeting of the Ovid-Elsie Area Schools Board of Education was held Monday, December 16, 2024. The highlight of the evening was recognizing the fall fund raising activities of the athletic teams and comments from staff and the public regarding the direction of the district and the board of education.

Kevin Nash, board member, opened the meeting with the following action. With regrets he moved that due to accusations of possible ethics violations two board members should be prohibited from voting and participating in the discussion on specific matters. The item was supported by Mary Thompson. He further commented that a review needs to made regarding Eric Jones and Dr. David Huff, held at a special meeting the first week of January with Mr. Josh Miller temporarily as board chair. The action appeared to leave the board in a state of confusion. The motion failed with a three yes; three no, and one abstention.

After monthly action items were addressed in the consent agenda the floor was opened for communication from Ovid-Elsie personnel. Michelle Moore, athletic administrative assistant, commented that the fear of instability is having an impact on staff. Athletic directors come and go, it is important to retain and support good staff specifically for the current athletic director Chris Winter. She further commented that the board should approve the administrative contracts this evening.

Danas Blank, English teacher, first extended a thank-you to Eric Jones and Mike Schieffer for their service and to Dr. Petroelje. Blank indicated that it is time for change and we need you to mentor that change. The high school is not a toxic work environment, we have an amazing team of educators and para professionals. Worried about the possible loss of Chris Winters, athletic director and Dan Davenport, we are hemorrhaging and need these quality people. She has indicated that the negativity has got to stop, we need stability. She stated that, "Once a Marauder, always a Marauder."

Melissa Jones, district nurse, community member and parent, commented that the lack of kindness and how we treat one another needs to change, we can do better. "Choose kindness." We are the models that set the tone for the community. Misinformation and accusations need to be addressed. "Be kind and be thoughtful, build up rather than tear down."

Mandy Fruchey, elementary staff, reminded board members that in May 2023 she addressed the board regarding concerns about the district – asked to eliminate division and negativity, she is "Marauder Proud." We need to go back to "students first," it is lost. Ethics, targeting and accusations can be hurtful and are counterproductive. In the last two years Ovid-Elsie has lost 22 teachers, 2 superintendents, 2 athletic directors, one building and grounds director, one transportation director, and one curriculum director, just to name a few. It should be noted that since the December 16 meeting the district has lost a third AD, with the resignation of Chris Winters. Take the negative energy and ask educators what you can do to help in a positive way. "We are failing our kids."

Travis Long, teacher and coach, parent, commented that we need to do our best to retain the staff, Chris Winters needs to be retained, he is the best for our kids. We need to retain

Next, the public had the opportunity to address the board. Sue Kadelk - thanked Eric Jones and Mike Schiffer for their commitment to Ovid-Elsie Area Schools. Furthering her comments by stating that members should consider their votes carefully. She was surprised that the December agenda is a pretty hefty compared to the last few years. Questioned the agenda. Supports change and a search for a new superintendent.

Charlie Green, resident and grandparent, He commented that he visits the fourth-grade classroom, a student was asked how he feels the response, "Depressed." Teaching is a complex challenge. Judge by actions, not my intentions. Just a thought. He stressed his support for past, and present board members.

Chris Winters, athletic director, introduced members of the Ovid-Elsie Marauder Athletic Council, students in a leadership role. Olivia Coon, addressed the board of education. Fund raising events focused on Breast Cancer and the Susan G. Colmen Foundation. The athletes raised over \$2,000. A check was presented to Ashley Dire representing the the Susan G. Coleman Cancer Foundation, huge thank-you.

Dr. Wayne Petroelje commented on the student leadership and the great work they do. A thank-you was presented to retiring board members Mike Schiffer and Eric Jones and gifts presented from Ovid-Elsie Area Schools.

Officials once again addressed the NEOLA Policies this was the second reading of the policies - two portions, A - eleven having to do with the finances; B -six policies a variety of

topics, with the next step to approve the policies and presented. Approved as presented.

New Business items started with employee retirement of Heather Cunningham, Leonard

Elementary School teacher, effective January 2025. Accepted with regrets.

Contracts were presented for board approval. – Katlin Kusnier hired as the business office specialists effective December 9, 2024. Officials approved the recommendation and extended the contract. Long term sub position to Linda Snelling for the remainder of the school year filing the position vacated by Mrs. Cunningham, approved. Teaching position - Robert "Cory" Gavenda as the high school building trades teacher, effective January 21, 2024, also

### **OE Area Schools...cont' from Front**

Individual contracts – three-year contract offered to Jarred Hyzer technology; Cody Staley – director building and grounds; Carla Perrin – transportation director; Crystal Loynes administrative assistant to the superintendent, Melissa Jones, school nurse; and Shawn Pardee, director of food service; all effective July 1, 2025

Human Resources & Business Management Position – to be posted immediately, which also includes human resources.

With the resignation of the curriculum director, it was recommended that Jara Latz receive a \$500 monthly stipend to pick-up the slake. This will be effective November 2024. Noting that there is no conflict with the teacher's master agreement. Petroelje noted that thirteen applicants have been received for the curriculum development position and that the team will interview the top six.

Ovid-Elsie Area Schools received a request form Laingsburg Community Schools to enter into a service agreement with the transportation department to provide maintenance services for their fleet of fifteen buses. Currently OE provides this service for Ashley Community Schools fleet. The OE mechanics feel they can handle the additional service agreement. The request was approved.

The organizational meeting of the Ovid-Elsie Board of Education is slated for January 20, 2025, 6:30 pm.

Finally, individual school members provided comments. Micheal Schiffer expressed a sincere thank-you to the public for letting him represent and assist with the growth of Ovid-Elsie Area Schools. And offering the following advice, please try to work together for the kids. "It has been an honor to have set here, 21 years."

Eric Jones read a statement – he chooses kindness and peace. It is an honor. Six-years, every decision I have made is putting for kids first. He voiced his concerned about the attitude of the new board members focusing on stakeholders, not the children. Focus on the educators and children and not work a specific agenda. "Students first." He further resigned and stepped down for the last fifteen days of his term, and passed the gavel on to Mr. Josh Miller.

Monthly action was taken to approve the consent agenda. The action included approval of the meeting agenda, the minutes of the November 18, 2024 regular meeting; approval of the minutes of the special board meeting, December 11, 2024; payment of expenditures and financial reports for October 2024 and approval of the Snow Sculpting field trip.

### Dawn D. Levey Appointed by the Governor of the Michigan Wildlife Council

Dawn Levey, of Elsie, retired in 2022 after teaching in an alternative program for thirty-two years. The Wildlife Council was created to educate about the importance of Wildlife conservation and the role of hunters and anglers in preserving Michigan's great outdoor heritage for future generations.

### "The Joyful Alley-picker"

"The Kingdom of God is like a treasure hidden in a field, which a man found and hid; and from joy over it he goes and sells all that he has, and buys that field (Matthew 13:44-46).'

I think trash is cool. As a kid in Detroit we used to go alley-picking all the time. We joyfully followed our sacred creed, "One man's trash is another man's treasure." Why root in rubbish? Because there's always a chance, a thrill, that we'd find some treasure!

In 1991, a man spent four dollars at a flea market on an ugly picture (for the frame). He dismantled it, found an envelope, and folded inside was a Declaration of Independence printed by John Dunlap on July 4, 1776 (only 7 of the 25 still exist). It had wet ink smudges at the folds, but those blemishes added value as it was printed that very day.

Its value is over 8 million, but value is really what one is willing to pay (last month a banana duct-taped to a picture frame sold for 6.2 million). I guess, "Beauty is in the eye of the banana-beholder," but Jesus knew a priceless work of art when He saw it, and that is people. Based on what He paid, in blood, you're a very special treasure (John 3:1-16).

In the Kingdom simile, Jesus is the man, the field is the world, and you are the treasure (or "the pearl" in verses 45-46). You may not feel like treasure, maybe even wrecked your life, but God sees a pearl; so dear He "sells all that He has" just to buy you back. "For the joy set before Him He endured the cross (Hebrews 12:2)." You're His thrill!

Why joyfully love you, happily give up all, and die on a Roman cross with a smile? Because His opinion of you is what alley-picker's see, the true worth...not the mess. We look for the Dunlap behind the ugly image. The world sees four dollars, but Jesus sees you as 8 million, and knows He can change you into a living Rembrandt, if you agree.

Agree? In Luke 19, Jesus told another story about His Kingdom, of ownership and authority, but the nobleman (Jesus) was rejected, "We do not want this man to reign over us," the citizens said. Whenever something broke, my Dad would say, "I can fix that." Our Father in Heaven says the same, "I can fix you." But you have to bring what's broken to Him, let Him dismantle the frame, fix you, and reign as your

My simile is the unwanted toys on the Island of Misfit Toys in the Rudolph the Red-nosed Reindeer cartoon, except that I see it as an Easter story. What's more unwanted than a corpse? We bury them and burn them. They stink, but a tomb doesn't stink if it's empty! That's what Jesus does — He rescues us, loves us, and changes death to pearls.

The largest pearl in the world is the Giga Pearl. It weighs over 60 pounds. The irony is that the Giga looks like a big white blob, not a pearl; a beach rock we'd walk past, but that misfit blob, in the eye of the right beholder, is worth 200 million today. An ecstatic Jesus sees you as His Giga, except that you are even more precious (1 Peter 1:18-19).

It's simple faith (John 1:12). Admit your sin, that you've trashed your life, and let Him alley-pick you up. Just bend your knee to the risen Christmas King "where meek souls will receive Him still, the dear Christ enters in." Christmas means there is always a chance, and Easter means your smudges are on a "pearl of great value" that Jesus wants.


