Officers Ashbaugh, Wright, Griffin, and Dible rushed to assist, ensuring both


the newborn and her mother were safe. Meghan's husband, Jacob, wrapped the two in a blanket until emergency department team members arrived and transported them inside for further care.

passionate care.



#### **Choose Kindness**

Letter to the Editor:

My name is Melissa Jones. I am a District Nurse, a community member, and a parent who cares deeply about our schools, our students, and our community. The actions we take—both in public and private—matter greatly. They shape the environment we create for our children and set the tone for the future of our community. I believe we must lead with love, kindness, and a commitment to doing what is right—not just in our words, but in every aspect of our lives.

Today, I feel compelled to address an issue affecting our community: the way we treat one another, especially when we disagree. Words and actions have immense power, and how we choose to use them reflects who we are. As a nurse, I see first-hand the impact of hurt—both emotional and physical—on children and families. As Matthew 5:9 reminds us, "Blessed are the peacemakers, for they shall be called children of God."

We all face battles that others may never see. But those struggles don't give us permission to hurt others or make accusations. Instead, they call on us to show compassion, to listen, and to work together for the greater good. Imagine what we can accomplish if we put aside selfish needs and focus on building each other up. The possibilities are endless.

So, I challenge our community today: Be kind. Be thoughtful. Be someone who lifts others instead of tearing them down. Let's make our schools and our neighborhoods places where everyone feels safe and respected. Kindness goes a long way, and it's the foundation of a strong, supportive community. Together, we can create a better future by embracing love and rejecting division. Let's lead with our hearts and be the example our children deserve to see.

Remember Alice in Wonderland when the Cheshire cat

told her, "If you knew where you were going, you would know when you got there." He also told her, "If you don't know where you are going, every road will take you there." Think about direction...there is a process: set your goal with a realistic date and a realistic plan to accomplish your goal.

Next, make achievable goals with a plan of action. Write it down! Instead of a resolution to lose weight, set a goal to lose 4 pounds a month, that is only 1 pound per week and 52 pounds for a year. Sounds achievable. Right? Check with your doctor if you need a specific plan or accommodations, but definitely - walking for 15 minutes 3 times a week could help achieve the weight loss goals. I challenge you to increase your time by a few minutes every week. I have challenged myself... I will get back with you in 6 months. My goal is to lose 1 pound a week by June 10, 2025; 26 weeks away. This scares me a little, but I think I can do it... how about you?

Making positive changes can be a challenge but recogniz-

Making positive changes can be a challenge but recognizing changes will improve your confidence and perception of your accomplishments. Many of us fail to reach our dreams or goals, due to our misguided perceptions and self-negativity. I must confess, I am guilty of what I coined as a "procrastination-perfectionisms." We need to accept that it' ok not to be perfect and it's ok to succeed. Get rid of the feeling that "this could be better" or that "it's not good enough."

Set goals in writing then when you accomplish them highlight with your favorite color or a big check mark. View it daily, post where you can see them. Try daily, weekly, and monthly goals. Make it a to-do list: ie. walking 15 minutes a day, an act of kindness every day, keep a box in the closet for goodwill, purge weekly. On the 1st when I pay my bills, list all the birthday dates to remember. It can cost less than a dollar to bring someone joy on their birthday.

Finally, NEVER GIVE UP! Keep trying. Change your goals or add new ones as needed. Be realistic about your goals and what you want. Did I say write them down? I would say good luck in 2025 but it just takes self-confidence and courage.



We have 15 girls on the team this year.


6 freshman,  $\overline{3}$  sophomores, 5 juniors and only one senior, Hannah Koutz. 9 girls are returning to our squad this year.

In addition, Janet recognized an opportunity to have anesthesia review charts earlier in the pre-assessment process to reduce patient cancellations and schedule needed clearances with specialties closer to the time of procedure onboarding. With her support, we were able to move the anesthesia review of patient charts closer to the time of boarding rather than two days before the procedure. Change is difficult, but Janet embraced this opportunity to improve patient care at Memorial. She pushed the limits of what we consider to be good care and helped us transform it into excellent care."
