

January is National Radon Action Month

St. Johns, Stanton, Ithaca, MI – The Mid-Michigan District Health Department (MMDHD) is encouraging residents to test their homes for radon this January and is offering free test kits



to those living in Clinton, Gratiot, and Montcalm counties.

Radon is a naturally occurring radioactive gas. It is tasteless, odorless, and colorless. It comes from the radioactive breakdown of radium, which comes from the radioactive decay of uranium. Both radium and uranium are found in at least trace amounts in almost any kind of soil or rock.

MMDHD's Environmental Health Director, Lonnie Smith says, "You cannot see, smell, or taste radon, so we encourage residents to test for radon in their homes. Any home, could have elevated levels of radon."

One in every four Michigan homes is expected to have radon levels that exceed the recommended federal action level. This is alarming because radon is the second leading cause of lung cancer, behind smoking. Home radon testing is recommended every two to five years because homes settle and new cracks form in the foundation, causing radon levels to change. You can't see, smell or taste radon. The only way to know if you have elevated radon levels is to test.

State Police Pilots First Battery Electric Vehicle in Patrol Fleet

LANSING -The Michigan State Police (MSP) is announcing the addition of its first battery electric vehicle (BEV) to be used on patrol starting today. The 2024 Ford Mustang Mach-E is assigned to MSP's State Security Operations Section to be used by state properties security officers, who are armed, uniformed members of the MSP who specialize in general law enforcement and security services at state-owned and leased facilities in the Lansing area.

"This is an exciting opportunity for us to research, in real time, how a battery electric vehicle performs on patrol," said Col. James F. Grady II, director of the MSP. "Our state properties security officers patrol a substantially smaller number of miles per day than our troopers and motor carrier officers, within city limits and at lower speeds, coupled with the availability of charging infrastructure in downtown Lansing, making this the ideal environment to test the capabilities of a police-package battery electric vehicle."

The MSP's Precision Driving Unit is nationally renowned for its annual Police Vehicle Evaluation, in which they test and evaluate police vehicles from various manufacturers to include alternative fuel vehicles. The data is compiled and published for use by police fleet managers and purchasing agents nationwide.

"We began testing battery electric vehicles in 2022, but up until now hybrids were the only alternative fuel vehicle in our fleet," said Lt. Nicholas Darlington, commander of the Precision Driving Unit. "Adding this battery electric vehicle to our patrol fleet will allow us to study the vehicle's performance long-term to determine if there is a potential for cost savings and broader applicability within our fleet."



New Year, New Rimfire

It is hard to believe that a new year has started just like it is hard to believe that rimfire enthusiasts have another new rimfire cartridge option. Drum roll please..



Introducing the new 21 Sharps from Winchester. Unlike the revolutionary .17's, the 5mm, and the 22 WMR this new cartridge is more like an improved .22 Long Rifle (LR) which has been pretty much the same since 1887.

Why make the improvements with the .22 long Rifle? After all, it is pretty hard to beat the inherent accuracy of a .22 LR out to around 60 yards or so because of the little amount of rise and fall in the bullet's trajectory. Thus, making it perfect for head shots on close squirrels, rabbits, woodchucks, etc. If there is one fault with the .22 LR, or maybe an issue, it's that the bullets are heeled and are very difficult to manufacture with non-lead materials. This hasn't really been a problem in the past but times are changing and it won't be very long until environmental safe bullets will be required across the country on all public lands. Back to the .22 LR bullet...the diameter of the bullet besides the heel is actually .225 which is the same outside diameter of the shell. The 21 Sharp uses the same shell but has no heel and the base of the bullet measures .2105. What does all this mean for the new 21 Sharp? The bullet is ballistically better with increased velocity and accuracy but also easier to manufacture

Winchester has announced four different factory target and game loads for the 21 Sharp. The first is the 25 grain Copper Matrix which has a velocity of 1750 fps and has proven very accurate in published test reports. Next is for game only and is the Super X 34 grain Jacket Hollow Point traveling at 1,500 fps and is said to outperform its rival .22LR in terms of accuracy, expansion, and impact energy on small game. The third option is a 37 grain Black Copper Plated which moves at 1,335 fps and will be the cheapest and best for economical plinking.

Last and slowest is the 42 grain Full Metal Jacket which travels at 1,330 fps and is designed for high volume range sessions when frequent cleaning isn't desired.

In terms of rifles available right now, it appears that Winchester and Savage are the only manufacturers but it probably won't be long until Ruger 10/22 barrels will probably be available. Ammo is hit or miss but when you do find it expect to pay double the cost of regular .22LR ammunition. What does this mean for the Weekly Sportsman? It would be great to shoot this through a Remington 510 but that won't be possible so the wait will start for a 10/22 barrel in 21 Sharp!

Setting Goals For Your Teens

Dear Andy, Last week, I read your column about making New Year's Resolutions and never too late to make changes. Do you think it is a good idea for our children? Middle School and High School ages. My husband and I were talking about our goals for this new year and we wanted to give suggestions for our children. Any ideas on how to get them to make changes?

Dear Mom & Dad,

Of course! Setting goals for the new year should be a family tradition. Start Now. It is fun and you might learn some things about your children. Call a family meeting. (No TV, No electronic or cell phones.) Bring Poster paper and/or a notebook to the table. And, provide markers, pens, and cookies. Goal setting does not need to be intimidating. It is a great assignment when students return from winter break at school. Teachers often use the goal-setting opportunities at that time of year to get back into the school routine. It works great for families, too!

First, set your children up for success. This is a project that builds self-esteem and awareness for your children. Depending on the child's age, share some of you and your husband's goals or resolutions for the year. Ie. Saving for a vacation, spending more time at grandma's, inviting friends and family over for dinner every other week. Being 10 minutes early for work. Going to all the Basketball games. Dishes in the dishwasher right after dinner. Remind our kids how much we love them. Remind your spouse how much you appreciate him or her. Exercise more. Plan a weekly family movie night, with popcorn. The list could go on and on. Make them achievable with a plan.

As for your children, list categories for goals. Personal goals: Such as, make my bed every morning (if that is important to both you and your child) or keep my room clean. (That might take some coaxing or reminding and suggestions on how to pick up or organize a room.) Some things may be as simple as, feed the dog or brush your teeth, without being told. Or, School Goals: Laying my clothes out the night before so I am not late for the bus. Reading for fun. Practice my saxophone for 20 minutes daily. Eat Breakfast every day. Go to bed an hour earlier. Say Good morning to my teacher when I enter the room.

Include, short-term goals and long-term goals. Some people might need something tangible for accomplishing their goals. Make rewards non-monetary and non-food related, for obvious reasons. You're building habits and self-esteem. Design a chart for self-monitoring. (Which is a great idea.) Some kids just need a sticker on the chart as a sign of accomplishment and often, recognition is enough of a reward. Small awards could be something like a match box car for a collector, or an extra half hour on a computer game. (Hoping you already have limits in place.) Something big after months of keeping goals and resolutions like a trip to a Pin-ball center, a Lazer Tag outing, or an activity tailored just for your individual child or yourself.



Time Management Tips for Your Wedding Day

As any married couple can attest, a wedding day has a tendency to fly by. Couples have much to do on the day they tie the knot, which can make the day feel like a whirlwind.

Certain skills can come in especially handy on a wedding day, and the ability to manage time is certainly one of them. As their big day draws closer, couples can employ these time management tips to slow the day down a little bit.

- Create and distribute a schedule. A schedule can ensure the happy couple and all members of the bridal party know when and where they need to be at certain times during the day. Include all pertinent information on the schedule, including when and where hair and makeup appointments begin, when transportation to and from the ceremony and reception site will arrive and, of course, the start time for the ceremony. A printed copy can help, but a digital copy sent via text or email can guarantee the schedule is accessible via smartphone at all times during the day.
- Collaborate with your photographer in advance of your wedding day. Couples can streamline wedding day photography sessions by collaborating with their photographer in advance. During these sessions, identify the bridal party shots you want to take and then create a schedule of photos so all party members know where they need to be and when. Some couples choose to schedule bridal party photoshoots before the ceremony, while others prefer theirs after the couple has made it official. Regardless of which option couples prefer, schedule these photos so no time is wasted finding bridal party members.
- Don't forget to set aside time to eat. Anything can derail a wedding day schedule if it's forgotten when couples devise their initial plan for how the day will unfold. Couples might be less inclined to forget hair and makeup appointments and photo sessions because such components are integral to wedding



planning. But couples should not forget to leave time for themselves and their bridal party to eat. Couples have much to manage on their wedding days. Perhaps no component is more important to manage effectively than time.

Consider Wedding Flowers Carefully

Although many decorative elements help to create ambiance for a wedding celebration, perhaps none is more awe-inspiring than beautiful floral arrangements. Flowers offer visual appeal, captivating aromas and texture that can make a space more welcoming.

Engaged couples typically go to great lengths when planning their weddings, but flowers may not be as micromanaged as other elements. Some are content to let florists design their arrangements, but the average cost of wedding flowers in 2023 was \$2,800, according to The Knot Real Weddings



Study. That price tag merits some input on the part of couples. Floral experts say couples should budget for floral arrangements coming in at 10 percent of the overall wedding budget, which is the industry standard. Therefore, for a \$60,000 wedding a couple should assume their florals will cost \$6,000. It's important to note that the cost of wedding flowers has been steadily increasing over the last few years due to inflation and climate change, says The Knot. So couples may need to be even more involved in floral decisions to maximize their dollars spent.

Here are some variables to consider when selecting wedding flowers.

- · Greenery: Adding greenery to fill in spaces in floral arrangements can save some money. Centerpieces and bouquets that are floral-heavy will certainly cost more.
- · Symbolism: Consider the meaning behind flowers to make choices even more personal. You also may want to select flowers that will complement the theme of the wedding. For example, traditional spring blooms like tulips and daffodils will coordinate with spring weddings.
- · Flower varieties: Hardier varieties of flowers, such as daisies, mums, carnations, and protea, are less likely to wilt quickly in bouquets or centerpieces than some other blooms, even when they are cut. Such blooms can hold up in any weather and last the entire day so that arrangements will be picture-perfect no matter the hour.
- · Venue: Couples may find that some venues already have faux flowers or other decor. That may mean couples do not need to have as many flowers or any elaborate arrangements.
- · Size: A particularly large floral centerpiece can overwhelm a table, and a bouquet that is overly cumbersome may detract from the bride or her bridesmaids. Choose the correct scale for comfort in bouquets. For table arrangements, select a size that will not discourage conversation or block guests' view, nor take up too much real estate on the table.
- · Allergies: Although they are cut, flowers in arrangements can trigger allergic responses in some people. Others may be bothered by overly aromatic flowers. Work with the florist to find blooms that will be best.
- · Color scheme: Although white flowers always coordinate, many couples like some color in their arrangements. Be sure the flowers pick up the hues used in bridesmaid dresses or even the season of the year.

Couples should take an active role in deciding what to include in floral pieces for their weddings.

Brides-to-be make many important decisions when planning their weddings, and one of the more notable ones is the choice of wedding gown. According to The Knot Real Weddings Study, the average wedding dress cost \$2,000 in 2023. Despite that hefty price tag, gowns remain a pivotal component of a wedding, as 98 percent of women who responded to the survey indicated they wore a dress for their nuptials. If the sizable price tag is a cause for concern to some aspiring brides, The Knot notes that customization can drive up the final price tag by a significant amount. Brides who opt for no or minimal customization can likely find a dress that costs significantly less than




Why Regular Car Washes Are Important
