### Ovid PostMaster Retires After 38 Years

Kay Goeckel, the longest serving PostMaster in Clinton County (30 years) officially retired from the Ovid Post Office on Friday, February 21, 2025 after 38 years of service with the US Postal Service

Her career with the United States Postal Service began in 1987 as a PTF Clerk in Ovid. She worked part-time, 2 hours in the morning and 2 hours in the afternoon and every Saturday with the exception of two Saturdays given off each year. In 1990 Kay became the Officer in Charge, a full-time position at the Ovid Post Office and in February of 1995 she was sworn in as PostMaster. She also served as PostMaster in Shaftsburg for one year in 1993.

When asked about what changes she has experienced over the years with the postal service, "The decline in mail volume, and the increase in packages. The mail volume is down by 75% from when I started. Technology has also created many changes in the

day to day work, not only for the office staff but also for the carriers," she explained.

Kay and her husband, Eric, reside in Owosso and have plans to spend more time at their up north cabin, more time with their three grandkids and doing some traveling.

### **Elsie Village Council Proceedings**

ELSIE - Prior to the regular meeting Elsie Village Council meeting February 11, 2025 a public hearing was held to allow the public to comment on the vacating of Third Street between Main and Pine streets; Pine Street east of Third Street and the northeast corner of lot 13 of block 4 of Bishop and Brown's re subdivision of parts of blocks 2 and 3 Van Dusen's addition. No public comment. Formal action was taken during the regular meeting to approve this request.

Action items included resolution 25-001 for vacating of street right-of-way as addressed in the public hearing. Officials approved the action item. Noting all resolutions were a roll

Resolution 25-002 authorization for the interim manager to execute the sale of 100 Pine Street and V/L W Pine Street, Elsie, MI, the former Elsie High School property to Ken Harris and his development firm. Officials approved the sale unanimously.

Next, development and reimbursement agreement between Elsie Development, LLC (developer) and the Elsie Brownfield Redevelopment Authority was also approved pending

Officials took action to correct the re-zoning 100 W Pine Street, Elsie, MI it should have

been re-zoned as R3 corrected from R2. Again, this is the former Elsie High School building. Ken Harris updated officials on the status of the project. The environmental crew is working and should be completed in a few weeks followed by bringing in the framing crew. The goal is to have the first apartment occupied April 1, 2026. Then as apartments are completed, they will become available.

Tim Fair, Capital Area Catalyst, was present to update officials on a number of projects that are in the planning stages including the establishment of a Downtown Development Association and the potential lagoon usage project.

Bryce indicated that with her current duties and the roles she is filling time for commiting to zoning administrator is very limited. After discussing the situation officials opted to appoint both the village manager and the department of public works supervisor as the Zoning Administrators will be a collaborative effort. In addition, officials took action to appoint Doug Sturgis to fill a vacancy created by the death of Don Cook on the zoning board.

Bryce, interim manager, presented the monthly report village manager's report. The USDA water report was presented noting that they reviewed our 2-year audit report for FY23 and FY24 with financial analysis showing currently it is unsustainable. This means that the village is not collecting enough in rates to adequately service the debt, pay operating expenses and fund the required services.

Michigan Rural Water is completing a rate study of the current water rates to ensure that the rates are maintaining the system. There will be changes regarding Elsie Village water rates and past practices.

It was suggested that after the water studies are complete and officials take action to make changes a town hall meeting should be held to educate the residents of the Village. The purpose would be to answer questions and involve residents in what is happening and the vision for the Village of Elsie.

The Village of Elsie will not qualify for ACT51 grand funds until after the Village deficit elimination plan is submitted to the State of Michigan. Bryce noted that the corrective plan

In addition, all investments have been dissolved as of January 2025, and expenditures regarding the village have been frozen until further notice; only outstanding invoices will be

The regular financial audit has been completed, a presentation will be made at a later date. Woodhill Group was paid 3,071.70 for services rendered.

A Heroes Park Committee needs to be established, the cost of installing the bricks is more than anticipated, fund raising may need to be one of the committees goal. This will be an in-progress project and addressed in the spring.

Chris Ormes, Department of Public Works, reported that water studies are underway. Reports have been provided regarding well-head protection; and the water department fiveyear plan. Rate studies are in progress, noting that there will be very few water rate adjust-

Chief Bryce presented the monthly Elsie Police Department report. Complaints had decreased from the prior month with a total of 54 calls. Police activity for the month of January included 911 hang ups, wellness checks, traffic and motor carrier enforcement and

The Elsie Police Department assisted Chief Merony, DeWitt Township Police Department, with a RUN, HIDE FIGHT ACTIVE VIOLENCE training for the staff at Ovid-Elsie Area Schools District. The training received very positive feedback.

The partnership between the Village of Elsie and Maple Rapids continues to progress and is providing very positive results. Additional certification is coming up for the officers and is scheduled for later this month, the Village of Maple Rapids has agreed to pay the training costs.

Monthly action was taken to approve the meeting agenda as amended adding the minutes of the closed session January 21, the minutes of the January 21, 2025 regular meeting and the financial reports. Next, officials took action to approve expenditures totaling

### Physician from UM Health-Sparrow and **MSU Appointed to Statewide Stroke Care Committee**

LANSING -Anmar Razak, M.D., has been named to Michigan's Statewide Stroke Care Advisory Subcommittee, a result of his dedication to advancing stroke care and improving patient outcomes

Members of this group support the Michigan Department of Health & Human Services and act as subject matter experts for the clinical and operational components of stroke care.

Razak, medical director of UM Health-Sparrow's comprehensive stroke center and chief of the cerebrovascular disease division at Michigan State University, began his three-year subcommittee term on Jan. 21, 2025. One of his goals is to enhance statewide protocols to ensure providers of emergency medical services, or EMS, are transporting stroke patients to the most appropriate site of care.

Timely detection and treatment are critical to improving

survival rates and minimizing disability," Razak said. "By collaborating on enhanced protocols for EMS, we can ensure that stroke patients are quickly routed to the right care, increasing their chances for a better outcome.'

Razak brings a wealth of expertise to the subcommittee. After earning a Bachelor of Science degree from the University of Toronto, he received his MBBS (MD) with distinction from the University of the West Indies in 2004. He completed his residency in neurology at MSU, followed by advanced fellowship training in vascular neurology and endovascular surgical neuroradiology at both MSU and UM Health-Sparrow Lansing. Razak specializes in minimally invasive endovascular treatment of brain aneurysms, cerebral/spinal arteriovenous malformations and fistulas, carotid, vertebral and intracranial artery blockages, among others. As part of the Neuro Care Network collaboration between MSU and U-M Health, he oversees UM Health-Sparrow's comprehensive stroke center, the only one of its kind in Mid-Michigan.

"It is an honor to serve on the Statewide Stroke Care Subcommittee and contribute to advancing these efforts across the state," he said.




### **Charlotte Edna Arnst**






