Dairy Business Builder Grant Now Accepting Applications

LANSING – Michigan dairy farms and producers can once again apply for funding to support and grow their operations, Michigan Department of Agriculture and Rural Development (MDARD) Director Tim Boring announced today.

The Dairy Business Innovation Alliance (DBIA) – which MDARD joined in Sept. 2022 – is now accepting applications for the Dairy Business Builder Grant opportunity. The grant encourages small and medium-sized dairy farmers, entrepreneurs, and processors in the Midwest to pursue projects such as dairy farm diversification, on-farm processing, value-added product creation, and efforts to market dairy products for export.

Since its creation in the 2018 U.S. Farm Bill, the DBIA has awarded over 250 grants totaling more than \$20 million to dairy businesses within the Midwest service area. Reimbursement grants of up to \$100,000 each will be awarded to different dairy businesses after a competitive review process.

During previous rounds of funding, 44 businesses were awarded over \$3.5 million. Two Michigan companies were among those awarded during the last round: Leelanau Cheese Company and Reny Picot – Old Europe Cheese, Inc. Information on previous award recipients is located on the grant website.

Applicants are encouraged to attend a webinar for the Dairy Business Builder Grant that will take place Wednesday, February 5, 2025 at 1 p.m. Central Time. Registration for the webinar can be found on the DBIA website. Applications are due by 5 p.m. Central Time on April 2, 2025. Award announcements will occur in late May 2025.

MDHHS Urges Vaccinations as Respiratory Cases Rise in Michigan

LANSING, Mich. – The Michigan Department of Health and Human Services (MDHHS) encourages Michigan residents to get vaccinated, as increases in flu, COVID-19 and RSV activity have been observed and are expected to continue.

At the end of December, trends in respiratory illness reached the highest levels so far this season at both the national level (6.8% of outpatient visits for influenza-like illness) and in Michigan (4.5%). Michigan activity typically lags a few weeks behind the national trend, meaning the next few weeks are likely to see increasing local activity, especially as children return to school after the December holidays.

The majority of Michiganders are not up to date on the vaccinations that protect against these infections. Only 11% of Michigan residents have been vaccinated this season for COVID-19 and 23.6% have been vaccinated for influenza. It is not too late to get vaccinated against the flu, COVID-19 and RSV. All three of these vaccines can help protect against severe respiratory illness and can be given at the same time. Nationally, 11 children have died from influenza during the 2024-25 flu season; none of the children were from Michigan.

"With many respiratory viruses circulating and Influenza cases rising, it is crucial for Michigan residents to get vaccinated to protect themselves and their families," said Dr. Natasha Bagdasarian, chief medical executive. "COVID-19 and flu vaccines are effective at preventing serious outcomes, including hospitalization and death. It is not too late to protect yourself and your family this season."

According to state data, as of Dec. 28, approximately 2.5 million people have received their flu vaccine this flu season. This is well below the 4 million doses of flu vaccine that were

expected to be administered this season. Vaccination coverage rates are highest among older adults, while they remain lowest for school-aged children (14.9% coverage for ages 5-12 and 7.7% coverage for ages 13-17) and college-aged young adults (10.9% coverage).

The Centers for Disease Control and Prevention (CDC) recommends the annual influenza vaccination for all persons 6 months and older, with rare exceptions. Getting vaccinated now, as respiratory virus activity is increasing, can still provide protection. Flu activity usually peaks in February, but significant flu activity can continue into May. It takes about two weeks after the vaccine is administered before the body builds up enough immunity to protect from severe illness from the flu. If eligible, Michigan residents should receive their flu, COVID-19 and RSV vaccines today to help protect from potentially severe consequences from these illnesses.

Vaccination is particularly important for these younger age groups as children return from the holiday break. It is also important for individuals at higher risk of developing serious complications — including young children, adults ages 65 years and older, people with certain medical conditions and pregnant persons. Speak to a health care provider to discuss vaccination and determine which flu vaccine is best for you. Vaccines are an essential health benefit under the Affordable Care Act and are covered with no out-of-pocket costs by most health plans in Michigan.



In lieu of flowers, memorial contributions may be made to Oakhurst United Methodist Church or the United Church of Ovid.



LANSING - Michigan dairy farms and producers can once again apply for funding to support and grow their operations, Michigan Department of Agriculture and Rural Development (MDARD) Director Tim Boring announced today.

The Dairy Business Innovation Alliance (DBIA) – which MDARD joined in Sept. 2022 – is now accepting applications for the Dairy Business Builder Grant opportunity. The grant encourages small and medium-sized dairy farmers, entrepreneurs, and processors in the Midwest to pursue projects such as dairy farm diversification, on-farm processing, value-added product creation, and efforts to market dairy products for

"The dairy industry in Michigan continuously makes a large economic impact while providing nutritious products across the state," said Director Boring. "This funding will support growth and sustainability, so we're encouraging dairy farms, processors and producers to apply.'

Since its creation in the 2018 U.S. Farm Bill, the DBIA has awarded over 250 grants totaling more than \$20 million to dairy businesses within the Midwest service area. Reimbursement grants of up to \$100,000 each will be awarded to different dairy businesses after a competitive review process.

During previous rounds of funding, 44 businesses were awarded over \$3.5 million. Two Michigan companies were among those awarded during the last round: Leelanau Cheese Company and Reny Picot - Old Europe Cheese, Inc. Information on previous award recipients is located on the grant

35th Shiawassee County Walk Dairy Business Builder Grant USDA Sets Michigan Deadline for Stewardship Applications

EAST LANSING — A U.S. Department of Agriculture program that provides annual payments for land stewardship is available to Michigan farmers and non-industrial private forest owners. Applications for the USDA Conservation Stewardship Program must be submitted by Feb. 14, 2025, to be eligible for the current selection period.

Through the Conservation Stewardship Program, the USDA's Natural Resources Conservation Service provides farmers and forestland owners a minimum annual payment of \$4,000 for maintaining their existing stewardship practices. Program participants earn additional financial assistance for implementing new conservation activities while maintaining agricultural production on their land. The Conservation Stewardship Program also encourages adoption of new technologies and management practices. Program participants enter into 5-year, renewable contracts that encompass the entire farming or forest operation.

Farmers and forestland owners who have participated in USDA conservation programs and have a conservation or forest management plan are ideal candidates for enrollment in the Conservation Stewardship Program. Applications for the Conservation Stewardship Program are selected on a competitive basis. Additional program funding through the Inflation Reduction Act offers an excellent opportunity for farmers and forestland owners to be selected for enrollment.

The Conservation Stewardship Program is offered in Michigan on a continuous basis. The program provides many benefits including increased crop yields, decreased inputs, wildlife habitat improvements and increased resilience to weather extremes. The program is for working lands including cropland, pastureland, nonindustrial private forest land and includes land under the jurisdiction of an American Indian
