# 1978 State Champion Wolfpack Feted for Inducation into Lansing Sports Hall of Fame

LAINGSBURG -- Teammates, families and fans gathered February 21 at LHS to fete the 1978 State Champion Wolfpack Softball Team.

Festivities were held at halftime of the LHS vs. Bath girls basketball game. A commemorative plaque presented by the Wolfpack Sports Boosters is now displayed with the team's State Championship hardware in the trophy case at LHS. The inscription on the plaque reads, "In commemoration of the 1978 State Champion Varsity Softball Team from Laingsburg High School, on their 2024 induction into the Greater Lansing Sports Hall of Fame. A grateful communkity says 'Thank You' for the honor you have shared with Laingsburg."

The team was officially inducted into the GLSHOF last August.

The 1978 Wolfpack finished undefeated and to date has won the program's only state championship -- even though LHS has an outstanding program going on right now under iconic coach Jeff Cheadle.

The 1978 season was only the fourth year that a state champion was crowned in girls soft-ball.

Laingsburg defeated Owendale-Gagetown in the semifinals, 15-2, then Central Lake 6-1 in the state championship game on June 17, 1978 at Ionia High School. Star pitcher Robbin Sawyer allowed just one hit. For the season, Sawyer compiled a 17-0 record in the circle.

They were a young squad, with just three seniors and four freshmen -- all the rest were juniors. As a team, the Wolves were a perfect 19-0 and you can make a strong case that they were the most dominant team -- in any sport -- in LHS history:

- -- Over half the team hit over .400. Four players were 1st Team All-CMAC, and three were All-Area for the Capital City region.
- -- When an opposing hitter actually got a ball in play off Sawyer, her defense fielded at better than a .900 clip. First baseman Debbie Wrobel, despite all the chances coming her way, with just one miscue all season.
- -- It was on the base paths, though, that the Wolfpack stunned opposing teams. In just 19 games, two hitters -- Lisa Mahoney and Sue Hurst -- both totaled over 40 steals. Sawyer added another 30.

Coach Bronwyn Krupa has reported that the team set or broke 17 different school records. One key player on the team, third baseman Carrie Koonter, was a power-hitting star for the Wolfpack and, sadly, passed away a few short years ago. A moment of silence was observed for

Carrie during the presentation.



# Reduce, Reuse, Recycling

submitted by Ellen Link For probably the first time in their 30+ years of service, the Greater Laingsburg Recyclers had to cancel their (Tuesday) recycling collections not once but twice this winter due to inclement weather-in this case, frigid temperatures deemed harmful to our volunteers. Our stated policy dictates that the recycling facility will be closed when the temperature is below 15



degrees or weather conditions are sufficiently bad to close schools. We sincerely apologize for the inconvenience this caused our users. But we hope folks will understand that our operation absolutely depends on volunteers, whose well-being must come first. If in doubt, check one of the options given below

Hopefully, normalcy has returned and the facility will be open on the 1st and 3rd Tuesdays (March 4 and 18), 4-6 p.m., and 2nd and 4th Saturdays (March 8 and 22), 9 a.m.-1 p.m. To view the long list of materials we accept and how to sort them, as well as get answers to your questions, consult our web page or the contacts below. In the meantime, the GLR will continue to continue to seek out new options for that list.

At present the GLR is interested in making it possible for area residents to compost their food waste. This can reduce one's trash fees as well as material sent to the landfill and keep stinky food waste out of your trash bin that may attract pests. Many people already have backyard compost piles, but it isn't always possible for everyone. At Laingsburg's LBCA Annual Pancake Breakfast last summer, leftover food items along with the commercially compostable plates, utensils, cups and napkins were collected and sent to a facility to be turned into compost, a healthy alternative to chemical fertilizer that will enrich the soil and help plants grow strong and healthy.

Perhaps more important is that food waste accounts for 25 percent of all the trash in a landfill. There, it creates a lot of methane, a gas more harmful than carbon dioxide. According to the EPA, "Wasting food in the U.S. causes greenhouse gas emissions equivalent to those of more than 50 million gas-powered passenger vehicles." (https://www.epa.gov/land-research/quantifying-methane-emissions-landfilled-foodwaste) The GLR will be circulating a survey to find out whether enough area residents are interested in in using a compost drop-off site for food waste at the Laingsburg Recycling Center. 

# DNR Conducting Wolf Count Below the Bridge

Well it is official, right now as you are reading this column the DNR is asking for assistance with their wolf survey below the Mackinac Bridge. Ironic, that this comes a year after a wolf is shot in southern Michigan under "suspicious" circumstances and the incident is still "under investigation" despite numerous DNR statements that wolves can't survive south of the bridge due to lack of habitat. The last lower peninsula survey was conducted in 2019 and produced more than 100 reports of possible wolf activity but most were tracks unverified or determined to be from coyotes and domestic dogs. Apparently the DNR really wants to determine if there is a breeding population below the bridge which is now at least feasible as the wolf population above the bridge in the upper peninsula is believed to be around 765 wolves distributed among 160 packs. Probably above the level of sustainability because at one time the carrying capacity above the bridge was believed to be around 300 to 400 wolves. There may be pressure to move south across the frozen water in search of new habitat. If you have a sighting please call 989-370-7313 or go online www.michigan.gov/EyesInTheField.

Hard to understand or know what is really happening from mixed signals with press releases and count studies being conducted, however, if there is a sasquatch sighting dismissed by the DNR in a press release don't be surprised if a year later they are asking for help from the public to do a count study. Afterall, do you remember the statements about no breeding populations of cougars above and below the bridge?????

# Signs and Symptoms of Parkinson's Disease

Retired NBA power forward Brian Grant; best-selling musician Neil Diamond; star of television and film Michael J. Fox; and the forty-first president of the United States, George H.W. Bush, have had wildly different careers, but all shared one thing in common: Parkinson's disease. This is proof positive that PD touches people from all walks of life.

The National Institutes of Health say Parkinson's disease is a neurodegenerative disorder that affects people of all ages, races and genders. Certain factors can increase the risk of developing PD, including being over the age of 60, being male, having a family history of the disease, and exposure to certain toxins like pesticides and herbicides.

Symptoms of PD start slowly and can worsen over time. The Mayo Clinic says the first symptom of the disease may be a barely noticeable tremor in just one hand or sometimes the jaw or foot. While there is no cure for PD, early intervention therapies may slow its progression, making diagnosis at the earliest of symptoms advantageous. The following are some of the common symptoms of Parkinson's disease, courtesy of the Parkinson's Foundation and the Mayo Clinic.

A slight shaking (tremor) in a finger, thumb, hand, or chin while at rest.

Small handwriting, also known as micrographia, may be a sign of PD. This is when letter sizes are smaller and the words are crowded together.

· Slowed movement, also called bradykinesia, can be a symptom. People with bradykinesia may find it hard to get out of a chair, shower or get dressed. Bradykinesia also may make it more difficult to blink and a person may have less expression







in his or her face.

- Although a loss of sense of smell can be linked to a respiratory condition like the common cold or even COVID-19, no longer smelling certain foods also might be a symptom of
- · Loss of automatic movements, such as smiling or swinging arms while walking, can occur.
- Those with PD often have diminished posture that becomes stooped, causing balance problems and falls.
- Voice changes, such as a breathy, soft or hoarse voice, could be an indicator of PD, as can slurring of words.
- Facial masking, which involves a serious or angry looking face, is present in some people with PD.

Additional potential symptoms of PD can include vivid dreams that cause acting out, frequent need to urinate, constipation, feeling very tired, and problems with thinking and memory.

A person should see a health care professional if any of these symptoms seem familiar. A doctor can help diagnose the condition and rule out other potential causes.


