Ovid-Elsie Area Schools

ELSIE – The regular meeting of Ovid-Elsie Area Schools was held Monday, May 19, 2025. The transition for a new superintendent is underway. Officials addressed a wide variety of year

Officials took action to appoint representation the Clinton County RESA board meeting to elect officers. The following board members were appointed to serves as OE Board Representative to attend CCRESA meeting, June 2, 2025, 5 pm Dr. David Huff and the alter-

Board members discussed the hiring of an individual to fill the business manager position. It was noted that the position had been posted twice. The first included a human resource element, twelve applications were received and after vetted did not fit the criteria or qualified for the school setting. - the responsibilities were outlined for board members. The second posting did not include human resources; two applicants were received. One withdrew, the other was not brought back for a second interview. Dr. Wayne Petroelje reported that CCRESA will not be providing business services for Ovid-Elsie after June 30, 2025. Additional options were outlined to fill the position however, in-house is the best option. Petroelje recommended that Kaitlyn Kusnier, current business office specialist, be promoted to that position. Kusnier has proven herself as very open to adding the skills necessary to fill the business manager position. Mark Horak the Ovid-Elsie Superintendent, as of July 1, 2025, agreed with the recommendation. The personnel committee did not make this recommendation and they voiced their concern regarding the recommendation and the process used. Intense discussion followed. The recommendation passed 4-3, the dissenting votes were Becky Taylor, Susan Kadlek and Mary

Brook Wooley, board president, brought up a related topic of discussion was the role of committees. When the committees the role of each was not defined. It was assumed that committees are an advisory capacity. Not all members had the same expectations. Mark Horak has been asked what he sees a committee role. Horak would like to restructure what committees will look like. It was moved to eliminate a number of the standing committees, hiring and personnel until Horak takes the helm of the district. The only standing committee that will be retained is the Finance Committee.

Officials took formal action to approve the superintendent's contract. Mr. Mark Horak's contract was approved and will be effective July 1, 2025.

A request for a second year of unpaid leave for a teacher for the 2025-26 school year. This is a second request and falls under the master agreement. This does not set a standard or a precedence and the employee does not qualify under FMLA. The teaching position will be filled by a long term qualified substitute teacher.

Elementary school roof bids were reviewed by officials. Officials took action to approve the bid with Roof Innovations in the amount of \$362,725 for reroofing Leonard and EE Knight elementaries. Noting that four bids were received. This is the alternate bid using the TPO membrane is a cost-effective, reliable, and energy-efficient solution that meets all warranty and performance expectations.

A number of the Ovid-Elsie Area Schools Board of Education members requested a special board of education meeting. The request was prompted by the May 8 senior prank issues that involved toilet papering the trees near the high school and possible entry into a building that was averted by the janitorial staff. It was noted that sixty high school seniors were involved. Concerns were shared and policies were reviewed. Teacher/staff key fobs were not utilized. Security of fobs was voiced. Additional concerns were what was the punishment and was the punishment consistent with past practices. Board members are not entitled to the individuals involved due to FIRPA, student privacy. There is a need to review security concerns. With that in mind what should be involved in a special meeting. Discussion followed. Coach responsibilities and a handbook addressed regarding access to the building. The Athletic Director will be involved in the discussion. TP incident has exposed a lot. The decision was made not to have a special meeting but to address the issues at a regular board meeting at a future date.

In other actions officials took annual action to review and approve the CCRESA 2025-25 general fund budget. A virtual presentation was provided with action taken under new business items. Officials took formal action to approve the presented resolution regarding the 2025-26 CCRESA Budget. This addressed only the General Fund which reflects an anticipated 3% increase in taxable values. There is also an anticipated reduction in Federal funding.

Officials addressed and approved the NEOLA Policies and by law after the second reading.

There was a lengthy list of updates which are available at the OE Administrative Business office. 15 policies and 1 bylaw – 2 rescinded the remainder revised.

Board members and the public were updated on a number of the district's programs. EE Knight Elementary updates were presented by Ms. Felicia Gingrich, school principal, a Candyland theme kicked off the year. Testing has wrapped for the year, three times a year a screener is administered to the students. MSTEP testing was completed last week; wrapped up staff and teacher appreciation week. End of the year field trips; picnics and field trips are underway. The 5th Grade Kindness Club was introduced to the board and recognized. This was a pilot program with amazing results, thirty-six members with six present to share their projects. Completed projects throughout the year starting small and progressing to larger projects – for example book marks, friendship bracelets for support staff and transportation; Christmas caroling and gifts for residents at Ovid Healthcare; spring bulletin boards. The students gave up recess time to complete the projects. Next year, plan to open it up to all of the students, possibly an after-school club for grades 3-5.

Wellness and Food Service a presentation by Melissa Jones, district nurse and Shawn Pardee, food service. The goal was to promote health and wellness for students and staff utilizing the whole child model. The focus was facilitating healthy food choice, encouraging an active life style, and overall wellness. Functional and purposeful. The activities aligned with the updated USDA/local wellness guidelines. Wellness and School Assessment Tool utilized – WellSAT which offers support for students and staff. OE scored in total comprehensiveness 92 and total strength 66, there is improvement but room to grow. The committee will be meeting 5/20/25 to set goals for the next year and they encourage interested individuals to participate. Meetings next year 9/16/25; 11/18/25; 2/17/26; 4/21/26, the high school student lounge. MSU Extension is involved as well.

Shawn Pardee reported on the digital menu system and she indicated that printed copies are still available at the elementary level. Chef Jeff's menus have been included some good others not so much. There is the possibility of re-establishing the high school salad bar. Pardee explained that Chef Jeff was from MSU, he was at the high school and middle schools for a month, he created the menu and prepared the food and provided taste testing for students and worked with the cafeteria staff.

Technology and School safety updates, Dan Davenport reported that "Stop the Bleed" Kits have been installed in all class rooms and other spaces as identified. The kits include bandages, tourniquets and other wound care supplies. Additional training has been slated for August 13, 2025 for all staff who could not participate due to job constrictions. A terminology plan will be involve changing the language and update the plan. HB 4095 and 4096 all schools will be using the same language and terminology when referring to first aid measures and school incidents. It is due by the summer of 2026. HB 5549 – BTAM Requirement – behavioral threat assessment team required by October 1, 2026; training was held May 15.

Davenport also presented a brief update about the Michigan International Prep School, a charter school supported by Ovid-Elsie Area Schools. Katie Kusnier, business manager is involved in assisting with the mandated paperwork. MIPS is in compliance there are currently 1,657 students enrolled. Parent/Student orientation is a new requirement, MIPS already has a process in place.

Next a summer technology projects were outlined. The gym will receive audio upgrades; Chromebook purchase – early purchasing using ECF funds, more repairable devices for 3rd and 9th grade; printer refresh – maintaining lease costs while replacing copy machines through Applied Imaging and Richoh; and a server sharing agreement with CCRESA for 2025 mitigation will be updated, current server has one year of life left. Network and security enhancements are ongoing. Student Wellbeing – Chromebook Shutdown 12:10 am-4:00am; Academic benefits research shows that students need adequate sleep for academic performance; and health impact, reduces digital fatigue and supports emotion regulations. Finally, WOES will see new equipment upgrades – tuner receives for the Emergency Announcement System. Remote control – adding equipment for more remote programming.

Positive Behavioral Interventions and Supports (PBIS) Amber Foster; a brief overview of the program was presented. The program is evidence based, increases attendance, improves culture. This is a tiered approach. Tier 1 is implementation – teaching expectations, core expectations, reinforcing positive behavior and a consistent disciplinary system. There is a lot of positive behavior taking place and recognition of this behavior. Noting that staff are recognized for positive activities as well. "We are all in this together". Tier 1effects 80% of students. Tier 2 – 15% of students – student ID system; tailored interventions and Tier 3 5% of the student population. Data is monitored focusing on behavior and attendance. Overall attendance is improving; suspensions are clearly on the decline. 91% of students do not have disciplinary issues. Tier 2 is in progress.

Mary Levey, Ovid-Elsie Alternative High School director and educator, presented the annual OEAHS report. A quick overview of the program was presented; the focus of the program is academics and earning a high school diploma. The program addresses the whole student by encouraging community involvement and expanding education experiences. Students have been active in community projects such as beautification of Friendship Park in Rochester Colony; and working with elementary students at Leonard Elementary. Cultural experiences including attending the Michigan Renaissance Festival and the Tribal Cultural Center in Mt Pleasant. Board members were reminded that twelve seniors will graduate from Ovid-Elsie Alternative High School, Thursday, May 22, 7 pm.

Dr Wayne Pertroelje, reported that the following teachers will complete probationary

Dr Wayne Pertroelje, reported that the following teachers will complete probationary teacher status at the end of this school year – Logan Kellogg (HS Art Teacher); Mary Levey (Alt Ed Teacher); Kristina Swisher (2nd grade), and Autum Winsor (school counselor). These teachers will receive tenure at the end of the school year, June 30, 2025.

In addition, the high school freshman seminar class will be reestablished and scheduled for the 2025-26 school year. However, the Dale Carnegie class will not be part of that class it could not be negotiated into the seminar class.

Lastly, end of the year hog roast, Wednesday June 4, 2025 at noon an appreciation to the staff, volunteers and retirees.

Public comment included a number of concerns about the behavior and bullying and lack of consequences at Ovid-Elsie Middle School. Kelsey Holmes presented officials with written documentation about recent events and a second complaint was voiced regarding students, male and female, being "panted" in gym class and in the halls. The consequences do seem to address the behavior.

Eric Jones thanked the board for extending the unpaid leave for Ms. Maddie Jones. He expressed frustration with a number of the board members, he is simply asking for time, that does not cost the district anything.

Finally, a request to establish the water aerobics class at the school, it is still needed at Ovid-Elsie. Petrolelje hopes to have an answer by the next board meeting in June.

Officials took action to approve the consent agenda. The agenda with the addition of roles of committees to the agenda, approval of the April 18, 2025, April 22, 2025, and May 2, 2025 personnel/negotiation committee meetings; approval of the minutes from the April 22, 2025; April 23, 2025; April 30, 2025 and May 12, 2025 special board of education meetings; approval of the minutes of the April 14, 2025 boards work session; approval of payment of bills and financial reports. Finally, to renew board policy 5113 to offer schools of choice an annual action item. at OEAS.





"Do Staples Float?"

"When they arrived at the Jordan, they began cutting down trees. But as one of them was cutting a tree, his ax head fell into the river. 'Oh, sir!' he cried. 'It was a borrowed ax!' 'Where did it fall?' the man of God asked. When he showed him the place, Elisha cut a stick and threw it into the water at that spot. Then the ax head floated to the surface. 'Grab it,' Elisha said. And the man reached out and grabbed it (2 Kings 6)."

I've heard this excuse many times. "If God is real, why doesn't He just appear to me here, right now, then I'd believe." In other words, prove it, impress me, make an ax head float. The great King Herod wanted Jesus to do parlor tricks for him, but Jesus declined. Jesus knew that even rising from the dead wouldn't grab a hard heart (Luke 16:19-31).

God is not a trained monkey doing dog and pony shows on our whims. His marvelous deeds are recorded in the Bible for all to read, from a victory parade through a bone-dry Red Sea to an empty tomb near Jerusalem. "Moses and the Prophets" are enough for a soft heart, but sometimes He gives us a tiny glimpse that He really is "here, right now."

On August 8-9, 1942, at only 19, Elgin Staples was blown overboard when Japanese cruisers near Guadalcanal attacked his ship. Despite shrapnel in his shoulder and both legs, his lifebelt kept him afloat for four frantic hours fighting not to be swept out to sea.

"I began treading water, trying to stay calm as I felt things brush against my legs, knowing that if a shark attacked me, any moment could be my last."

When he was safely onboard a third ship (he was rescued, returned to his ship, but it was too badly damaged and sank), he examined the M1926 inflatable lifebelt and saw that it was made in Akron, Ohio at the Firestone Tire and Rubber Company...his hometown! He decided to keep the lifebelt as a souvenir. Eventually he got sent home to recuperate.

"After a quietly emotional welcome, I sat with my mother in our kitchen, telling her about my recent ordeal and hearing what had happened at home since I had gone away. My mother informed me that 'to do her part,' she had gotten a wartime job at the Firestone plant. Surprised, I jumped up and grabbing my life belt from my duffel bag, put it on the table in front of her.

'Take a look at that, Mom,' I said, 'It was made right here in Akron, at your plant.'

She leaned forward and taking the rubber belt in her hands, she read the label. She had just heard the story and knew that in the darkness of that terrible night, it was this one piece of rubber that had saved my life. When she looked up at me, her mouth and her eyes were open wide with surprise. 'Son, I'm an inspector at Firestone. This is my inspector number,' she said, her voice hardly above a whisper.

We stared at each other, too stunned to speak. Then I stood up, walked around the table and pulled her up from her chair. We held each other in a tight embrace, saying nothing. My mother was not a demonstrative woman, but the significance of this amazing coincidence overcame her usual reserve. We hugged each other for a long, long time, feeling the bond between us. My mother had put her arms halfway around the world to save me."

Is this a huge reach, just a crazy coincidence? Maybe. I did not plan to write this column today, but is it a coincidence that today is the 80th anniversary of our victory in World War II? Maybe. But if you asked Vera Staples, who prayed for her boy 8,000 miles away, I know what she'd say. Coincidence is God's way of remaining anonymous.

Now ask yourself this...what are the odds, that God did all that, over 80 years ago, and indeed rose from the dead 2,000 years ago (to be your lifebelt), just to get your attention "here, right now," by reading these words? You could ignore it as a coincidence, and let this Luke 16:19-31 moment float by, but I know what Elisha would say. "Grab it!"

Friends and Teens

Dear Andy,

I am worried about my teenage daughter. We moved two years ago to another city for my work. She switched schools in the middle of Middle school. It was tough for her to make friends. She was not happy with the move. I am worried about the friends she has found and now hangs out with. They almost always wear all black clothes and hang out at a local fast-food restaurant after school or a nearby public park or my house. My daughters' grades are great, and her attitude is getting better. My worry is the friends she has made. I am concerned she might make some bad choices and get into something illegal or in trouble. I am so worried; I can make myself go from zero to 60 with negative thoughts in a minute. What should I do? Worried Mom

Dear Worried Mom,

Worrying is quite normal, but it is a misuse of your imagination! Take a deep breath....whew. It isn't easy to switch schools at any age. Making changes and making decisions are good "character-building" traits. Keep your lines of communication open. Ask her to let you know when and where she is going to hang out and who she is with. Have her text you when she is heading home. If she forgets, just a gentle reminder that you love her and you want to know she is safe. Give her the words for a quick departure if there are signs of trouble. When someone suggests doing something inappropriate or wrong, she could say, "OMG, my mom told me I had to be home at 5:30!" Then she can take off for home.

If your home is a place they like to be, make them feel welcome. Ask questions, name, grade, love your pink hair or something nice. Don't pry and don't you hang out. If you cannot be home when they hang out at your place, leave lots of food: rice crispy treats, sodas, chips, PBnJ. Teens are all hungry after school. Have guidelines, like backpacks on the porch when they go to town or the park. Be in the sunroom or family room only. Pick up your trash. Set limits on times. Some may not want to go home and feel safe at your place. BE the parent who always volunteers to drive wherever they need to go. Be attentive and a good listener. Teens want an adult they can count on...and not always their parents.

Encourage them to get involved in school activities, such as home games, activities at school, a local or school drama or after-school teen clubs. In the summer, make outdoor activities possible: such as corn hole, swimming, cards, music, art, a bonfire and marshmallows on Saturday evening, and ask them to make a bucket list of things they want to do. Give them markers and poster board and the tools they need to have fun and stay out of trouble.

Ever heard the saying, "Don't judge a book by its cover." Don't judge her friends or teens because they wear all black. Some cannot afford trendy clothing. Girls are still trying to figure themselves out, as their bodies change and grow into young women. Some feel protected by wearing black and dressing neutral. Some find it thinning. And, just because a girl is dressed in half shirts and short skirts does not mean they are flirty...it just a style. Most are just naïve and not that aware of themselves.
