#### Ovid-Elsie Area Schools Selects Mark Horak to Lead District

Ovid-Elsie Area Schools Board of Education has selected Mark Horak to be the district's next superintendent. "Mr. Horak is an experienced educational leader whose determination in public education will continue the district's vision of high expectations and provide a world class educational experience for all students. His expressed commitment to fiscal responsibility, strategic planning, and transparency will support the effective management of our district and its resources. "stated board president Brooke Wooley. "The board is confident that Horak's vision and his focus on building positive relationships within our schools and community will continue us on our journey to excellence while putting students first."

Horak brings with him to the position considerable experience as a superintendent, administrator and teacher in districts across Clinton County, Michigan. As superintendent/high school principal of Fowler from 2021- 2023, Horak managed the daily operations of the district while seeing through the completion of a \$17 million construction project for the district. Prior to that, Horak served in progressively broader roles at St. Johns Public Schools over a span of 27 years including teacher, coach, and high school principal.

Consistent with the values of Ovid-Elsie Area Schools, the selection was supported by an inclusive process. Selection criteria were generated based upon the input of numerous community members, parents and staff via an online survey. Community members provided immediate feedback to board members during face-to-face candidate interviews. Additionally, administrators, faculty, students, and parents provided input following a series of structured stakeholder conversations. The board of education appreciates the district's citizens and staff support of the process.

Horak and the board of education are currently in the process of contract negotiations, with the new superintendent expected to assume the position July 1, 2025.

Laingsburg, MI – Red Thunder Robotics made Laingsburg proud as they soared all the way to the 2025 FIRST Robotics World Championship in Houston, Texas.

Known as "Worlds", this championship brought together over 50,000 people from countries across the globe, creating an unforgettable experience for all who attended.

After a 20-hour charter bus ride—complete with a stop at the famous Buc-ee's truck stop—Red Thunder Robotics landed in Houston ready to make their mark.

And that they did. After three days of tough competition, Red Thunder fought hard through their division rounds. Red Thunder's season looked like it might be wrapping up—until Michigan's #1 ranked team and State Champion, The HOT Team, invited them to join their alliance. Partnering with this amazing team gave Red Thunder Robotics the chance to keep competing—and to go further at Worlds than they ever had before. It was an unforget-table experience that showed just how much grit, teamwork, and determination this group really has.

On top of their strong performance, Red Thunder was honored in their division with the prestigious FIRST Robotics Team Sustainability Award. This award recognizes teams that have developed practices to have a positive environmental impact and ensure long-term team growth. "I'm beyond proud of this team," said Melissa Kramer, District Robotics Coordinator and Head mentor. "They've worked so hard to get here, and to see them competing on the world stage was amazing. I can't wait to see what the future holds for these students."

## State Treasurer Announces Grants for Distressed Municipalities

LANSING, Mich. – State Treasurer Rachael Eubanks today announced a total of \$2.5 million is being awarded to 13 municipalities through the Financially Distressed Cities, Villages and Townships (FDCVT) Grant Program.

Municipalities can participate in the FDCVT Grant Program if they are experiencing one or more conditions indicative of "probable financial distress" as defined in state law. The grants fund specific projects, services, or strategies, including infrastructure and public safety enhancements, that move a city, village or township toward financial stability.

"This year, the Michigan Department of Treasury awarded grants for infrastructure and public safety projects in communities spanning from Southeast Michigan to the Upper Peninsula," State Treasurer Rachael Eubanks said. "Funded projects help provide movement toward financial stability for our local communities. Our team will ensure these grants are provided to our communities as expeditiously as possible."

For Fiscal Year 2025, the Michigan Legislature appropriated \$2.5 million for the program, with a carryover of \$13,049 from the previous fiscal year. The FDCVT Grant Program has a \$2 million cap per municipality and grants are awarded based on applications submitted by the municipality.

The following municipalities will receive funding this year, with projects and amounts noted: Elsie Village, Water system enhancement through replacement of water meters \$148,531, was one of 13 villages/city that received part of the grant.

For waste materials we can't accept, don't forget the special county spring recycling collections. The complete list of what they will accept, available on their website (https://shiawasseechd.net/household-hazardous-waste/) or by calling (989) 743-2390, does NOT include latex paint, used motor oil, tires, explosives or smoke detectors. No appointment is necessary.



Mom was cremated and requested that we not have a Service for her. Sharing stories will keep her Alive in our hearts so when you see somebody that she knew please share a story or






